Pursuant to the Real Estate Tax Sale Law, 72 P.S. §5860.610 properties will be sold free and clear of all taxes and municipal claims, mortgages, liens, charges, and estate whatsoever kind, except ground rents separately taxed.

**JUDICIAL SALE TERMS
AND CONDITIONS**

1. Bidders must register prior to the Judicial Sale at the Cumberland County Tax Claim Bureau, One Courthouse Square, Room 106 (Old Courthouse), Carlisle, PA 17013. Registration will be open from June 3, 2019 to July 11, 2019, from 8 a.m.—11:00 a.m. and from 12:00 p.m.—4:30 p.m. Bidders shall be required at time of registration to sign a certification form that he or she or the party that they represent or are affiliated with are not delinquent in paying real estate taxes to any of the taxing districts where the property is located and have no municipal utility bills that are more than one year outstanding. Bidders will receive a copy of the terms and conditions of sale and shall also be required to sign acknowledgement that they received same. A non-refundable registration

fee of \$10.00 will be due upon registering. Please present a valid driver's license, state identification or birth certificate.

2. The Tax Claim Bureau acting as an agent of each taxing municipality on which taxes are unpaid is selling the taxable interest of the owner. It makes no guarantee or warranty whatsoever as to the existence or condition of the property, accuracy of ownership, size, boundaries, locations, existence of structures or lack thereof, liens, titles, occupancy, possession, or any other matter whatsoever affecting the property. It has attempted to comply with all statutory rules regarding notice, and retains records of such notices in its archive for public inspection, but makes no guaranties or warranties whatsoever.

3. The Judicial Sale price of the property includes all unpaid costs and fees incurred since the property has been in delinquent status plus transfer taxes and recording fees.
