NOTICE IS HEREBY GIVEN that
the Foster Township Board of Super-
visors at their regularly scheduled
meeting on June 3, 2015, at the Foster
Township Municipal Building, 1540
Sunbury Road, Foster Township,
Schuylkill County, Pennsylvania,
adopted an Ordinance signifying the
intention and desire of the Board of
Supervisors of Foster Township to
organize a joint authority with Cass
Township, Minersville Area School
District, County of Schuylkill and
Schuylkill County Industrial Develop-
ment Authority, under the provisions
of the Act of the General Assembly,
known as the Municipality Authorities
Act, 53 Pa. C.S.A. §5601; setting forth
and authorizing execution of Articles
of Incorporation; appointing and fix-
ing the term of the first member of the
Board of such joint authority on behalf
of the Township authorizing all other

necessary action; and to establish an Intergovernmental Cooperation Agreement with Cass Township, Minersville Area School District, County of Schuylkill and Schuylkill County Industrial Development Authority; and repealing all inconsistent ordinances or parts of ordinances. The Articles of Incorporation shall be filed on July 15, 2015, with the Secretary of the Commonwealth of Pennsylvania.
