

### ORDER

AND NOW, this 1st day of February, 2018, upon consideration of the Petition for Bifurcation filed by Steven Harper, Linda Dennis failing to respond despite actual service at her last known address of record and service by publication pursuant to court order, the court finds and directs as follows:

- 1. The circumstances that allow for bifurcation are discussed in 23 Pa. C.S. §3323 (c.1).
- 2. As set forth therein, "in the absence of the consent of both parties", bifurcation is only permitted in the limited circumstances provided in sections (c.1) (1) and (2). Id, see comments.
  - 3. Here, there is no consent.
- 4. Accordingly, the court must determine whether grounds have been established under subsection (g), which requires the following:
- a. In a §3301(a) (fault) divorce, findings must be made that grounds for divorce exist. Here, no such finding may be made because Linda Dennis denies the allegations in her Answer, and no prior findings have been made that grounds for divorce exist.
- b. In a §3301(c) (no fault) divorce, both parties must have filed consents. Here, neither party has.

- c. In a §3301(d) (two-year separation), an affidavit must be filed and no counter affidavit. Here, no affidavit appears to be filed.
- 5. The matter is currently scheduled for a pre-trial conference on March 12, 2018 at 9:30 a.m. in courtroom 3.
- 6. In order to allow Steven Harper an opportunity to file an affidavit or present evidence to enable the hearing master to make necessary findings, a bifurcation hearing on the petition is scheduled at the same time as the upcoming pretrial conference, i.e., March 12, 2018 at 9:30 a.m. in courtroom 3.
- 7. Plaintiff shall serve Linda Dennis with a copy of this Order by publication. BY THE COURT:

AND NOW this \_\_\_\_ day of January, 2018 the Court finds as follows:

- 1. The Plaintiff filed a Petition for Bifurcation on or about September 14, 2017.
- 2. Service of the Petition for Bifurcation was made upon the Defendant pursuant to this Court's Order dated October 18, 2017, authorizing service by publication.
  - 3. Plaintiff has filed proof of service.
- 4. Defendant has not filed an answer to the Petition for Bifurcation.
- 5. In accordance with Pa.R.C.P. 206.7, the Petition for Bifurcation is hereby granted and the Plaintiff may file for the entry of a divorce in accordance with the Divorce Code and the Rules of Civil Procedure.
