LACKAWANNA COUNTY UPSET TAX SALE LIST SEPTEMBER 30, 2019 AT 10:00 A.M.

NOTICE IS HEREBY GIVEN THAT THE TAX CLAIM BUREAU OF LACKAWANNA COUNTY, PENNSYLVANIA, WILL EXPOSE THE FOLLOWING PROPERTIES TO PUBLIC SALE PURSUANT TO THE PROVISIONS OF THE REAL ESTATE TAX SALE LAW OF 1947, AS AMENDED AND SUPPLEMENTED, FOR THE COLLECTION OF DELINQUENT AND UNPAID REAL ESTATE TAXES ASSESSED AND LEVIED BY THE VARIOUS TAXING DISTRICTS WITHIN THE COUNTY OF LACKAWANNA. THE SALE WILL TAKE PLACE AT THE LACKAWANNA COUNTY COURTHOUSE LOCATED AT 200 NORTH WASHINGTON AVENUE, SCRANTON, PENNSYLVANIA ON SEPTEMBER 30, 2019 AT 10:00 AM AND MAY BE CONTINUED BY ADJOURNMENT TO SUCH OTHER TIME OR TIMES AS THE TAX CLAIM BUREAU SHALL DESIGNATE.

TERMS OF SALE: (1) ALL PROSPECTIVE BIDDERS ARE REQUIRED TO PRE-REGISTER FOR THE JUDICIAL TAX SALE BY SUBMITTING A NOTARIZED BIDDER AFFIDAVIT ALONG WITH A COPY OF THEIR DRIVER'S LICENSE AND BY ALSO OBTAINING AN AUCTION BID TICKET FROM THE TAX CLAIM BUREAU NO LATER THAN 3:00 P.M.
