SUMMARY OF OPINION:

The purchaser of commercial property sued the seller for alleged breaches of the express warranties and representations contained in the sales agreement, and sought to recover damages for the replacement and repair of the commercial buildings' roofs, mechanical systems, and water-damaged equipment allegedly caused by their defective conditions that the seller affirmatively concealed. The purchaser also claimed damages for loss of business income and profits for the period of time that it was allegedly delayed in offering CT scanning and physical therapy services due to roof leaks. Following the completion of discovery and the production of expert reports, the seller filed a motion for summary judgment seeking to dismiss the claims for: (1) replacement of the chiller and generator on the grounds that they were component parts of equipment sold on an "as-is" basis under the agreement; (2) loss of business income based upon the purchaser's acknowledged inability to establish such loss with reasonable certainty; and (3) repair and replacement costs that were paid by the buildings' tenant, rather than the purchaser.

The chiller and generator were not included on the six-page list of 64 items of identified equipment that were sold "as-is" and without any express or implied warranties, and the summary judgment record contained a genuine issue of fact as to whether the chiller and generator were part of the buildings' mechanical, utility, or electrical systems" subject to contractual warranties, rather than as mere components of the MRI unit. In contrast, even when the summary judgment record was viewed in the light most favorable to the purchaser, it lacked sufficient evidence upon which a fact-finder could calculate, with the requisite reasonable certainty, any lost income or profits allegedly experienced by the CT scanning and physical therapy services. The purchaser admitted under oath that he "cannot quantify" and had "not been able to compute" those alleged losses, and the purchaser din to retain an expert who attempted to calculate those claimed losses. Last, the purchaser's lease agreement obligated it to reimburse the tenant for any replacement and repair costs that the tenant paid, and the indemnification clause in the realty agreement required the seller storach of any warranty/representation, as a result of which the purchaser for costs, damages, or liabilities related to the seller storach of any warranty/representation, as a result of which the purchaser and replacement calculate, the seller storach from the purchaser's liability to the tenant for those repair and replacement expenses. Accordingly, the seller's motion was granted as to the buyer's claims for loss of business income or profit, but denied in all other respects.

SUMMARY OF OPINION:

What began as a straightforward ejectment action in 2006 later spawned three additional lawsuits, with the pending action claiming wrongful use of civil proceedings for instituting an earlier suit asserting wrongful use of civil proceedings. In this matter, a lawyer sued his ex-client, that client's former attorneys, and the counsel who represented the ex-client's former lawyer in the prior action alleging wrongful use of civil proceedings. Defendants filed preliminary objections asserting, *inter alia*, that the instant case was barred by the statute of limitations since it was not commenced within two years of the date that the prior suit was voluntarily discontinued with prejudice as to all parties. Plaintiff contended that the suit was timely filed, and that the discovery rule operated to extend the governing limitations period.

It was clear and free from doubt that the underlying Dragonetti action was voluntarily discontinued as to all parties and "with prejudice" on July 10, 2017, and that the Clerk of Judicial Records filed a discontinuance order on that date and served it upon all counsel of record. Although the tort of wrongful use of civil proceedings is governed by a two-year statute of limitations, this matter was commenced two years and twenty-six days after the Clerk's entry of her order discontinuing the underlying litigation with prejudice. Since the statute of limitations defense was clear on the face of the pleadings and record, and plaintiff did not file preliminary objections to defendants' assertion of that affirmative defense by way of preliminary objections rather than new matter, the merits of the statute of limitations defense was properly before the court. Additionally, inasmuch as the two-year limitations period began to run on July 10, 2017, when the underlying Dragonetti action was terminated in favor of plaintiff, and more than two years had elapsed by the time the plaintiff initiated the pending action on August 5, 2019, the instant matter was clearly time-barred and the demurrer based upon the expiration of the statute of limitations was sustained.
