The Lehigh County Court of Common Pleas is seeking to contract with an attorney to provide legal representation as one of four (4) part-time Criminal Conflicts Counsel. Responsibilities include representing indigent defendants who, because of conflicts of interest with the Public Defender's Office, cannot be represented by that office. Criminal Conflicts Counsel are not appointed to homicide cases. Trial experience in the prosecution or defense of criminal cases is required, as is membership in the Bar of the Pennsylvania Supreme Court. The annual compensation is currently \$65,736, which is paid in twelve (12) equal monthly installments of \$5,478.00.
