JUDICIAL OPINION

OPINION AND ORDER

Linda R. Cordaro, J.

April 10, 2023

Before this Court is Defendant's Omnibus Pretrial Motion (OPT), which includes a motion to dismiss for lack of probable cause to conduct a traffic stop; a motion to suppress due to an invalid search warrant; and writ of habeas corpus/motion to dismiss/motion to quash. A hearing was held on March 20, 2023, at which both Defendant's counsel and counsel for the Commonwealth consented to disposition based on the preliminary hearing transcript and admitted exhibits. {1} For the following reasons, Defendant's Motion is denied in part and granted in part.

FINDINGS OF FACT

The following facts were established in testimony in the preliminary hearing transcript. On January 1, 2022, Trooper Patrick Biddle observed the Defendant driving a vehicle with an inoperable registration light to the right of its license plate, and the trooper had to use his headlights to read the plate. The trooper activated his patrol vehicle lights and siren to initiate a traffic stop. The Defendant's vehicle continued to travel approximately .4 miles before stopping almost directly in front of his residence. Upon approaching the vehicle, the trooper detected the odor of marijuana. "When the Defendant retrieved his driver's license from his wallet, the trooper observed money folded in different directions in the wallet. The trooper testified that his training had taught him that when an individual has money folded in different directions it means the person is involved with sales, and that folding the money differently is to separate sales proceeds from the person's own money. The Defendant did not provide any proof of registration and insurance and told the trooper that the vehicle belonged to his fiancee. The trooper asked if he would look in the glove box for the documents, and the Defendant declined, stating he knew they weren't in the vehicle. While speaking with the Defendant, Trooper Biddle noticed the Defendant's eyes were red. He asked the Defendant to exit the vehicle, and as the Defendant did so, the trooper noticed two plastic grocery bags behind the driver's seat. The trooper then administered the horizontal gaze nystagmus and modified

Romberg balance tests. During the modified Romberg balance test, the trooper observed the Defendant had a half-inch sway, his eyes fluttered, and, when asked to estimate when 30 seconds of time had passed, he over-estimated by 21 seconds. The trooper asked whether the Defendant had smoked marijuana, and the Defendant responded that he had not. The trooper then asked for consent to search the vehicle, which the Defendant refused.

Defendant's fiancee appeared on the scene, and Trooper Biddle also asked her for consent to search the vehicle, which she refused. The trooper observed the Defendant pacing and appearing to be nervous. When the trooper went to his vehicle to call for backup, the Defendant ran from the traffic stop. The trooper advised him he was not free to leave but did not pursue. There is no mobile video recording (MVR) of the encounter.

The vehicle was towed to PSP Belle Vernon, and Trooper Biddle obtained a search warrant. Various paraphernalia, drugs, currency, and a loaded firearm were seized from the vehicle.

The Defendant was charged with two (2) counts of Possession with Intent to Deliver under 35 Pa.C.S.A. §780-113(a)(30); two (2) counts of Possession under 35 Pa.C.S.A. § 780-113(a)(16); three (3) counts of Use/Possession of Paraphernalia under 35 Pa.C.S.A. § 780-113(a)(32); one (1) count of Possession of a Small Amount of Marijuana under 35 Pa.C.S.A. § 780-113(a)(31)(i); one (1) count of DUI under 75 Pa.C.S.A. § 3802(d)(2). He was also charged with one (1) count of third-degree misdemeanor Disorderly Conduct under 18 Pa.C.S.A. § 5503(a)(4) and several summary offenses.

DISCUSSION

The first count of Defendant's OPT is a motion to dismiss based on insufficient cause to conduct a traffic stop. Under 75 Pa.C.S.A. § 6308(b), whenever a police officer has reasonable suspicion that a violation of the Vehicle Code is occurring, the officer may stop a vehicle to secure information he reasonably believes necessary to enforce the provisions of the Vehicle Code. According to 75 Pa.C.S.A. § 4303(b), vehicles shall be equipped with a rear lighting system including "rear lamps, rear reflectors, stop lamps, and license plate light."

Trooper Biddle testified at the preliminary hearing that he observed the light on the right side of Defendant's vehicle license plate was inoperable, and he had to use his headlights in order to read the plate. These observations constitute sufficient cause to suspect a violation of the Vehicle Code and to initiate a stop. The motion to dismiss for lack of cause therefore is denied.

The second count of Defendant's OPT is a motion to suppress based on a fatally flawed and invalid search warrant. When considering whether to issue a warrant, the issuing authority is bound by the facts within the "four corners" of the affidavit. Commonwealth v. Dukeman, 917 A.2d 338, 341 (Pa. Super. Ct. 2007). Under Pa.R.Crim.P. 206(2), an application for a search warrant must identify specifically the items to be searched for and seized. The issuing authority must determine if, given the totality of the circumstances presented, there is "a fair probability" that evidence of criminal activi-

ty or contraband will be found in a particular place. Commonwealth v. Housman, 986 A.2d 822,843 (Pa. 2009) (quoting Illinois v. Gates, 462 U.S. 213, 238-39 (1960)). The authority must make a common sense assessment as to this "fair probability" and, generally, that decision must be accorded deference. Commonwealth v. Huntington, 924 A.2d 1252, 1255 (Pa. Super. Ct. 2007).

Here, however, the affidavit was insufficient to establish probable cause for a search warrant. First, the affidavit states generally that contraband "such as guns, drugs, money and other illegal items" were to be seized. To be sure, these are examples of contraband, but the affidavit has no specifics as to what the trooper expected to find.

Second, the facts as set forth in the "four corners" do not support "a fair probability" that contraband would be found in the vehicle. The circumstances as described do include several observations such as the odor of marijuana; Defendant's refusal to open the glove box; the folded bills in his wallet; his red eyes; the Defendant's performance on field sobriety tests; his and his fiancee's refusal to consent to a vehicle search; and Defendant's flight from the scene. However, a common sense reading of these facts does not lead to the conclusion that contraband was probably in the vehicle. Defendant's motion for suppression due to an invalid search warrant is granted.

The final count of Defendant's OPT challenges that the Commonwealth failed to establish a prima facie case for the charges related to drug and paraphernalia possession.

It also challenges that there is insufficient evidence to support the DUI charge. {2} A petition for a writ of habeas is the proper means for testing a pre-trial finding that the Commonwealth has sufficiently established a prima facie case. Commonwealth v. Scott, 578 A.2d 933, 936 (Pa. Super. Ct. 1990). The Commonwealth must present evidence as to each material element of the crimes charged and establish sufficient probable cause that the accused is the person who committed the offenses. Commonwealth v. McBride, 595 A.2d 589, 591 (Pa. 1991).

Here, since the evidence procured from the vehicle is to be suppressed, the Defendant's motion with respect to the drug and paraphernalia possession charges is granted. Further, there is no evidence the Defendant was operating the vehicle in an unsafe manner and insufficient evidence that he was impaired to the point of being unable to safely operate it. The motion with respect to the DUI charge is granted.

The Defendant does not specifically challenge any other charges. However, since evidence is subject to suppression, and the sole fact set forth in the Information to support the disorderly conduct {3} charge is that the Defendant possessed drugs and paraphernalia, there is insufficient evidence for a prima facie case for this charge.

^{{3} &}quot;A person is guilty of disorderly conduct if, with intent to cause public inconvenience, annoyance or alarm, or recklessly creating a risk thereof, he ... creates a hazardous or physically offensive condition by any act which serves no legitimate purpose of the actor." 18 Pa.C.S.A. § 5503(a)

(4). The offense is graded as an M3 "if the intent of the actor is to cause substantial harm or serious inconvenience, or if he persists in disorderly conduct after reasonable warning or request to desist." 18 Pa.C.S.A. § 5503(b).

Similarly, there is no evidence to support the summary charge for public drunkenness. {4}

The motion is granted with respect to these charges as well.

Therefore, the Court enters the following:

ORDER

AND NOW, this 5th day of April, 2023, in consideration of Defendant's Omnibus Pretrial Motion and after a review of the preliminary hearing transcript and admitted exhibits, it is hereby ORDERED and DIRECTED that Defendant's Motion is DENIED IN PART and GRANTED IN PART.

The first count of Defendant's Motion is denied; all other counts are granted.

All evidence obtained from the vehicle pursuant to the invalid search warrant shall be suppressed. This Court further finds there is insufficient evidence to support a prima face case for Counts 1-11 of the Information, which are hereby DISMISSED.

^{[4] 18} Pa.C.S.A. § 5505 prohibits a person from appearing "in any public place manifestly under the influence of alcohol or a controlled substance ... to the degree that he may endanger himself or other persons or property or annoy persons in his vicinity."
