#### **OPINION**

#### SUMMARY

Currently before this Court is the Defendant's Omnibus Pretrial Motion for suppression of evidence and writ of habeas. Both the motor vehicle recording (MVR) and transcript of the preliminary hearing were admitted into evidence at the December 9, 2022 hearing. For the following reasons, Defendant's Motion is granted.

#### BACKGROUND

The following facts were established via the preliminary hearing {1} and MVR evidence. On August 26, 2021, Trooper Grant Rukat was with another trooper, in full uniform, operating a marked patrol vehicle during the 2200 - 0600 hour shift. He conducted a traffic stop on a Honda CRV in Connellsville Township, Fayette County because the issuing jurisdiction on the license plate of the vehicle was covered and the registered owner (the Defendant) was suspended.

Upon executing the stop, Trooper Rukat approached the driver's side to speak with the Defendant, while his partner approached the passenger side. Trooper Rukat informed the Defendant the reason for the stop was the suspension. and obscured plate. The trooper asked for the Defendant's identification, and where she was headed. The Defendant responded that she was going to drop off food for her friend, then going straight home. Trooper Rukat asked for her "insurance, which she provided. While examining her documents, the trooper asked if there was anything illegal in the vehicle that he "needed to be worried about," which the Defendant denied. Both troopers then returned to the patrol vehicle.

<sup>{1}</sup> The Defendant did not appear at the preliminary hearing: At the hearing, the affiant, Trooper Grant Rukat, did not testify but did swear under oath that everything in the criminal complaint and affidavit of probable cause was true and accurate. The facts as in the affidavit are incorporated here.

On returning to the driver's side of the Defendant's vehicle, Trooper Rukat asked the Defendant to exit the vehicle so he could show her the license plate frame. He asked if she had any weapons on her, which she denied. She followed him to the rear of her vehicle, where they discussed the frame. The trooper then asked about her relationship to the passenger, and the Defendant stated that the two worked together. The trooper reminded her that she was not supposed to be driving.

The trooper then asked if she was all right, since she was "shaking a lot." The Defendant replied that her workday had been stressful, and she knew she was driving with a suspended license. The trooper then said he "had to ask" if there were any illegal drugs in the vehicle. The Defendant denied this, and the trooper listed several types of illegal drugs, one after the other, each of which she denied. He asked her if there were any illegal guns in the vehicle, which she denied. He asked her if there were any large amounts of money, which she denied. The trooper asked the Defendant if he could search the vehicle, and she said, "Yeah."

Trooper Rukat directed her to stand at the front of the patrol vehicle. He then went to the passenger, who was still inside the vehicle, and asked him if the two worked together. The passenger said they did not. The trooper then asked the passenger to exit the vehicle, patted him down, and asked both individuals if there was anything in the vehicle that could poke or stick him. Both denied that there was any such thing. Trooper Rukat searched the vehicle while his partner remained with the Defendant and the passenger.

After approximately eight minutes of searching, the trooper approached the Defendant, handcuffed her, and informed both individuals that they were being detained because he had found needles in the Defendant's purse. He asked the Defendant why she had claimed she and the passenger worked together, and she responded that the passenger had assisted her with one of her patients.

According to the affidavit of probable cause, the search ultimately yielded an orange pill later identified as buprenorphine, three (3) buprenorphine and naloxone sublingual strips, eight (8) glassine stamp bags marked "Dirty Harry" containing, suspected heroin residue, one (1) white glassine stamp bag marked "Mike Tyson" containing suspected heroin residue, and two (2) syringes.

#### LEGAL PRINCIPLES

The exclusionary rule functions as a "judicially created remedy designed to safeguard Fourth Amendment rights generally through its deterrent effect... ." United States v. Leon, 468 U.S. 897, 906 (1984) (quoting United States v. Calandra, 414 U.S. 338,348 (1974)). The purpose of this "exclusionary rule" is to discourage law enforcement officers from constitutionally violative conduct by suppressing evidence obtained by unconstitutional means. Commonwealth v. Santiago, 160 A.3d 814, 827-28 (Pa. Super. Ct. 2017).

A warrantless search is deemed to be unreasonable, subject to specific exceptions, including consent to the search. Commonwealth v. Strickler, 757 A2d 884, 888 (Pa. 2000). If the underlying encounter is lawful, then the voluntariness of the consent be-

A petition for a writ of habeas is "the proper means for testing a pre-trial finding that the Commonwealth has sufficient evidence to establish a prima facie case" against a defendant. Commonwealth v. Scott, 578 A.2d 933, 936 (Pa. Super. Ct..1990). A pre-trial petition writ of habeas corpus is similar in its purpose to a preliminary hearing in that it seeks to prevent unlawful detention for a crime which was never committed, or for a crime for which there is no evidence of the accused's connection. Id. a:t 937. Accordingly, to establish its prima facie case, the Commonwealth must present evidence as to each material element of the crimes charged and establish sufficient probable cause that the accused is the person who committed the offenses. Commonwealth v. McBride, 595 A.2d 589, 591 (Pa. 1991).

#### DISCUSSION

The Defendant does not challenge the legality of the initial stop. She argues at Count I of the Motion that her consent to a search was not voluntary and therefore the search was invalid and the fruits of the search should be suppressed. She further argues at Count II that if the evidence procured from that invalid search is indeed suppressed; the Commonwealth cannot sustain its burden to present a prima facie case for the charge of possession under 35 Pa.C.S.A. § 780-113(a)(16) and possession of paraphernalia under 35 Pa.C.S.A. § 780-113(a)(32).

Here, Defendant's consent to a search was not the product of a "free and unconstrained choice" in the totality of circumstances. The analysis of voluntariness of consent should include: (1) establishing whether the accused was seized at the time of the request; and (2) whether the accused had knowledge of the right to refuse consent, taking into account factors such as maturity, sophistication, and mental/emotional state. Strickler, 757 A.2d at 901. Other factors to consider are those as analyzed in Commonwealth v. Acosta, including: (1) a prior, lawful detention; (2) withholding of documentation; (3) the presence of other officers and marked police cars with flashing lights inclose proximity; (4) the absence of an express endpoint to the detention. 815 A2d 1078,1085 (Pa. Super. Ct. 2003). In Acosta, the defendant's consent to a vehicle search was found not to be the product of a free choice because of these coercive factors. Id. at 1087.

Here, there are several factors that weigh in favor of the claim that the Defendant's consent was not voluntary: (1) the trooper withheld the Defendant's documentation, so she could not have been free to leave; (2) the traffic stop was conducted at night, with the patrol vehicle lights activated throughout the encounter; (3) the trooper transitioned immediately from admonishing the Defendant about driving with a suspended license into questioning her about other criminal activity; (4) the trooper did not advise her that she had the right to refuse consent; and (5) the trooper did not indicate in any way that the traffic stop had concluded. The facts here are somewhat distinguishable from Acosta in that here there was one (1) patrol vehicle and an equal ratio of citizens to law enforcement officers while in Acosta there were three (3) police vehicles and three (3) officers to the unaccompanied Acosta. However, this does not outweigh the other fac-

tors. The Commonwealth has not shown that the Defendant's consent was from her own unconstrained choice in the totality of circumstances. Count I of the Motion is therefore granted and any evidence obtained from the search shall be suppressed.

Since the evidence obtained from the search is suppressed because the Defendant's consent was not voluntary, the Commonwealth is not able to show a prima facie case of possession of a controlled substance or paraphernalia. Count II of the Motion is therefore granted and Counts 1 and 2 of the Information under 35 Pa.C.S.A. § 780-113(a) (16) and (a)(35) are dismissed.

Furthermore, although the Defendant does not dispute the legality of the stop itself, the facts indicate that the initial traffic stop was extended in length and scope without reasonable suspicion of a crime.

Under 75 Pa.C.S.A. § 6308(b) a police officer may stop a vehicle on reasonable suspicion of a violation "for the purpose of checking the vehicle's registration, proof of financial responsibility, vehicle identification number or engine number or the driver's license, or to secure such other information as the officer may reasonably believe to be necessary to enforce the provisions of this title." An officer is permitted to inquire into matters unrelated to the justification for the traffic stop, and this will not convert the encounter into "something other than a lawful seizure, so long as those inquiries do not measurably extend the duration of the stop." Arizona v. Johnson, 555 U.S. 323, 333 (2009) (emphasis added).

In Commonwealth v. Lopez, the officer executing the traffic stop concluded that the defendant's documentation was in order and explained the traffic violation to the defendant. 609 A.2d 177, 262 (Pa. Super. Ct. 1992). However, rather than terminate the encounter, the officer instead withheld the defendant's documents and based on his "policeman's intuition," continued to pose questions to the defendant before asking if he could look inside his vehicle. Id. The defendant gave consent and even signed a consent form. Id. at 256. However, the court found that, "[n]o objective circumstances suggested that [the defendant] ... had committed any crime more serious" than the traffic violation for which the officer initiated the stop, and it concluded that the defendant's consent in Lopez did not justify the search, despite the Commonwealth's claim that the search was thereby "legitimized." Id. (citing Florida v. Royer, 460 U.S. 491 (1983)).

Here, the purpose of the traffic stop was to resolve the issues of the Defendant's suspension and license plate frame. Therefore, the trooper was authorized under 75 Pa.C.S.A. § 6308(b) to perform checks on the Defendant's information and then to take relevant and appropriate action.. Although the circumstances here are distinguishable from those in Lopez in that here the Defendant's documentation was not all in order, the trooper still withheld her documents beyond the time in which the stop could have been resolved. The affidavit of probable cause, to which the trooper attested under oath, articulated no facts supporting a reasonable suspicion of criminal activity, nor are such facts evident in the MVR footage. The validity of the traffic stop ended when the trooper was able to resolve the reasons for the stop, and a detention beyond this in time or scope lacked constitutional basis.

#### ORDER

AND NOW, this 10th day of January, 2023, in consideration of Defendant's Omnibus Pretrial Motion, after a hearing on the Motion and consideration of the MVR footage and preliminary hearing transcript admitted into evidence, it is ORDERED and DI-RECTED that the Motion is GRANTED.


Counts 1 and 2 of the Information are hereby DISMISSED.
