Commonwealth v. Penaloza

Guilty plea withdrawal – Ineffective assistance of counsel – Direct appeal – Request for release on bail pending appeal

- 1. A request to withdraw a guilty plea on the grounds that it was involuntary is a claim that must be raised by motion in the trial court in order to be reviewed on direct appeal.
- 2. An ineffective assistance of counsel claim is not subject to review on direct appeal, but only on petition for post-conviction relief.
- 3. Although the language of Pa.R.Crim.P. 521(B)(3) does not expressly so state, its phrasing suggests that the appropriate time for the defendant to request a release on bail, if he is eligible under 521(B)(1), is at the time of sentencing.
- 4. Where, following sentencing in a negotiated guilty plea, defendant, sentenced to imprisonment of less than 2 years, (a) does not initially request to be released on bail, but instead, voluntarily commences his agreed sentence; (b) does not file a post sentence motion requesting to withdraw his guilty plea; (c) subsequently changes counsel and takes a direct appeal; (d) indicates in his Motion for Bail Pending Appeal that he has "colorable meritorious constitutional claims;" (e) but, thereafter, in his Statement of Matters Complained of raises only two claims, both of which, on their face, are not proper grounds for direct appeal, simply modifying bail pursuant to Pa.R.Crim.P. 521(D) is not appropriate and would set a poor precedent for other negotiated guilty pleas wherein a defendant may have second thoughts after spending some time in prison.
- Defendant, while represented by counsel, and pursuant to a written guilty plea 5. colloquy, entered pleas of guilty to the crimes of statutory sexual assault and corruption of a minor. Immediately following the oral guilty plea colloquy and pursuant to the negotiated and agreed terms of sentence set forth on the written colloquy form, defendant was sentenced to 11½ to 23 months on the statutory sexual assault charge, and 4 years consecutive probation on the corruption of minors charge. He was taken into custody at the conclusion of the sentencing hearing and commenced serving his sentence. Thereafter, new counsel entered his appearance on behalf of defendant, and simultaneously filed (a) a Notice of Appeal to the Superior Court from the judgment of sentence and (b) a Motion for Bail Pending Appeal. In compliance with the court's Order for Concise Statement of Errors Complained of on Appeal, Defendant filed his Statement of Matters Complained of Pursuant to Pa.R.A.P. 1925(B). Upon consideration of the defendant's Motion for Bail Pending Appeal, and following a hearing on the Motion, the Court Held, that the Motion was denied.

AND NOW, this 30th day of September, 2011, upon consideration of Defendant's Motion for Bail Pending Appeal, filed August 19, 2011, and following the hearing conducted on September 27, 2011 in open court, on the record, with all parties present, it is hereby ORDERED and DECREED that the relief requested in the Motion is DENIED. ¹

Ton July 21, 2011, Defendant, Edwin Penaloza, represented by his attorney, Richard E. Meanix, and pursuant to a written Guilty Plea Colloquy, entered pleas of guilty to the crimes of statutory sexual assault and corruption of a minor. The charges arise from Defendant having sexual intercourse on several occasions with a female, then 15 years of age, when he was 4 years, 2 months and 10 days older than she. Defendant and the victim were, at the time, boyfriend and girlfriend.

Immediately following the oral guilty plea colloquy and pursuant to the negotiated and agreed terms of sentence set forth on pages 3 and 4 of the written colloquy form, Defendant was sentenced to $11\frac{1}{2}$ to 23 months on the statutory sexual assault charge, and 4 years consecutive probation on the corruption of minors charge. He was taken into custody at the conclusion of the sentencing hearing and commenced serving his sentence.

On August 19, 2011, Jonathan J. Sobel entered his appearance on behalf of Defendant, and simultaneously filed (1) a Notice of Appeal to the Superior Court from the judgment of sentence and (2) the instant Motion for Bail Pending Appeal (hereinafter "Motion"). Paragraph 8 of the Motion reads as follows: "Inasmuch as Penaloza claims that the Appeal will raise colorable meritorious constitutional claims, the further execution of his sentence should be stayed pending the disposition of the pending appeal." Hearing on the Motion was scheduled for September 27, 2011.

In compliance with the court's August 29, 2011 Order for Concise Statement of Errors Complained of on Appeal, Defendant filed, on September 19, 2011, his Statement of Matters Complained of Pursuant to Pa.R.A.P. 1925(B). The Statement avers as follows:

- "1. The voluntary guilty plea entered into by Defendant, Edwin Steven Penaloza was not knowing, voluntary or intelligent.
- 2. Defense Counsel was ineffective in its representation of Defendant, Edwin Steven Penaloza."

It appears that neither of these grounds for direct appeal is proper. A request to withdraw a guilty plea on the grounds that it was involuntary is a claim that must be raised by motion in the trial court in order to be reviewed on direct appeal. Commonwealth v. Rush, 959 A.2d 945 (Pa.Super. 2008). This claim was not raised by motion in the trial court. An ineffective assistance of counsel claim is not subject to review on direct appeal, but only on petition for post-conviction relief. Commonwealth v. Quel, — A.3d —, 2011 WL 3672083 (Pa.Super. 2011).

We begin with a review of the provisions of Pa.R.Crim.P. 521(B). Although the language of Pa.R.Crim.P. 521(B)(3) does not expressly so state, its phrasing suggests that the appropriate time for the defendant to request a release on bail, if he is eligible under 521(B)(1), is at the time of sentencing. Otherwise, the prospective nature of the following language would be meaningless: "the judge shall require as a condition of release that the defendant either file a post-sentence motion and perfect an appeal or, when no post-sentence motion is filed, perfect an appeal within the time permitted by law." Here, Defendant, after he voluntarily entered a guilty plea with negotiated and agreed terms of sentence, made no request for bail after sentencing and, instead voluntarily was taken from the courtroom to Chester County Prison by the sheriff's deputies. He has now served more than 2 months of his sentence.

The court is also mindful of the language of Pa.R.Crim.P. 521(B)(1) which states: "When the sentence imposed includes imprisonment of less than 2 years, the defendant shall have the same right to bail as before verdict, unless the judge, pursuant to paragraph (D), modifies the bail order." We are aware, as well, of Pa.R.A.P. 1762(a), which addresses applications "relating to bail when an appeal is pending" which "shall ordinarily first be presented to the lower court, and shall be governed by the Pennsylvania Rules of Criminal Procedure."

Our research reveals no case law on the issue before us, which we lengthily frame as follows: Where, following sentencing in a negotiated guilty plea, defendant, sentenced to imprisonment of less than 2 years, (1) does not initially request to be released on bail, but instead, voluntarily commences his agreed sentence; (2) does not file a post sentence motion requesting to withdraw his guilty plea; (3) subsequently changes counsel and takes a direct appeal; (4) indicates in his Motion for Bail Pending Appeal that he has "colorable meritorious constitutional claims;" (5) but, thereafter, in his Statement of Matters Complained of raises only two claims, both of which, on their face, are not proper grounds for direct appeal,

does the trial court have discretion to refuse bail, or must it rather act pursuant to Pa.R.Crim.P. 521(D), to somehow modify the bail order? More succinctly stated, the issue is, under these circumstances, when it is now evident that the appeal is frivolous, does a defendant maintain "the same right to bail as before verdict"?

We conclude that simply modifying bail pursuant to Pa.R.Crim.P. 521(D), under the circumstances present in this case, is not appropriate and would set poor precedent for other negotiated guilty pleas wherein a defendant may have second thoughts after spending some time in prison. If the court were to modify the existing bail order, we would set bail at \$50,000 cash, and impose a condition of electronic home confinement. (We note that the Commonwealth's position on bail, if the court acted to modify, was \$100,000 cash, and a condition that Defendant not leave Pennsylvania). However, because Defendant is a resident of New York, and intends to return to New York if he is released, the Chester County Bail Agency is unable to conduct his electronic monitoring out of state. Moreover 521(D) requires the court to "consider whether there is an increased likelihood of the defendant's fleeing the jurisdiction." When asked at the hearing, Mr. Sobel stated that his client would not be "fleeing" because he is announcing in advance that he would not be remaining in Pennsylvania. Nevertheless, we are concerned that, if his Superior Court appeal is denied, Defendant would have little incentive to return to Chester County to complete the 9 remaining months of his sentence. Bench warrant proceedings could become complicated and lead to protracted extradition proceedings.

This is not an instance where Defendant has raised trial errors for appellate review, because there was no trial. He has no argument that erroneous evidentiary rulings were made, that jury instructions were improper, that a verdict was against the weight of the evidence, nor even that the court improperly exercised its discretion in sentencing. The facts of the case are not complicated: the issue is whether Defendant had sexual intercourse with his girlfriend, then 15 years old. We view this as a situation where Defendant has changed his mind about pleading guilty only after experiencing life in prison.

Under these circumstances, and for these reasons, we have refused Defendant's request for bail.


