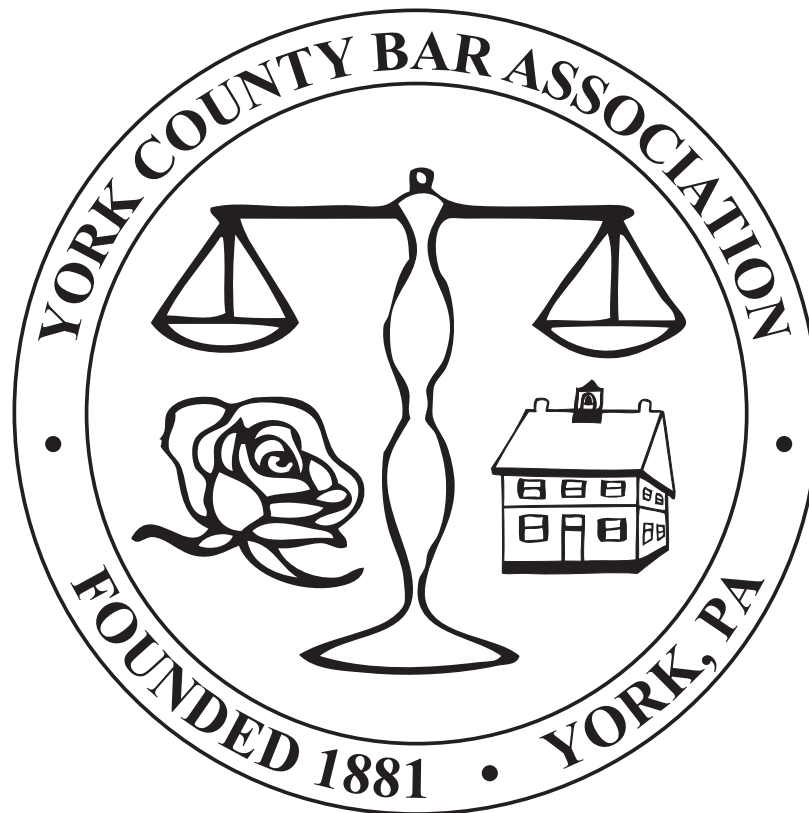

MEMORANDUM OPINION

This case is before the Court on Defendant UPMC's Preliminary Objection to Count V (Negligent Infliction of Emotional Distress) of Plaintiff's Complaint. Count V is a claim between Plaintiffs Mary Elsbeth and Jeffrey David Wirick against all Defendants. For the following reasons Defendant UPMC's Preliminary Objection to Plaintiff's claim of Negligent Infliction of Emotional Distress is **DENIED**.

FACTS AND PROCEDURAL HISTORY

Plaintiffs, Mary Elsbeth Wirick and Jeffrey David Wirick, are husband and wife. (herein "Parent Plaintiffs"). They are the parents and natural guardians of Plaintiff J.J.W., a minor child (herein "Minor Plaintiff"), collectively with his parents "Plaintiffs"). Defendants are Ravichamdran Suppiah, M.D., a physician licensed to practice anesthesiology in the Commonwealth (herein "Defendant Suppiah"), and Susan Adams, CRNA, a certified registered nurse anesthetist (herein "Defendant Adams"), both of which either maintain an office at or work for Defendant UPMC Memorial, a hospital located at 1701 Innovation Drive, York, PA 17408 (herein Defendant UPMC). Defendants Suppiah and Adams are also employees for or agents of Defendant North American Partners in Anesthesia LLC, (herein "Defendant NAPA").

On January 16, 2020, the Minor Plaintiff, who was four years old at the time, was admitted to Defendant UPMC's hospital as an outpatient to undergo eye muscle surgery. Defendant Suppiah was the attending anesthesiologist responsible for the child's care. Minor Plaintiff was administered general anesthesia with laryngeal mask airway and a balanced anesthetic when the surgery began at 12:09 p.m. At 12:53 p.m., Defendant Adams administered 1 mg. of morphine intraoperatively. In the recovery room at 1:13 p.m., Defendant Adams administered 4 mg of morphine to Minor Plaintiff. At 1:15 p.m. Defendant Adams gave the minor child 5 mg. of morphine. The morphine was ordered for agitation of the Minor Plaintiff. In total, Minor Plaintiff was given 10 mg. of morphine within twenty-one minutes, about eight times the recommended dose.

The Minor Plaintiff was out of recovery at 1:22 p.m., and was noted to be drowsy at 1:45 p.m. The Minor Plaintiff was discharged at 1:49 p.m. while not fully conscious. During discharge, Parent Plaintiffs were told that Minor Plaintiff was "given a little something to relax." At no time during the discharge were the Parent Plaintiffs informed that their son had received morphine, nor were they given any instructions or warnings regarding the harmful effects morphine could cause Minor Plaintiff.

After discharge, Parent Plaintiffs eventually noticed Minor Plaintiff was not waking up. They took Minor Plaintiff to Defendant UPMC's

Emergency Department where he was evaluated and found to be hypothermic, unresponsive, and acidotic. Minor Plaintiff was treated with Naloxone (for narcotic overdose) and fluid boluses before being transferred to the Pediatric Intensive Care Unit at Johns Hopkins Hospital. Minor Plaintiff remained at Johns Hopkins until January 31, 2020.

While at Johns Hopkins, Minor Plaintiff's labs and presentation were noted as "concerning for opioid intoxication possibly contributing end organ hypoxia..." Minor Plaintiff also received a brain MRI on January 22, 2020, which revealed a "constellation of findings compatible with acute/subacute hypoxic ischemic injury." Additionally, while at Johns Hopkins, Minor Plaintiff underwent consultations with pediatric neurology, metabolism/genetics analysis, surgery, cardiology and ophthalmology analysis. Minor Plaintiff had to have several procedures including lumbar puncture, EEG, ECG, an echocardiogram, CT scans, brain MRI, as well as ultrasounds of his abdomen, liver, kidney, and bladder. Minor Plaintiff also had various labs to detect viruses, bacterial infections, and to rule out metabolic etiologies, as well as others. The labs ruled out all potential causes of Minor Plaintiff's numerous injuries except for opioid toxicity.

Once Minor Plaintiff was discharged from Johns Hopkins, he was admitted to the Kennedy Krieger Institute on January 31, 2020 for rehabilitation. While at the Kennedy Krieger Institute, Minor Plaintiff had to undergo comprehensive rehabilitation for significant defects in his mobility, ability to participate in age-appropriate activities of daily life, and head/trunk control with ataxia. Minor Plaintiff remained at the Kennedy Krieger Institute until March 11, 2020.

Plaintiffs have filed a Complaint alleging Negligence against Defendant Suppiah, Negligence against Defendant Adams, Vicarious Liability against Defendant NAPA, Vicarious Liability against Defendant UPMC, and Negligent Infliction of Emotional Distress against all Defendants.

Plaintiffs filed their Complaint on October 13, 2020. Defendant UPMC filed a Preliminary Objection on November 23, 2020, under Pa.R.C.P. § 1028(a)(2) and (4). Plaintiffs filed a Response to Defendant UPMC's Preliminary Objection on November 25, 2020. Defendant UPMC filed a Brief in Support of Preliminary Objections on December 3, 2020. Plaintiffs filed a Brief in Opposition to Defendant UPMC's Preliminary Objections on December 15, 2020. This case was listed for One Judge Disposition on December 15, 2020, and the matter was assigned to this Court on December 22, 2020.

DISCUSSION

I. Preliminary Objection Standard

Preliminary Objections may be filed by any party to any pleading on the grounds that the pleading fails to conform to law or rule of court Pa.R.Civ.P. § 1028(a)(2). Preliminary Objections may also be based on the legal insufficiency of the pleading (demurrer) Pa.R.C.P. § 1028(a)(4). Preliminary objections in the form of a demurrer tests the legal sufficiency of a pleading. *Ins. Adjustment Bureau, Inc. v. Allstate Ins. Co.*, 860 A.2d 1038, 1041 (Pa. Super. 2004). Preliminary objections, which if sustained, would result in the dismissal of a cause of action should only be sustained where it is "clear and free from doubt." *Bower v. Bower*, 611 A.2d 181, 182 (Pa. 1992). Furthermore, preliminary objections should be granted "only where it appears with certainty that, upon the facts averred, the law will not allow the plaintiff to recover." *Snare v. Ebsburg Power Co.*, 637 A.2d 296 (Pa. Super. 1993).

In ruling on preliminary objections, all material facts in the complaint and all references that could be reasonably deduced therefrom, must be accepted as true. *Bill-Rite Contractors, Inc. v. The Architectural Studio*, 866 A.2d 270, 272 (Pa. 2005). A trial court may sustain a demurrer, and thereby dismiss a claim, only when the law is clear that a plaintiff is not entitled to recovery. *HCB Contractors v. Liberty Place Hotel Associates*, 652 A.2d 1278, 1279 (Pa. 1995). If there is any doubt as to whether the demurrer should be sustained, then it should be overruled. *Bruno v. Erie Ins. Co.*, 106 A.3d 48, 56 (Pa. 2014).

II. Negligent Infliction of Emotion Distress - Pa.R.C.P. § 1028(a)(2) and (4)

Defendant UPMC claims that Parent Plaintiffs' Negligent Infliction of Emotional Distress (NIED) claim fails under Pa.R.C.P. § 1028(a)(2) and (4). In Pennsylvania, a cause of action for NIED is recognized in four sets of circumstances:

- (1) situations where the defendant had a contractual or fiduciary duty toward the plaintiff;
- (2) the plaintiff was subjected to a physical impact;

(3) the plaintiff was in the zone of danger, thereby reasonably experiencing a fear of impending physical injury; or
(4) the plaintiff observed a tortuous injury to a close relative.

(4) are DENIED.

BY THE COURT:

Weiley v. Albert Einstein Med. Ctr., 51 A.3d 202, (Pa. Super. 2012)

In *Toney v. Chester County Hospital*, 36 A.3d 83 (Pa. 2011), an evenly divided Pennsylvania Supreme Court held that NIED is not available in garden-variety breach of contractual or fiduciary duty cases, but only in those cases where there exists a special relationship where it is foreseeable that a breach of the relevant duty would result in emotional harm so extreme that a reasonable person should not be expected to endure the resulting distress. The Court did not identify all of the qualifying relationships that would be subject to a NEID claim, instead holding:

... relationships involving life and death fall within this category. It is impossible, and indeed would be irresponsible on our part, to create an exhaustive list of qualifying relationships in this opinion. Rather, we find it prudent to leave the legal question of whether a sufficient duty exists to our trial judges to decide on a case-by-case basis, at some point prior to trial, be it preliminary objections, summary judgment, or the like. Nonetheless, we would hold that some relationships, including some doctor-patient relationships, will involve an implied duty to care for the plaintiff's emotional well-being that, if breached, has the potential to cause emotional distress resulting in physical harm. 36 A.3d at 95

Toney involved a radiologist who erroneously reported that plaintiff's prenatal ultrasound was normal, causing plaintiff to suffer severe shock and emotional distress when she gave birth to a child with physical abnormalities. Having found Plaintiff stated a viable claim for NIED the trial court's granting of preliminary objections was reversed.

Defendant UPMC argues that Plaintiffs' NIED claim fails in regards to Parent Plaintiffs because they have not demonstrated the necessary special relationship with Defendant UPMC. They assert that the patient-physician duties flowed from UPMC to the minor child, not to his parents. Additionally, Defendant UPMC alleges that Plaintiffs failed to establish the necessary elements for a negligence claim in their Complaint. Finally, Defendant UPMC asserts that Parent Plaintiffs were not actually present when the alleged negligence took place and, therefore, recovery is not permitted.

Parent Plaintiffs counter that there was in fact a special relationship between them and Defendant UPMC. Parent Plaintiffs point to the fact that they were required to sign all of the consent forms given the child's age and all of the discharge instructions were given directly to them. Moreover, they believe that have met the necessary elements for negligence claims: duty, breach, causation and damages. In particular, the child's inability to understand his medical care required Defendant UPMC (*a duty*) to provide his parents with important information and discharge instructions. The information and instructions provided were grossly inadequate and incomplete (*breach of duty*). The child was very near death, leading foreseeably (*causation*) to their shock and severe emotional distress (*damages*). Parent Plaintiffs also argue that the fact that they did not witness the negligent administration of morphine is irrelevant as it relates to only one aspect of Defendant UPMC's overall negligent conduct.

Given the standard for preliminary objections the Court finds that Parent Plaintiffs have alleged sufficient facts to support a negligent infliction of emotional distress claim against Defendant UPMC. There was a special relationship between Parent Plaintiffs and Defendant UPMC which was established by virtue of the child's very young age and the need for his parents to receive the discharge information. The allegations assert that the information provided was wholly inadequate which almost resulted in the child's death. The allegations further allege that Parent Plaintiffs suffered emotional distress. Specifically, Parent Plaintiffs, are alleged to have suffered physical, emotional and mental injuries including, but not limited to, shock, anxiety, headaches, sleep disturbance, crying spells, fear, depression, mental and emotional anguish. Taken in total, the allegations are sufficient to survive a preliminary objection challenge. It is not imperative that the Parent Plaintiffs did not witness the negligent administration of morphine as that is only one aspect of the underlying claim.

CONCLUSION

For the reasons stated herein, Defendant UPMC's Preliminary Objections to Plaintiffs' NIED claim, based on Pa. R.C.P. 1028(a)(2) and
