Obiter Dictum

From the ABA Journal Daily Newsletter: : [1]The U.S. Court of Appeals for the Sixth Circuit has refused to disturb a 14-day temporary restraining order allowing some abortions needed to save a women's life or health or to preserve the ability to obtain an abortion before viability to continue during Ohio's ban on non-elective surgeries.; [2] A federal judge in Chicago has ordered the sheriff of Cook County to take measures to curb the spread of COVID-19 in the county jail, where there is a high rate of infections that led to two inmate deaths. According to the opinion, the infection rate for COVID-19 at the jail is 50 per 1,000 people, the highest rate in the country.; [3] Based upon controlling precedent, a U.S. District Judge in Maryland has upheld a ban in Ocean City, Maryland prohibiting women exposing their breasts in public finding no equal-protection violation. "Whether or not society should differentiate between male and female breasts is a separate inquiry from whether it is unconstitutional to do so."; [4] The American Civil Liberties Union and the ACLU of Georgia have filed a lawsuit contending that election officials' failure to pay postage on mail-in ballots amounts to an unconstitutional poll tax. The suit is seeking a preliminary injunction requiring officials to provide prepaid return envelopes for the ballots and for ballot applications. According to the suit, filed in federal court in Atlanta, voters should not have to expose themselves to COVID-19 just to get stamps for voting.; [5] The Oklahoma Governor has commuted the sentences of 452 inmates in an effort to reduce the risk of COVID-19 spreading behind bars. Most of the inmates are imprisoned for drug related crimes and most will see their sentences commuted to time served.; [6] A U.S. District Judge in Maryland has temporarily banned the City of Baltimore from using planes to collect photographs as part of a new crime-fighting program. The order was entered in connection with a lawsuit filed by the American Civil Liberties Union and the ACLU of Maryland challenging the constitutionality of the surveillance program in light of the Fourth Amendment right to be free from unreasonable searches and the constitutional right to free association.; [7] The Kansas Supreme Court has upheld the right of the governor to limit church services to 10 people or less pursuant to a state law giving the governor the power to declare a disaster emergency on the basis that while the legislature has the ability to revoke such a the declaration and orders related thereto, the legislature must be in session in order to do so which it is not.




