#### NOTICE TO ALL ATTORNEYS

On January 6, 2018, The Pennsylvania Supreme Court's new Public Access Policy takes effect. This policy will alter the way you draft documents for filing with the Court.

Mercer County has elected to follow Option 1. Option 1 requires that all pleadings be drafted so that no confidential information or documents are in the pleadings. "Confidential Information" is defined as follows:

- 1. Social Security Numbers;
- 2. Financial Account Numbers, except an active financial account number may be identified by the last four digits when the financial account is the subject of the case and cannot otherwise be identified;
- 3. Driver License Numbers:
- 4. State Identification (SID) Numbers;
- 5. Minors' names and dates of birth except when a minor is charged as a defendant in a criminal matter (see 42 Pa.C.S. § 6355); and
- 6. Abuse victim's address and other contact information, including employer's name, address and work schedule, in family court actions as defined by Pa.R.C.P. No. 1931(a), except for victim's name.

"Confidential Documents" are defined as follows:

- 1. Financial Source Documents:
- 2. Minors' educational records;
- 3. Medical/Psychological records;
- 4. Children & Youth Services' records;
- 5. Marital Property Inventory and Pre-Trial Statement as Provided in Pa.R.C.P. No. 1920.33;
- 6. Income and Expense Statement as provided in Pa.R.C.P. No. 1910.27(c); and
- 7. Agreements between the parties as used in 23 Pa.C.S. § 3105.

The confidential information or documents must be put on a Confidential Information Form. That form is to be designed by The Administrative Office of Pennsylvania Courts.

The burden of complying with the new policy is entirely upon the person filing the document. The filing office will not review it to see if it is correct.

If the person fails to comply with the policy, the Court has the power to impose "appropriate sanctions", including, but not limited to, costs necessary to prepare a pleading in compliance with the policy.
