

The following cases were addressed by the Honorable <u>Janine Edwards, President Judge</u> Wayne County:

HONESDALE, PA — January 30, 2020

VINCENT DEGROAT JR., age 27 of Honesdale, PA, was placed on probation for a period of 9 months for one count of Simple Assault (M3). He was also ordered to pay the costs of prosecution. Undergo a drug and alcohol evaluation and comply with all recommendations for treatment and complete an anger management program through a provider approved by your probation officer. The incident occurred on August 12, 2019 in Honesdale Borough, Wayne County.

DAVID JACQUES, age 22 of Beach Lake, PA, was sentenced to the Wayne County Correctional Facility for a period of 15 months nor more than 30 months (time served) for one count of Possession of Controlled Substance- Marijuana (M), one count of Possession of Controlled Substance- MDMA (M) and one count of Possession of a Controlled Substance-Acid (LSF) (M). He was also ordered to pay the costs of prosecution, pay a fine in the amount of \$300.00, and obtain employment within 30 days of parole or provided documentation from a doctor precluding you from employment. The incident occurred on September 20, 2018 in Honesdale Borough, Wayne County.

BRANDON ALECKNA, age 19 of Waymart, PA, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to DUI. She was also ordered to pay all Court costs and perform 25 hours of community service. The incident occurred on August 31, 2019 in Honesdale Borough, Wayne County.
