Commonwealth vs. Hamara

Possession of instrument of crime - Writ of habeas corpus

- 1. 18 Pa.C.S. §907(a), Possessing an Instrument of Crime, provides a person commits a misdemeanor of the first degree if he possesses any instrument of crime with intent to employ it criminally; subsection (d) defines an instrument of crime as anything specially made or specially adapted for criminal use or anything used for criminal purposes and possessed by the actor under circumstances not manifestly appropriate for lawful uses it may have.
- 2. The allegations are that the defendant ripped his t-shirt off, tore it in half, stuffed it into the alleged victim's mouth, and wrapped it around her neck. Such conduct meets the definition of instrument of crime as a t-shirt need not be commonly used for criminal purposes if it was used for criminal purposes and possessed under circumstances not manifestly appropriate for lawful uses it may have. The Court Held Defendant's Petition for Writ of Habeas Corpus as to Count 12, charging 18 Pa.C.S. §907(a), Possessing an Instrument of Crime, was denied.

<u>ORDER</u>

AND NOW, this 14th day of June, 2024, upon consideration of Defendant's Petition for Writ of Habeas Corpus filed May 17, 2024, the Commonwealth's response thereto, the transcript of the preliminary hearing on October 12, 2023, and the statements on the record at the June 7, 2024 hearing, it is hereby **ORDERED** that the Petition is **GRANTED** in part and **DENIED** in part as follows:

- The Petition is GRANTED insofar as the Commonwealth concedes in its Brief in Response to Defendant's Memorandum of Law in Support of his Petition for Habeas Corpus filed June 14, 2024 (Commonwealth Brief) that it concedes to the Defendant's request regarding: (i) Count I 18 Pa.C.S. § 901(a)-2502(a) Attempted Murder; (ii) Count 3 18 Pa.C.S. § 3701(a)(1) (i) Robbery Inflicts Serious Bodily Injury; and (iii) Count 5 18 Pa.C.S. § 3701(a)(1)(ii) Robbery Commits a Felony of the First or Second Degree. Accordingly, those charges are STRICKEN; and
- The Petition is **DENIED** as to Count 12 18 Pa.C.S. §907(a) Possessing an Instrument of Crime. Specifically, the allegations are that the defendant ripped his t-shirt in half and "hulked his shirt off," stuffed it into the alleged victim's mouth, and wrapped it around her neck. See Notes of Testimony, 10/12/23 at 55-60. 18 Pa.C.S. § 907(a) provides that "A person commits a misdemeanor of the first degree if he possesses any instrument of crime with intent to employ it criminally." Subsection (d) defines instrument of crime as "(1) Anything specially made or specially adapted for criminal use" or "(2) Anything used for criminal purposes and possessed by the actor under circumstances not manifestly appropriate for lawful uses it may have." Defendant points to Commonwealth v. Rodriguez, 462 A.2d 1310 (Pa.Super. 1983), in which the Superior Court held, under a prior version of Section 907, that a double-edged razor blade used in a killing did not meet the statutory definition of an instrument of crime. That version of Section 907 defined an instrument of crime as "(2) anything commonly used for criminal purposes " 18 Pa.C.S. § 907(d)(2) (emphasis added). As noted by the Superior Court in Commonwealth v. Vida, 715 A.2d 1180, 1182-83 (Pa.

Super. 1998), the legislature, possibly in response to a concurring opinion in Commonwealth v. Ngow, 652 A.2d 305 (Pa. 1995), amended the definition to delete the word "commonly." As the Ngow opinion noted, deletion of the word "commonly" would "effectuate the original intent of the statute defining criminal instruments: to establish a separate and distinct crime for any person who possesses and uses ordinary items for criminal purposes under circumstances not manifestly appropriate for lawful uses that the item may have." Id. at 307. For example, the Vida court held that a paint stick used to write graffiti was an instrument of crime because of the way in which it was used. Id. at 1183.1 Accordingly, a t-shirt need not be commonly used for criminal purposes; rather, it must be used for criminal purposes and possessed under circumstances not manifestly appropriate for lawful uses it may have. Tearing a t-shirt in half to specifically stuff in somebody's mouth and wrap around their neck meets the current definition of instrument of crime. See also Commonwealth v. Fisher, 2015 WL 9306912 (Pa.Super. 2015) (finding that notes written by a defendant in committing a robbery threatening violence were instruments of crime); Commonwealth v. Hynson, 2014 WL 10575169 (Pa.Super. 2014) (holding that gasoline used to commit arson was an instrument of crime). Here, the t-shirt is not alleged to have facilitated crime but is rather alleged to have been the instrument through which some of the alleged crimes (e.g. strangulation, recklessly endangering another person) were committed. Accordingly, the relief requested for Count 12 is denied.

The Superior Court specifically rejected an argument that the item must be possessed or used in a manner wholly different than that inherent in its lawful possession or use. "If we employ such a construction, appellant explains, the graffiti artist is not guilty of PIC because he has merely painted with a paint stick (albeit on public property); the forger is not guilty of PIC since he has merely written with a pen (although his writing was fraudulent); the cocaine user is not guilty of PIC since he has only ingested a substance with a straw (despite the fact that the substance is illegal and he has ingested it into his nose, not his mouth); and the drunk driver's car is not an instrument of crime since it was used for its intended purpose: driving (though while under the influence of alcohol)." <u>Id.</u> at 1183. Here, the use is not a lawful use in any event but the court finds the list of rejected examples enlightening for the case *sub judice*.
