1. Advertisements of the Grant of Letters to the Co-Executrixes were run in the Adams County Legal Journal on February 22, 2019, March 1, 2019 and March 8, 2019. Advertisements of the Grant of Letters to the Co-Executrixes were run in the Gettysburg Times on February 18, 2019, February 25, 2019 and March 4, 2019.

2. Respondent did not file her Notice of Claim pursuant to 20 Pa. C.S. §3532 until August 25, 2020, more than seventeen months after the first complete advertisement of the Grant of Letters.

3. Petitioner argues that Respondent's Notice of Claim was not timely filed because such claim was known to Respondent and such claim was not made within one year after the first complete advertisement of the Grant of Letters.

4. Respondent does not contest the application of 20 Pc.C.S.§3532 but instead claims she was unaware of the statutory requirements and relied on counsel for the Estate to inform her of all statutory requirements. Her failure to know the statutory requirements and her reliance on Estate counsel do not excuse the requirements to file a claim within one year under 20 Pa. C.S. §3532(b)(1). Therefore, the filing of such claim was untimely.

OPINION

Before this Court for disposition is Leonard J. Martin, Jr.'s (hereinafter "Petitioner") Motion to Refuse Notice of Claim Filed by Co-Executrix Judy West Against the Estate of Leonard J. Martin, Sr. as Untimely Filed. For the reasons set forth herein, Petitioner's Motion is granted and Judy West's (hereinafter "Respondent") Notice of Claim, filed August 25, 2020, is hereby dismissed.

BACKGROUND

Leonard J. Martin, Sr. ("Decedent") died on January 20, 2019 with his last principal residence at 1871 Herrs Ridge Road, Gettysburg, Adams County, Pennsylvania 17325. The Decedent died testate leaving his Last Will and Testament ("will"), dated January 10, 2019. The Decedent's will was admitted to probate on January 29, 2019, and the Adams County Register of Wills granted Letters Testamentary to the Decedent's daughter, Beverly A. Martin-Gross

and the Respondent as Co-Executrixes. The Decedent is survived by three children, Petitioner, daughter Rebecca M. Martin and daughter Beverly A. Martin-Gross. In pertinent part, the second article of the will directs that the residue and remainder of the estate be distributed evenly between the Decedent's children, Petitioner, Rebecca M. Martin and Beverly A. Martin-Gross.

Advertisements of the Grant of Letters to the Co-Executrixes were run in the Adams County Legal Journal on February 22, 2019, March 1, 2019 and March 8, 2019. Advertisements of the Grant of Letters to the Co-Executrixes were run in the Gettysburg Times on February 18, 2019, February 25, 2019 and March 4, 2019.

On or about October 3, 2019 the Estate filed its Pennsylvania inheritance tax return with the Pennsylvania Department of Revenue. The inheritance tax return was signed by Respondent and Schedule J of the inheritance tax return designated the beneficiaries as Petitioner, Rebecca M. Martin and Beverly A. Martin-Gross, with each receiving a share of 33.33% of the estate.

On August 25, 2020 Respondent filed Notice of Claim against the Estate pursuant to 20 Pa. C.S. §3532. On November 19, 2020 Petitioner filed Motion to Refuse Notice of Claim Filed by Co-Executrix Judy West Against the Estate of Leonard J. Martin, Sr. as Untimely Filed and brief in support of such motion. On December 10, 2020 Respondent timely filed Answer to Motion to Refuse Notice of Claim by Co-Executrix Judy West Against the Estate of Leonard J. Martin, Sr.

This Court treats Petitioner's Motion to Refuse Notice of Claim Filed by Co-Executrix Judy West Against the Estate of Leonard J. Martin, Sr. as Untimely Filed as a preliminary objection to Respondent's Notice of Claim in accordance with Pennsylvania Orphans' Court Rules, Rule 3.9. Petitioner challenges Respondent's Notice of Claim as untimely filed in accordance with 20 Pa. C.S. §3532(b)(1).

LEGAL STANDARD

Preliminary objections are limited to the grounds listed in Pa.O.C. Rule 3.9. It is well established that in ruling on preliminary objections, this Court must accept as true all well-pleaded allegations of material fact as well as all inferences reasonably deductible from those facts. *Ballroom, LLC v. Commonwealth*, 984 A.2d 582, 586 (Pa. Commw. Ct. 2009). Preliminary Objections will be sustained where the case is clear and free from doubt. *Rambo v. Greene*, 906 A.2d 1232, 1235 (Pa. Super. 2006).

DISCUSSION

Petitioner argues that Respondent's Notice of Claim was not timely filed because such claim was known to Respondent and such claim was not made within one year after the first complete advertisement of the Grant of Letters.

Under 20 Pa.C.S. §3532, a claimant must make a claim known to the estate within one year after the first complete advertisement of the grant of letters. The completion of the advertisement of the Grant of Letters occurred on March 8, 2019. Respondent did not file her Notice of Claim pursuant to 20 Pa.C.S. §3532 until August 25, 2020, more than seventeen months after the first complete advertisement of the Grant of Letters. As Co-Executrix of the Estate, Judy West was aware of the dates of the Grant of Letters. Further, Respondent does not contest the application of 20 Pa.C.S. §3532 but instead claims she was unaware of the statutory requirements and relied on counsel for the Estate to inform her of all statutory requirements. Her failure to know the statutory requirements to file a claim within one year under 20 Pa.C.S. §3532(b)(1). Therefore, the filing of such claim was untimely.

Because the filing of Respondent's claim was untimely, Petitioner's Motion to Refuse Notice of Claim Filed by Co-Executrix Judy West Against the Estate of Leonard J. Martin, Sr. as Untimely Filed is granted. Accordingly, the attached Order is entered.

ORDER OF COURT

AND NOW, this 7th day January, 2021, in consideration of Petitioner's Motion to Refuse Notice of Claim Filed by Co-Executrix Judy West Against the Estate of Leonard J.
