# **Obiter Dictum**

From the ABA Journal Daily Newsletter: [1] The Supreme Court of Texas has ruled that a federal law protecting websites that publish third party content doesn't insulate Facebook from sex trafficking lawsuits that are based on a state statute. In a recent opinion, the state Supreme Court allowed the statutory claim by three Houston women who alleged that their abusers recruited them as teenagers through Facebook. The Texas law creates a civil cause of action for intentionally or knowingly benefitting from participation in sex trafficking. The Court dismissed other claims for negligence and products liability that were based on an alleged failure to warn about sex trafficking or to take measures to prevent it on its platforms. Those claims had to be dismissed because of the protections in Section 230 of the Communications Decency Act. [2] An en banc Federal Appeals Court has ruled that a warrantless ariel surveillance program run by the Baltimore Police Department violated the Fourth Amendment. The ruling came in a lawsuit filed on behalf of grassroots community advocates by the American Civil Liberties Union and the ACLU of Maryland. The program was known as The Ariel Investigation Research Program. The planes conducted surveillance in Baltimore using high tech cameras to record "the movements of the city" and ariel photography was used to track movements of people in vehicles in connection with serious crimes. According to the majority opinion, because the "program enables police to deduce from the whole of individuals movements, that accessing it's data is a search and it's warrantless operation violates the Fourth Amendment." [3] Several abortion rights advocates and providers have filed a federal lawsuit challenging a new Texas law that permits private citizens to sue doctors, clinics and anyone else who knowingly helps a pregnant person get an abortion after a fetal heartbeat is detected. "If not blocked, the law will force abortion providers and others who are sued to spend massive amounts of time and money to defend themselves in lawsuits across the state, in which the deck is heavily stacked against them, according to the complaint if not blocked." The new Texas law, which took effect September 1, 2021, prevents abortions after a doctor detects a fetal heartbeat, typically at about 6 weeks of pregnancy. It contains an exception only for medical emergencies but not for rape or incest. As part of the law, anyone inside or outside of Texas can sue those who violate its terms and potentially be awarded at least \$10,000.00 per illegal abortion if they are successful.
