PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE DRUG INVESTIGATION YIELDS LARGE HEROIN/FENTANYL SEIZURE IN PIKE COUNTY

June 25, 2020 — MILFORD, PA. Pike County District Attorney Ray Tonkin and the Pennsylvania State Police announced the seizure of a large amount of suspected heroin/fentanyl and the arrest of two individuals on June 25, 2020. The Pennsylvania State Police vice unit, along with the Pike County District Attorney's Office, conducted a two month investigation into the supplier of a large quantity of heroin to Northeastern Pennsylvania. The investigation revealed that Kenneth Smith of Honesdale, Pennsylvania would be bringing a large quantity of heroin/fentanyl from Paterson New Jersey to Northeastern Pennsylvania during the overnight hours of June 25th. Troopers made contact with Kenneth Smith who was operating a rental vehicle registered in Florida at a hotel in Milford Township, Pike County at 4:30 a.m. June 25th. Smith and his passenger, Paul Wassel, were arrested on probable cause of possession of a controlled substance with intent to deliver and criminal conspiracy.

After the arrest, troopers obtained a search warrant for the vehicle Smith was driving from Magisterial District Judge Randy Schmalzle. According to the charges troopers

searched the vehicle and located over 2300 bags of suspected heroin/fentanyl located in the engine compartment of the vehicle and over \$600.00 in cash. The street value of the heroin/fentanyl is approximately \$23,000.00.

Charged¹ in the investigation to date are: Kenneth Smith, age 38, of Honesdale, Pennsylvania and Paul Wassel, age 51 of Taylor, Pennsylvania. Each are charged with possession of a controlled substance with intent to deliver, i.e. heroin, and criminal conspiracy to deliver a controlled substance, both are felony charges. Smith was also charged with delivery of a controlled substance, heroin, for a previous sale of the drug and tampering with evidence for attempting to hide some heroin in his mouth after he was stopped by troopers. Both Smith and Wassel were arraigned on the charges before Magistrate Deborah Fischer and bail set at \$ 800,000.00 each. Both were remanded to the Pike County Correctional Facility in lieu of posting bail.

The agencies taking part in the investigation were and the Pennsylvania State Police vice unit and the Pike County District Attorney's Office Criminal Investigation Division. The Wayne County District Attorney's Office also assisted in the investigation.

Tonkin commended the continued effort of law enforcement to investigate large drug dealers in our community and the region at large. Tonkin stated: "That troopers conducted this investigation in the middle of the night shows that drug dealers can have no rest or comfort and that at any time of the day or night police will be working hard for the good citizens to investigate and arrest drug dealers.' According to Tonkin this is a large seizure of heroin/fentanyl for this area and likely prevented several overdoses from the drugs.

A preliminary hearing for both Smith and Wassel will be scheduled before Magisterial District Judge Deborah Fischer in Pike County.

PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE TWO CHARGED AFTER DRUG RAID IN WESTFALL TOWNSHIP

June 24, 2020 — MILFORD, PA. Pike County District Attorney Ray Tonkin and the Pennsylvania State Police announced the seizure of a large amount of suspected heroin/fentanyl and the arrest of two individuals on June 25, 2020.

Milford, Pa.-Pike County District Attorney Ray Tonkin announced the arrest of two individuals after a search warrant was served on a hotel room in Westfall Township, Pike County. The search warrant and arrests came after an investigation by the Pike County District Attorney's Office Criminal Investigation Division and member agencies of the Pike County Drug Task Force.

Charged¹ in the investigation are: Kyle Conklin, age 27, of Westfall Township, and Susan J. Beam, age 42 of Wallkill, N.Y. Each are charged with possession of a controlled substance with intent to deliver, i.e. heroin, and criminal conspiracy to deliver a controlled substance, both are felony charges. Conklin was also arrested for a violation of his parole and remanded to the Pike County Correctional Facility. Beam was arraigned on the charges before Magistrate Deborah Fischer and bail set at \$ 100,000.00. Beam was remanded to the Pike County Correctional Facility in lieu of posting bail.

According to the criminal charges, investigators served a search warrant on a hotel room at a local motel. In the room investigators located over 120 bags of suspected

heroin, \$ 237.00 in U.S. currency and drug paraphernalia.

The agencies taking part in the investigation and service of the search warrant were the Pike County District Attorney's Office Criminal Investigation Division, the Eastern Pike Regional Police Department, the Pennsylvania State Police at Blooming Grove, and the Pennsylvania State Police vice unit.

Tonkin commended the ongoing effort of law enforcement to investigate drug dealers in our community and the cooperation of hotel management. Tonkin stated: "Here the management of the hotel went by the phrase "If you see something, say something." Hotel management contacted police about their belief of what may be going on inside the hotel room and investigators were able to confirm those beliefs and execute a search warrant on the hotel room. We certainly need a shared trust between the community and law enforcement to help keep the community safe for residents and businesses, and we greatly appreciate the assistance of hotel management in this case."

A preliminary hearing for both Conklin and Beam is scheduled before Magisterial District Judge Deborah Fischer on July 8, 2020.

June 15, 2020 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Nicholas Bradley Zoeller, age 29, of Stroudsburg, PA, was sentenced to 149 days to 23 months in the Pike County Jail and fined \$300.00 for the crime of Endangering the Welfare of a Child. Zoeller was responsible for the supervision of a five year old child on July 18, 2019, while at various locations in Lehman Township and while being under the influence of drugs. Zoeller became disoriented and the child was lost while under his care, the child was located and uninjured.

Kevin M. Lemma, age 29, of Holbrook, NY, was sentenced to 1 year to 3 years in a state correctional facility, to run concurrent to his New York sentence, and fined \$1,500.00 for the 3 counts of the crime of Burglary. In September of 2013, Lemma entered 3 residences in Lackawaxen Township, without the permission of the property owners, taking items valued in excess of \$2,000.00 and causing damage to the residences in excess of \$1,000.00.

Sherry Desmond, age 41, of Shohola, PA, was sentenced to 12 months of probation and fined \$500.00 for the crime of Endangering the Welfare of a Child. Between May of 2018 and July of 2018, Desmond allowed a black bear to repeatedly enter her residence in Dingman Township while her minor child was present. Desmond and her codefendant, would feed and interact with the bear putting the minor at risk of serious bodily injury or death.

Francheska Marie Santiago, age 25, of Jersey City, NJ, was sentenced to 6 months of probation and fined \$300.00 for the crime of Disorderly Conduct. Santiago engaged in a physical altercation with an individual at a retail store parking lot in Westfall Township on August 13, 2019.

Steve M. Height, age 36, of Mill Rift, PA, was sentenced to 6 months of probation and fined \$300.00 for the crime of Possession of a Firearm or Other Dangerous Weapon in a Court Facility. Height attempted to gain entrance into the Pike County Administration Building while in possession of brass knuckles on October 9, 2019.
