UNITED STATES THIRD CIRCUIT VACANCY ANNOUNCEMENT FEDERAL PUBLIC DEFENDER IN THE DISTRICT OF NEW JERSEY

Chief Judge D. Brooks Smith of the United States Court of Appeals for the Third Circuit announces the application process for the Federal Public Defender in the District of New Jersey.

Qualifications for the Position of Federal Public Defender

An applicant should have the following qualifications: a member in good standing in the bar of each state in which admitted to practice; a minimum of five years criminal practice experience, preferably with significant federal criminal trial experience, which demonstrates an ability to provide zealous representation of consistently high quality to criminal defendants; the ability to effectively administer the office; a reputation for integrity; and (S) a commitment to the representation of those unable to afford counsel.

Qualified candidates will be considered equally and without regard to race, sex, religious affiliation, national origin, age or disability.

Federal Public Defenders may not engage in the private practice of law and are subject to full background investigations and to judiciary financial disclosure requirements.

Term and Salary

A Federal Public Defender is appointed to a four-year term pursuant to 18 U.S.C.§ 3006A, and compensation is currently set at \$172,500 per annum.
