## Ottensman vs. Piskorski, et al.

Expert testimony – Podiatrist - Medical Care Availability and Reduction of Error Act – Motion in *Limine* 

- 1. 40 P.S. § 1303.512(a) of the Medical Care Availability and Reduction of Error Act provides no person shall be competent to offer an expert medical opinion in a medical professional liability action against a physician unless that person possesses sufficient education, training, knowledge and experience to provide credible, competent testimony and fulfills the additional qualifications set forth in that section.
- 2. A podiatrist is not a physician and therefore does not fall within the scope of 40 P.S. § 1303.512.
- 3. Defendants filed a Motion in *Limine*, seeking preclusion of Plaintiff's experts from testifying that Defendants' negligence caused Plaintiff's injuries on the ground that Plaintiff's experts do not meet the qualifying criteria set forth at § 1303.512. The Court determined Defendants' reliance on § 1303.512 was misplaced because it applies only in an action brought against a physician and a podiatrist is not a physician. Accordingly, the Court Held Defendants' Motion in *Limine* was denied.

## MEMORANDUM

Plaintiff ably set forth Plaintiff's theory of the case in her Administrative Conference Memorandum filed April 7, 2023, as follows:

This is a professional liability action arising from podiatric care provided to Plaintiff Amy Ottensman by Dr. Edward Piskorski, as an agent of Craig T. McHugh, DPM, PC. Ms. Ottensman alleges negligence regarding the bilateral plantar faciotomies performed by Dr. Piskorski on June 17, 2015. More specifically, Ms. Ottensman suffered from bilateral Calcaneal stress fractures upon initial presentation to Dr. Piskorski that went unnoticed and untreated, before and after the bilateral plantar fasciotomies. Dr. Piskorski also allowed Ms. Ottensman to walk in sneakers post operatively. Walking in a sneaker immediately post operatively after a plantar fasciotomy is below the standard of care.<sup>2</sup>

Memorandum, 4/7/2023, p. 1 (footnote added).

By their Motion *in Limine*, Defendants ask this court to preclude Plaintiff's experts (Sara Marks Tabby, M.D. and Howard Shapiro, D.P.M.) from testifying that Defendants' negligence caused Plaintiff's Chronic Regional Pain Syndrome (CRPS), RSD, and Chronic Neuropathic Pain Syndrome on the ground that Plaintiff's experts do not meet the qualifying criteria set forth at § 1303.512 of the Medical Care Availability and Reduction of Error Act, 40 P.S. § 1303.101, *et seq*. Motion, 5/14/2024, ¶¶ 18-21. *See also* Brief, 5/14/2024, pp. 4-5.

By her Response, Plaintiff clarifies that Plaintiff intends for Plaintiff's experts to testify that Defendants' negligence caused Plaintiff's Chronic Neuropathic Pain Syndrome, not that Defendants' negligence caused CRPS or RAD. Response, 5/24/2024, ¶ 11. Apart from that, Plaintiff argues, among other things, that Defendants' reliance on 40 P.S. § 1303.512 is misplaced because it applies only in an action brought against a physician and a podiatrist is not a physician. Response, 5/24/2024, ¶ 19 (citing Freed v. Geisinger Medical Center, 971 A.2d 1202 (Pa. 2009); Wexler v. Hecht, 928 A.2d 973 (Pa. 2007); and Price v. Catanzariti, 138 A.3d 8 (Pa.Super. 2016)).

Here, this court finds merit in Plaintiff's argument. By its express terms, 40 P.S. § 1303.512 sets forth the qualifying criteria for experts in a medical professional liability action against a *physician*. 40 P.S. § 1303.512(a) ("No person shall be competent to offer an expert medical opinion in a medical professional liability action against a *physician* unless that person possesses sufficient education, training, knowledge and experience to provide credible, competent testimony and fulfills the additional qualifications set forth in this section as applicable.") (emphasis added). The Superior

#### Ottensman vs. Piskorski, et al.

Court explained that a podiatrist is not a physician within the scope of 40 P.S. § 1303.512, as follows:

By statute, podiatrists are not "physicians." *See*, 1 Pa.C.S.A. § 1991 (defining "physician" in relevant part as a person licensed "to engage in the practice of medicine and surgery in all its branches"); 63 P.S. 422.2 (defining "physician" as a "medical doctor" or "doctor of osteopathy"; further defining "medical doctor" as one who is licensed by the State Board of Medicine); 63 P.S. § 42.1 *et seq.* (podiatrists are licensed by the State Board of Podiatry); 40 P.S. § 1303.103 (distinguishing between physicians and podiatrists in the definition of "health care provider")."

Wexler v. Hecht, 847 A.2d 95, 103 (Pa.Super. 2004), affirmed, 928 A.2d 973 (Pa. 2007).

It follows that 40 P.S. § 1303.512 does not apply to this case since Defendants are podiatrists and not physicians and thus cannot invoke the qualifying criteria set forth at 40 P.S. § 1303.512 to argue that Plaintiff's experts are not qualified to testify that Defendants' negligence caused Chronic Neuropathic Pain Syndrome.

Accordingly, for the reasons set forth above this court will enter an order denying Defendants' *Motion in Limine* filed May 14, 2024.
