SUMMARY OF OPINION:

Plaintiffs initiated this personal injury action against a tractor-trailer driver and his employer as a result of a highway accident, which crash was the driver's third tractor- trailer collision within his first month of employment. The record contained evidence that: (1) the driver exaggerated the extent of his prior tractor-trailer experience on his employment application; (2) the employer failed to conduct any past employment investigation as required by federal regulations to verify the driver's prior experience; (3) the employer disregarded industry standards by neglecting to terminate the driver, or at a minimum, to compel him to undergo immediate remedial training after he was involved in his first preventable crash during his probationary period; (4) the employer egregiously ignored those same standards when the employer continued to allow the driver to operate its tractor-trailers without first completing clearly indicated safety training, even after he was involved in a second preventable accident eight days after his first accident; and (5) an industry expert opined that the employer's actions "represented a reckless indifference" and "a reckless disregard to the safety of the motoring public," and that the third collision at issue resulted from the employer "knowingly and recklessly allowing an unsafe driver to continue operating one of its tractor-trailers." Based upon that evidence, plaintiffs sought to recover compensatory and punitive damages from the driver and his employer.

Defendants filed a motion for partial summary judgment seeking (a) to dismiss the driver as a named party since the employer admitted, for purposes of vicarious liability, that the driver was acting within the scope of his employment at the time of the accident, and (b) to strike the punitive damages claims against both defendants on the basis that the proffered evidence of recklessness was insufficient as a matter of law. Under the theory of respondeat superior, the primarily liable employee and the vicariously liable employer are not joint tortfeasors, and the goal of vicarious liability is to provide a secondary fund of recovery if the employee-tortfeasor lacks the ability to pay. Pennsylvania law permits an injured plaintiff to sue both the primarily liable employee and the vicariously liable employer and obtain a recovery from either party, and because defendants did not cite any authority to the contrary in those instances where the employer concedes an agency relationship, their motion to dismiss the employee as a named defendant was denied.

Plaintiffs did not allege that the driver's conduct at the time of the accident was reckless, and instead based their punitive damages claim against him on the single ground that he overstated his tractor-trailer driving experience on his employment application. However, the record lacked any evidence, or even a reasonable inference, that the driver knew or should have realized that there was a strong probability that harm to others may result from his misrepresentation, as a result of which the evidence was insufficient to sustain the punitive damages claim against him. In contrast, the record contained adequate evidence, including the opinions of an industry expert, to support plaintiffs allegations of recklessness and their accompanying claim for punitive damages against the employer. Therefore, the motion for partial summary judgment with respect to the punitive damages claims was granted as to the employee, but denied with regard to the employer.
