#### LEGAL NOTICE

Notice is hereby given that Christian H. Buhl Legacy Trust [hereinafter referred to as the "Legacy Trust"], formerly known as Sharon Regional Health System, has filed a Petition for Approval of Plan for Future Operations, Including Transfer of Assets Committed to Charitable Purposes at No. 2014-58 in the Orphans' Court Division of the Court of Common Pleas of Mercer County.

The Petition seeks the following from the Orphans' Court:

(1) approval of the Legacy Trust's plan for future operations as it continues to progress toward the conclusion of its winding-up process, which includes transfer to the Buhl Regional Health Foundation [hereinafter referred to as the "Foundation"] of all the Legacy Trust's cash and investments except its workers' compensation trust funds and a cash reserve sufficient to discharge its remaining liabilities, and a restructuring of the Foundation's supporting organization status through amendment of the Foundation's Articles of Incorporation and Bylaws;

(2) modification of the Asset Purchase Agreement, to which the Legacy Trust and Steward Sharon Regional Health System, Inc. [hereinafter referred to as "Steward"] are parties, to grant Steward an extension to October 1, 2022 to meet its capital expenditure commitment;

(3) a declaration that the noncompetition covenants set forth in Section 9 of the Asset Purchase Agreement are not applicable to the Foundation; and

(4) amendment of the Legacy Trust's Bylaws to reduce its minimum number of Directors to 1.

The Petition can be examined in the office of MaryJo Basilone DePreta, Clerk of Courts and Register of Wills, in the Mercer County Courthouse, Mercer, Pennsylvania. A hearing on the Petition is scheduled for

December 6, 2021 at 1:30 p.m. in Court Room No. 1 of the Mercer County Courthouse in Mercer, Pennsylvania.

The Office of Attorney General of the Commonwealth of Pennsylvania, as parens patriae, is reviewing this transaction to ensure that the public interest in the charitable assets of the Legacy Trust is fully protected.
