

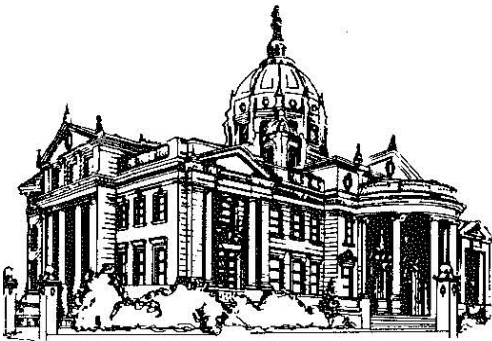

## Obiter Dictum

From the *ABA Journal Daily Newsletter*: [1] The Pennsylvania Supreme Court has criticized Cynthia Baldwin, a former justice, after she said that an affidavit, alleging comments made by the Chief Justice, if true, shows “bias and vindictiveness” in the discipline case against her. According to the Court, Baldwin’s reprimand “was based not on favoritism or bias but solely on her professional and ethical failings.” Baldwin was reprimanded in July for conflicts of interest when she was general counsel for Penn State University and represented school officials before a grand jury.; [2] A backup driver for an Uber self-driving test vehicle has been charged with negligent homicide for a crash which killed a homeless woman. Police said that the driver’s cell phone was streaming a TV show at the time of the crash.; [3] In a recently filed lawsuit, two women learned from their children’s home DNA tests that their fertility doctors fraudulently used their own sperm to impregnate them. The doctors allegedly told the women that they would receive sperm from healthy, anonymous donors. One of the women says her child is a carrier for Tay Sachs disease because the doctor used his own sperm.; [4] A U.S. District Judge from South Dakota has approved a \$440,000 settlement in a lawsuit alleging that forced catheterizations violated the Fourth Amendment. The plaintiffs were catheterized after police obtained search warrants to detect the presence of drugs.; [5] A U.S. District Judge from New York was so incensed by government conduct in the prosecution of an Iranian businessman that she ordered every federal prosecutor in Manhattan to read her decision criticizing the prosecution failures. In the opinion, the judge noted that the federal prosecutors made “countless belated disclosures” of arguably exculpatory evidence and when pressed for information, made a misrepresentation to the court.; [6] According to the National Registry of Exonerations, police and prosecutor misconduct that distorted evidence or undercut innocence contributed to 54% of false convictions that later resulted in exonerations. The misconduct included witness tampering, violence, lying and coercive conduct in interrogations, fabricated evidence, including planted drugs and forensic fraud, concealment of exculpatory evidence and misconduct at trial including perjury by police and lying to prosecutors.; **Other News:** The PA Supreme Court is seeking to fill vacancies on the Criminal Procedural Rules Committee, Orphans’ Court Procedural Rules Committee and the Continuing Legal Education Board. The deadline for applying is October 31, 2020. For more information contact the Administrative Office of Pennsylvania Courts.

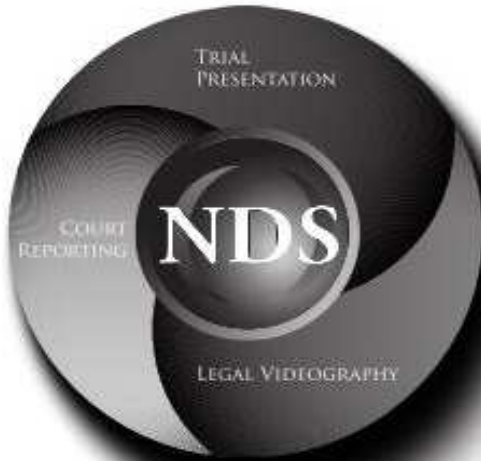
