DISTRICT ATTORNEY'S OFFICE — PRESS RELEASE

TACTICAL COMMUNICATIONS TRAINING HELD IN WAYNE COUNTY

May 5, 2021 — Wayne County District Attorney A.G. Howell announced today that the Wayne County District Attorney's Office hosted a training course entitled "Tactical Communications: The Art of De-Escalation". Close to 40 students attended the course, including state, county and local police officers, adult and juvenile probation officers and police dispatchers.

Officers are frequently tasked with dealing with a variety of differing personalities when encountering the public. Some of these encounters can be characterized as negative in nature. Most violent encounters begin with a breakdown in the communication process between the law enforcement or treatment professional and the individual they have encountered. Many times, these incidents begin with non-verbal cues indicating an attack is about to occur. What is said and done during these critical moments can many times determine whether the outcome is a positive one or the situation erodes into a physical encounter.

The course delved into the communication model, taking a detailed look at what communication is while examining each step in the process. Students looked at verbal skills, non-verbal behaviors, and effective intervention techniques that are instrumental in defusing conflict situations. In addition, the course helped students to identify and discuss pre-attack indicators that will enable them to recognize when a conflict is about to escalate into a use of force situation. This will allow the students to acquire necessary information from individuals while ending the encounter on a positive note, thereby minimizing potential dangerous situations.

District Attorney Howell stated, "Effective policing begins with effective communication, both verbal and non-verbal. This course provided a both a refresher and update to students for their training of their communication skills during stressful and intense situations"

He was also ordered to pay the cost of prosecution, pay restitution in the amount of \$16,255.00, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, and undergo a mental health evaluation and comply with any recommendations for treatment. The incident occurred on September 1, 2017 in Honesdale Borough.

GERMAIN RIVER CLARK, age 42 of Damascus Pa, was sentenced to 6 months probation with 5 days House Arrest through the SCRAM program for one count of Driving Under the Influence of Alcohol (M). He was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$300.00, participate and cooperate with drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and complete 25 hours of community service. The incident occurred on November 1, 2020 in Damascus Township.

JASON PAUL McGOVERN, age 27 of Forest City Pa, was placed on the Accelerated Rehabilitative Disposition Program for a period 6 months related to Unsworn Falsification to Authorities. He was also ordered to pay all costs, and perform 20 hours of community service. The incident occurred on May 31, 2020 in Preston Township.

LAWRENCE JOHN SWAIM JR., age 23 of Warminster Pa, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to Boating Under the Influence. He was also ordered to pay all costs, perform 20 hours of community service, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, complete the Boaters Safety Course, and have his watercraft operating privileges suspended for 6 months. The incident occurred on August 16, 2020 in Paupack Township.

NICHOLAS MICHAEL CLOSE, age 32 of Hawley Pa, was issued a bench warrant for failure to appear for criminal proceeding.

BRANDON KNECHT, age 34 of Lake Ariel Pa, was issued a Bench Warrant for failure to appear for criminal proceedings.
