SUMMARY JUDGMENT—TORTS—PREMISES LIABILITY—ACTUAL AND CONSTRUCTIVE NOTICE—PRIMA FACIE CASE—BURDEN OF PRODUCTION—NANTY-GLO RULE

- [1] Summary judgment is appropriate where no genuine issue exists as to any material fact; it is also appropriate where, after discovery closes, the non-moving party has failed to produce evidence of essential facts if that party bears the burden of proof.
- [2] In negligence cases, the plaintiff bears the burden of proving, *inter alia*, breach of a duty, a fact essential to the plaintiff's case.
- [3] In premises liability cases, a land possessor must protect public invitees from conditions for which the possessor or its agents are responsible, from unreasonably dangerous conditions of which the possessor has actual knowledge, and from conditions of which the possessor has constructive knowledge.
- [4] Where evidence indicates that an unreasonably dangerous condition is not due to the acts of a land possessor or its agents, a case may not be submitted to the jury absent evidence tending to prove that the possessor had actual or constructive notice.
- [5] Since constructive notice stems from the land possessor's duty to monitor the premises, proving constructive notice requires definitive evidence, rather than mere speculation, as to how long a hazardous condition existed (such that it existed long enough for the possessor to have discovered it in the exercise of reasonable care) or other evidence as to its nature, cause, or origin.
- [6] To permit submission to a jury, a plaintiff harmed by a transitory danger *must* submit evidence as to how long the transitory danger existed because the existence of a transitory danger, in and of itself, is not evidence of a breach of a duty of care owed by a land possessor.
- [7] A plaintiff who, by the close of discovery, has not submitted sufficient evidence to support a factual finding of actual or constructive notice beyond mere speculation, cannot survive a motion for summary judgment.
- [8] Where summary judgment is granted due to the lack of evidence of essential facts by a party bearing the burden of proof, *Nanty-Glo* does not apply.

OPINION AND ORDER

On September 2, 2017, Plaintiff Susan Griffith was shopping at the Walmart in the Trinity Point Shopping Center where she slipped in a tan-colored liquid and fell, injuring her back and right leg. Griffith subsequently sued Walmart for negligence under a premises liability theory. The matter before the Court for disposition is Defendant Walmart's Motion for Summary Judgment. Discovery closed on December 31, 2018. For the reasons set forth below, the Court hereby GRANTS summary judgment.

[1] Summary judgment is appropriate:

- (1) whenever there is no genuine issue of any material fact as to a necessary element of the cause of action or defense which could be established by additional discovery or expert report, or
- (2) if, after the completion of discovery relevant to the motion, including the production of expert reports, an adverse party who will bear the burden of proof at trial has failed to produce evidence of facts essential to the cause of action or defense which in a jury trial would require the issues to be submitted to a jury.

Pa.R.Civ.P. 1035.2. See also Milliken v. Jacono, 60 A.3d 133, 138 (Pa.Super. 2012), aff'd, 103 A.3d 806 (Pa. 2014). In deciding whether to grant summary judgment, this Court "examine[s] the record in the light most favorable to the non-moving party and resolve[s] all doubt as to the presence of a genuine issue of material fact against the moving party." Wilkinsburg Sch. Dist. v. Bd. Prop. Assessment, 797 A.2d 1034, 1035 n.3 (Pa.Commw. 2002). A fact is material "if its resolution could affect the outcome of the case under the governing law." Strine v. Commonwealth, 894 A.2d 733, 738 (Pa. 2006). Subject to the Court's review are all "pleadings, depositions, answers to interrogatories, admissions on file, and affidavits" David Pflumm Paving & Excavating, Inc. v. Found. Servs. Co., 816 A.2d 1164, 1167 (Pa.Super. 2003). "Although the non-moving party must be given the benefit of all reasonable inferences, that party need not be given the benefit of inferences not supported by the record or of mere speculation." Myers v. Penn Traffic Co., 606 A.2d 926, 930 (Pa.Super. 1992).

[2] To establish a defendant's negligence under Pennsylvania law, a plaintiff must prove: "(1) a duty or obligation recognized by law; (2) a breach of that duty; (3) a causal connection between the conduct and the resulting injury; and (4) actual damages. *Toro v. Fitness Int'l LLC.*, 150 A.3d 968, 976–77 (Pa.Super. 2016) (quotations omitted). "The nature of the duty which is owed in any given situation hinges primarily upon the relationship between the parties at the time of the plaintiff's injury." *Id.* at 977 (quotations omitted). Where premises liability is concerned, the duty of care owed by a land possessor depends upon the classification of the entrant. *See, e.g., Wombacher v.*

Greater Johnstown Sch. Dist., 20 A.3d 1240, 1242 (Pa.Commw. 2011). In this case, there is no dispute that the Plaintiff was an invitee. The duty owed to an invitee in this Commonwealth parallels that which is outlined in the Restatement (Second) of Torts:

A possessor of land is subject to liability for physical harm caused to his invitees by a condition on the land if, but only if, he:

- (a) knows or by the exercise of reasonable care would discover the condition, and should realize that it involves an unreasonable risk of harm to such invitees, and
- (b) should expect that they will not discover or realize the danger, or will fail to protect themselves against it, and
- (c) fails to exercise reasonable care to protect them against the danger.

See id. at 1242 (quoting Restatement (Second) of Torts § 343 (Am. Law Inst. 1965)).

[3] [4] Pennsylvania courts have observed that the § 343 duty does not convert stores into "insurer[s]" of customer safety. *Myers*, 606 A.2d at 928 (citation removed). Rather, it requires that stores protect customers from unreasonably dangerous conditions for which the store is responsible or of which the store has actual notice. *See id.* at 929. Additionally, stores have a duty to make "proper efforts . . . to keep clean the passageways so they may be safely traversed[.]" *Martino v. Great Atl. & Pac. Tea Co.*, 213 A.2d 608, 610 (Pa. 1965). *See also Rodriguez v. Kravco Simon Co.*, 111 A.3d 1191, 1195 (Pa.Super. 2015) (stating that the "[d]efendants had a duty to protect [the plaintiff] from dangers of which they knew or would have known upon reasonable monitoring of the premises"). Therefore, constructive notice may be imputed to stores where "the condition existed for such a length of time that in the exercise of reasonable care the owner should have known of it." *Myers*, 606 A.2d at 929 (quotation omitted).

When determining whether constructive notice exists, "one of the most important factors . . . is the time elapsing between the origin of the defect or hazardous condition and the accident." *Neve v. Insalaco's*, 771 A.2d 786, 791 (Pa.Super. 2001) (quotation omitted). Other factors include

the size and physical condition of the premises, the nature of the business conducted thereon, the number of persons using the premises and the frequency of such use, the nature of the defect and its location on the premises, its probable cause and the opportunity which defendant, as a reasonably prudent person, had to remedy it.

Bremer v. W.W. Smith, Inc., 191 A. 395, 397 (Pa.Super. 1937).

[5] [6] Our Supreme Court has held that a hole in a road provided constructive

notice where it was two-feet deep and existed for at least a month. See McKelvey v. Juniata Borough, 108 A. 205, 205, 206 (Pa. 1919). Where, by contrast, a condition is only *transitory* in nature (such as a puddle), evidence must be presented as to "how long" it existed before the injury occurred. See Toro, 150 A.3d at 977. The evidence cannot be merely speculative, see id. ("A plaintiff cannot survive summary judgment when mere speculation would be required for the jury to find in plaintiff's favor" (quotation omitted)), such that jurors are tasked with "reach[ing] conclusions based upon guess or conjecture." *Martino*, 213 A.2d at 610 (noting the dearth of evidence from which the jury could reach a conclusion concerning the origin of an accidentinducing grape). Where evidence is insufficient to establish constructive notice beyond mere speculation, the question of constructive notice may not be submitted to the jury. See Myers, 606 A.2d at 930; Bremer 191 A. at 398. See also Myers, 606 A.2d at 929 (stating, "[w]here . . . the evidence indicates that the [condition] is traceable to persons other than those for whom the owner is . . . accountable, the jury may not consider the owner's ultimate liability in the absence of other evidence which tends to prove that the owner had actual notice of the condition or that the condition existed for such a length of time that in the exercise of reasonable care the owner should have known of it" (quoting Moultrey v. Great A & P Tea Co., 422 A.2d 593, 596 (Pa.Super. 1980))).

[7] Accordingly, our Superior Court has held constructive notice to be absent as a matter of law: where the plaintiff's case consisted of testimony that the liquid he fell in "must have been there for a little while" because it was sticky around the edges as if it were drying, *Rodriguez*, 111 A.3d at 1194; where the plaintiff "admitted . . . he [did] not know how long the substance he slipped on was present on the stairs" and the "nature of the substance [did] not establish that any of [the] defendants' employees spilled the substance or that they should have been aware of its presence[,]" *Porro v. Century III Assocs.*, 846 A.2d 1282, 1286 (Pa.Super. 2004); where the plaintiff argued that the condition (a soapy floor) "*could have* existed" for a long time because the store did not keep accurate records of its inspections and maintenance, *see Toro*, 150 A.3d at 977 (emphasis original); and where "[t]he only evidence submitted . . . was . . . that the hole looked 'as though many cars had passed over it' and its edges were 'sort of smoothed down by the tracks of other machines going over it," *see Bremer*, 191 A. at 397.

Here, Walmart contends that Griffith has presented no evidence to indicate that Walmart or its agents caused the condition, that Walmart had actual notice of the condition, or that the liquid had been on the floor long enough to impute constructive notice to Walmart.²

In turn, Griffith contends that how much time is required to impute constructive notice is "fact specific . . . and should be left to a jury." Griffith contends that Walmart had "constructive, if not actual notice" of the condition, 4 because: (1) the liquid was tan rather than clear (such that it would have been visible and duly noticed had reasonable care been exercised); (2) one employee, who walked past the incident's location prior to its happening, would have cleaned it had he been exercising reasonable care; and (3) "[Walmart] has offered no evidence to show [that] not enough timed [sic]

passed for [Walmart] to be on constructive notice " Griffith also argues that since the aforementioned employee was later terminated for violating Walmart's attendance policy, a material issue of fact exists as to whether that employee "would have followed the policies about cleaning hazards " Griffith also characterizes the parties' disagreement as to the nature of the liquid as a dispute as to a material fact. Finally, Griffith argues that the *Nanty-Glo* rule prevents summary judgment in this case.

The Court determines that Griffith has failed to produce evidence of facts that are essential to her case. See Pa.R.Civ.P. 1035.2(2). Griffith's arguments to the contrary misapprehend the burden of proof in this case. It is not Walmart's burden to prove that an insufficient amount of time elapsed for constructive notice to result. Rather, it is Griffith's burden, as the plaintiff, to submit evidence that would permit a jury to find actual or constructive notice beyond mere "conjecture." See Bremer, 191 A. at 398. See also Toro, 150 A.3d at 977. Absent such evidence, "the jury may not consider [Walmart's] ultimate liability...." See Myers, 606 A.2d at 929 (quotation omitted).

Griffith has failed to present such evidence. Griffith's own deposition testimony betrays an utter lack of information as to the nature or origin of the liquid, how it was deposited on the floor, and how long it existed on the floor prior to Griffith's fall. ¹³ See Neve, 771 A.2d at 791 (stating that the length of time elapsing is "one of the most important factors"). See also Bremer, 191 A. at 397 (observing that other factors include the "nature of the defect and . . . its probable cause"). Additionally, Griffith testified that there were no footprints in the liquid 14 and that the spill appeared to be fresh "because it wasn't dried around the edges . . . [so] it couldn't have been laying there unless it was a substance that takes a very long time to dry." Such evidence is akin to that which was held to be insufficient in Porro (where the plaintiff could not identify the nature of the substance or how long it had been present, see 846 A.2d at 1286). It is a far cry from that which existed in *Rodriguez* (where the plaintiff asserted that the liquid must have been present for a while because it was drying, see 111 A.3d at 1194) and Bremer (where the hole appeared as if it had been there awhile because of its smootheddown appearance, see 191 A. at 397). Even in these latter two cases where plaintiffs testified that the conditions existed for some time and pointed to observations supporting their conclusions, the respective courts regarded such testimony as inadequate to establish constructive notice, absent more definite evidence of how long the condition existed. See Rodriguez, 111 A.3d at 1194 ("Without evidence of how long it takes the liquid in question to become sticky or dry, the jury would be unable to determine whether the spill was present for a sufficiently long time to warrant a finding of constructive notice."); Bremer, 191 A. at 398 ("Time is always an important factor in the problem of constructive notice, and we think the general principles announced in store cases are applicable here. Upon consideration of the record, our conclusion is that this case falls within the line of cases in which the evidence has been held insufficient to justify the submission of the question of constructive notice to the jury.").

So too in this case, there is a fatal lack of facts essential to Griffith's case. It is not a question as to the existence or absence of a materially factual dispute (as the Plain-

tiff suggests¹⁶), but rather the abject lack of evidence supporting Griffith's case (even after Griffith is given the benefit of all reasonable inferences) which is determinative. *See Myers*, 606 A.2d at 930. The existence of a spill in Walmart is not, "in and of itself," evidence of a breach of the duty Walmart owes to its customers. *See id.* at 928. To survive summary judgment, Griffith needed to present sufficient evidence to remove a jury's determination from beyond the realm of "guess [and] conjecture." *See Martino*, 213 A.2d at 610. Griffith failed to submit such evidence, as it remains anyone's guess as to what the offending liquid was, how long it was present, and how it came to be on the floor.

The Court's determination is further bolstered by reviewing the surveillance video. In the hour preceding Griffith's fall, approximately twenty-three Walmart employees transversed the passageway where the accident occurred, eight of whom were equipped with cleaning carts. 17 Based on this video evidence, whether the liquid was deposited on the floor (that portion of the passageway is not visible from the video) five minutes prior to Griffith's fall, ten minutes prior to Griffith's fall, twenty minutes prior to Griffith's fall, or thirty minutes prior to Griffith's fall is purely hypothetical. There would be no way a jury could determine how or when the liquid was deposited and how many, if any, Walmart employees had the opportunity to remedy the condition, but failed to do so. Griffith submits that a genuine issue of material fact exists as to whether one of these employees would have cleaned the spill when he was later terminated for noncompliance with attendance policies.¹⁸ Again, whether the spill occurred before or after this particular employee walked through the area is a matter of pure speculation. See Toro, 150 A.3d at 977 ("A plaintiff cannot survive summary judgment when mere speculation would be required for the jury to find in plaintiff's favor" (quotation omitted)).19

In short, the Plaintiff has proffered no evidence from any Walmart employee or patron to help establish that the liquid remained on the floor long enough to result in constructive notice. The Plaintiff has proffered no evidence from any Walmart employee or patron to help establish that one or more employees had actual notice of and failed to remedy the condition. The Court recognizes that the Plaintiff, who happened into the dangerous condition, would not have had personal knowledge as to how long the condition existed. But in discovery, some such evidence might have been revealed. Discovery is now closed. Based on the record before the Court, to submit this case to a jury, would be to submit it to their imaginations. *See Martino*, 213 A.2d at 610 ("jurors may not be permitted to reach conclusions based upon guess or conjecture"). Thus, even when viewing the record in a light most favorable to Griffith, Griffith has failed to produce enough evidence to allow the case to be heard by a jury.

[8] Even the *Nanty-Glo* rule does not provide refuge for the Plaintiff. "The *Nanty-Glo* rule instructs that the party moving for summary judgment may not rely solely upon its own testimonial affidavits or depositions, or those of its witnesses, to establish the non-existence of genuine issues of material facts." *Ludwig v. McDonald*, 204 A.3d 935, 944 n.8 (Pa.Super. 2019) (quotation omitted). Here, the Court grants

summary judgment because Griffith has failed to produce evidence of facts that are essential to establish constructive or actual notice. See Pa.R.Civ.P. 1035.2(2). Nanty-Glo is "not a consideration" where summary judgment is granted on this basis. Ack v. Carroll Twp. Auth., 661 A.2d 514, 518 (Pa.Commw. 1995). See DeArmitt v. N.Y. Life Ins. Co., 73 A.3d 578, 594–95 (Pa.Super. 2013) (recognizing that Nanty-Glo does not "come [] into play" until after it is determined "whether the plaintiff has alleged facts sufficient to establish a prima facie case). Finally, the Court's decision is based on nontestimonial evidence (e.g., the video footage) and admissions by Griffith, the nonmoving party. See Bank of Am., N.A. v. Gibson, 102 A.3d 462, 466 (Pa.Super. 2014) ("Nanty-Glo prohibits entry of summary judgment based on the moving party's oral testimony. An exception [exists] where the moving party supports the motion by using admissions of the opposing party." (citations and quotations removed)). Thus, Nanty-Glo does not apply.

ORDER OF COURT

AND NOW, this 28th day of August 2019, the Court GRANTS Summary Judgment in favor of Defendant Walmart Stores East, L.P., and Plaintiff Susan Griffith's Complaint is DISMISSED with prejudice.
