#### OPINION AND ORDER

VERNON, J. November 4, 2019

Before the Court are Preliminary Objections filed by Defendants, First Baptist Church of Ronco, PA, Michael Burden, Tiffany Burden, Gloria Peggues, and Robert Burton, to Plaintiffs' Complaint alleging this Court lacks subject matter jurisdiction pursuant to the ministerial exception of the First Amendment of the United States Constitution and that Plaintiffs lack capacity to sue as they are not active and good standing members of the First Baptist Church of Ronco.

According to the Complaint, Plaintiffs are members of the First Baptist Church of Ronco, which they allege is owned and operated by First Baptist Church of Ronco, PA, a Pennsylvania nonprofit corporation. See, Complaint ¶11-12. In 2016, the position of pastor of the Church became vacant. Id. at 18. Pursuant to the Church's bylaws, certain procedures were required to be followed to fill the pastoral position. Id. at ¶19. Plaintiffs allege the procedures were not followed and Defendants and other persons acting in concert with them improperly voted to select Defendant Robert Burton as pastor over Plaintiffs' objections. Id. at ¶20-28. Plaintiffs further allege Defendants did not comply with the Church's bylaws by purportedly electing Defendants Tiffany Burden and Gloria Peggues as trustees and officers of the Church. Id. at ¶31. Plaintiffs also allege Defendants have denied access to the Church building to some Trustees and janitor of the Church. Id. at ¶33.

By letter dated September 22, 2018, Plaintiffs notified the individual defendants and others purportedly acting as officers and trustees of the Church that the action taken to select Defendant Robert Burton as pastor did not conform to the bylaws and requested that that action and the election of any trustees and officers which did not comply with the bylaws be rescinded, and a meeting be scheduled in accordance with the by-

laws to consider the call of a pastor. Id. at  $\P 32$ . Because Defendants have failed to take these steps, Plaintiffs request this Court to grant relief pursuant to the Judicial Supervision of Corporate Action subsections of the Nonprofit Corporation Law of 1988 (15 Pa.C.S.A.  $\S 5791-5793$ ).

Plaintiffs' requested relief includes entering an order to rescind the election of Robert Burton as pastor; to order a meeting of the members of the Church properly scheduled and held to appoint a pulpit committee in accordance with the bylaws; order the selection of any trustees or officers after March 1, 2018 be rescinded, appoint judges of election to select a pulpit committee, pastor, and officers and trustees of the Church; order an accounting of funds; order minutes from meetings; and order that trustees and the janitor be provided a key to the Church building.

In ruling on preliminary objections, the Court must accept as true all well-pleaded, material and relevant facts. Mellon Bank v. Fabinyi, 650 A.2d 895, 899 (Pa. Super. 1994). "[C]onclusions of law, unwarranted inferences from the facts, argumentative allegations or expressions of opinion" need not be accepted as true. Myers v. Ridge, 712 A.2d 791, 794 (Pa. Commw. 1998).

Preliminary objections in the nature of a demurrer should be granted where the contested pleading is legally insufficient. Cardenas v. Schober, 783 A.2d 317, 321 (Pa. Super.2001) (citing Pa.R.C.P. 1028(a)(4)). "Preliminary objections in the nature of a demurrer require the court to resolve the issues solely on the basis of the pleadings; no testimony or other evidence outside of the complaint may be considered to dispose of the legal issues presented by the demurrer." Hess v. Fox Rothschild, LLP, 925 A.2d 798, 805 (Pa. Super. 2007). All material facts set forth in the pleading and all inferences reasonably deducible therefrom must be admitted as true. Id.

The first preliminary objection of Defendants questions this Court's subject matter jurisdiction in accordance with the "ministerial exception" which exempts from certain employment laws the employment relationship between religious institutions and their ministers so as to ensure that no branch of secular government trespasses on the most spiritually intimate grounds of a religious community's existence, and precludes any inquiry into the substantive reason to employ a minister. Plaintiffs counter that the ministerial exception does not apply as the Church is a nonprofit corporation who is subject to this Court regarding its corporate action, including in the conduct of its meetings and its adherence to its own bylaws. Plaintiffs maintain that they are not alleging employment laws were violated, but rather, the procedural requirements for holding a meeting of members of the church to extend an offer to a pastor and for selecting officers, trustees, and other church leaders specified in its bylaws were not met.

The deference rule provides that civil courts are bound to accept the decisions of the highest judicatories of a religious organization of hierarchical policy on matters of discipline, faith, internal organization, or ecclesiastical rule, custom, or law. Serbian Eastern Orthodox Diocese v. Milivojevich, 426 U.S. 696 (1976). This deference rule is not all inclusive, however, as the Pennsylvania Supreme Court has recognized:

All disputes among members of a congregation, however, are not doctrinal disputes. Some are simply disputes as to meaning of agreements on wills, trusts,

contracts and property ownership. These disputes are questions of civil law and are not predicated on any religious doctrine.

Presbytery of Beaver-Butler of the United Presbyterian Church in the United States of America v. Middlesex Presbyterian Church, 489 A.2d 1317, 1320-21 (Pa. 1985).

Though, civil courts may resolve disputes involving churches that do not require a determination of ecclesiastical issues. Poesnecker v. Ricchio, 631 A.2d 1097 (Pa. Cmwlth. 1993). Where a case presents questions that require "no doctrinal exogenesis," civil courts retain jurisdiction and should apply "neutral principles of law" to resolve intra-church disputes. Presbytery, supra., at 1321-22. We may apply principles of law which are religiously neutral, such as statutes governing Pennsylvania nonprofit corporations.

Rooted in the First Amendment's guarantee of religious freedom, the ministerial exception precludes courts from considering claims involving the employment relationship between a religious institution and its ministerial employees, based on the institution's constitutional right to be free from judicial interference in the selection of those employees. Hollins v. Methodist Healthcare, Inc., 474 F.3d 223, 225 (6th Cir.2007). Under the "ministerial exception," the Free Exercise Clause of the First Amendment of the United States Constitution prohibits courts from exercising subject matter jurisdiction in cases where the court's involvement would encroach on decisions made by religious institutions concerning employment of ministers.

To determine whether the First Baptist Church of Ronco, PA complied with its by-laws in its election of a pastor, trustees, and officers would not require this Court to delve into any ecclesiastical matters whatsoever in order to decide this dispute. All disputes among members of a congregation are not doctrinal disputes; deference is not mandated simply because there exists a judicature in the church. Resolution of this Church's bylaw compliance does not require "resolution of any competing doctrinal issues." Accepting as true Plaintiffs' allegations that Defendants failed to conform with the Church's bylaws in the election of Defendant Robert Burton, this Court's examination of the adherence to these bylaws may lead to the same end result – the election of Defendant Robert Burton as pastor of the First Baptist Church of Ronco, PA. Judicial inspection of those persons who purport to exercise corporate office are clearly within the purview of this Court. As such, the first preliminary objection is overruled.

Defendants also lodge objection to Plaintiffs capacity to sue alleging Plaintiffs do not have standing as they were not active and good standing members of the Church at the time of the actions in question. Defendants maintain that Church doctrine was established in 2008 that required only active members in good standing could vote on Church matters. At the preliminary objection stage, this Court is bound to accept as true the factual averment of Plaintiffs Complaint that all Plaintiffs are members of the Church. See, Complaint ¶12. Accordingly, the second preliminary objection is also overruled.

WHEREFORE, we will enter the following Order.

#### ORDER

AND NOW, this 4th day November, 2019, upon consideration of the Preliminary Objections of Defendants, First Baptist Church of Ronco, PA, Michael Burden, Tiffany Burden, Gloria Peggues, and Robert Burton, to Plaintiffs' Complaint alleging this Court lacks subject matter jurisdiction and that Plaintiffs lack capacity to sue, it is hereby OR-DERED and DECREED that the Preliminary Objections are OVERRULED in accordance with the foregoing Opinion.
