SUMMARY OF OPINION:

The defendant-store owners in this slip-and-fall case filed a motion for summary judgment on the grounds that the plaintiff could not establish the presence of any substance on or a condition of the store floor that allegedly caused the decedent to fall, nor did the record reflect any direct or circumstantial proof of any owner's actual or constructive notice of such an allegedly dangerous condition. As part of the plaintiff's burden of proof in this action, the plaintiff had to show that the decedent fell due to a dangerous condition existing on the property, that the owner(s) had actual or constructive notice of that condition, and that the owner(s) failed to exercise reasonable care to protect the decedent against the danger. Even when the record was examined in the light most favorable to the plaintiff, it did not contain admissible evidence of a liquid, substance, or other dangerous condition on the store floor that conceivably caused the decedent's fall. The record similarly lacked any evidence of an owner's actual or constructive notice of such a condition. Thus, since plaintiff failed to adduce sufficient evidence on an essential issue upon which plaintiff bore the burden of proof, the owners were entitled to summary judgment in their favor.

SUMMARY OF OPINION:

An invitee, who allegedly slipped, fell, and was injured as a result of the landowners' "high gloss treatment" on their hardwood stairs, filed a tort action asserting the negligent creation and maintenance of "a hazardous condition" and the failure "to provide adequate lighting for the slippery stairs" and "to warn all invitees of the hazardous condition of the stairs." The invitee further averred that one owner stated after the fall that "[w]e usually tell people these stairs are slippery." Despite those averments, the owners filed a demurrer to the legal sufficiency of the invitee's negligence claim. Accepting the invitee's allegations as true, and affording her all inferences reasonably deducible from those averments, the complaint stated a cognizable negligence claim for the manner in which the owners applied and maintained the high gloss treatment on their stairs, as evidenced by their alleged knowledge of the need to warn invitees about the "slippery condition" of the steps. Therefore, the preliminary objection in the nature of a demurrer was overruled.
