## Commonwealth vs. Johnson

Impeachment by prior conviction - Preservation of appeal issue - Harmless error

- Rule of Evidence No. 609 states in relevant part: for the purpose of attacking the credibility of any witness, evidence that the witness has been convicted of a crime, must be admitted if it involved dishonesty or false statement, but, if more than 10 years have passed since the later of the witness's conviction or release from confinement for it, evidence of the conviction is admissible only if its probative value substantially outweighs its prejudicial effect. Also, the proponent must give an adverse party reasonable written notice of the intent to use it so that the party has a fair opportunity to contest its use.
- 2. In order to preserve issues for appeal, objections to the error or offense must be made in a timely fashion.
- 3. If an objection is not timely made on the record, it is considered waived, even if it has been raised in a post-sentence motion.
- 4. Boilerplate allegations, without more, cannot a successful basis on appeal.
- 5. An appellate court has the ability to affirm a valid judgment or verdict for any reason appearing as of record.
- 6. The doctrine of harmless error is a technique of appellate review designed to advance judicial economy by obviating the necessity for a retrial where the appellate court is convinced that a trial error was harmless beyond a reasonable doubt. Its purpose is premised on the well-settled proposition that a defendant is entitled to a fair trial, but not a perfect one.
- 7. An appellate court may affirm a judgment based on harmless error even if such an argument is not raised by the parties.
- 8. An error may be harmless where the properly admitted evidence of guilt is so overwhelming and the prejudicial effect of the error is so insignificant by comparison that it is clear beyond a reasonable doubt that the error could not have contributed to the verdict.
- 9. Defendant was convicted of Unlawful Contact With Minor, Sexual Assault, Corruption of Minors, and Indecent Assault. Defendant appealed, arguing the trial court erred in denying the defense Motion to Preclude Use of Defendant's Conviction. Because Defendant testified at trial and the prosecutor did not impeach Defendant with the conviction, there is not a cognizable issue to appeal. Because the Court deemed its ruling to allow the use of Defendant's ten and one-half year old robbery conviction as correct; the conviction was not brought to the jury's attention; the Defendant suffered no prejudice; any potential error was harmless and this issue was not properly preserved for appeal, this Court respectfully requested that its decisions be affirmed.

#### **OPINION**

**AND NOW**, this 16th day of April, 2019, this Opinion is filed pursuant to Pa. R.A.P. 1925 and in response to Dion Maurice Johnson's ("Defendant") timely Concise Statement of Errors Complained of on Appeal ("Statement"), filed with the Court on March 15, 2019.

## PROCEDURAL AND FACTUAL HISTORY

On October 18, 2018, following a four (4) day jury trial, Defendant was convicted of one count Unlawful Contact With Minor (18 Pa.C.S.A. § 6318(a) (1)),<sup>1</sup> one (1) count Sexual Assault (18 Pa.C.S.A. § 3124.1), one (1) count of Corruption of Minors (18 Pa.C.S.A. § 6301(a)(1)(i)), and one (1) count of Indecent Assault (18 Pa.C.S.A. § 3126(a)(1)). The jury acquitted Defendant on the offense of Rape-Unconscious Victim (18 Pa.C.S.A. § 3121(a)(3)). See Verdict Sheet, 10/18/18.

Sentencing was deferred in this matter to obtain a pre-sentence investigation ("PSI") report and to conduct a Court-ordered evaluation by the Sexual Offender Assessment Board ("SOAB") to determine whether Defendant met the statutory criteria to be classified as a sexually violent predator ("SVP") pursuant to 42 Pa.C.S.A. § 9799.24.<sup>2</sup>

On January 17, 2019, Defendant was sentenced to an aggregate term of imprisonment of not less than twelve and a half  $(12 \frac{1}{2})$  and not more than

twenty-five (25) years in a state correctional institution.<sup>3</sup> Defendant was classified as a Tier 3 sexual offender under SORNA and was ordered to comply with all of the applicable SORNA requirements. Defendant received the applicable credit for time served. Defendant was represented at trial, the SVP proceedings and sentencing by Nellie Verduci, Esquire.

On February 14, 2019, Maria Heller, Esquire<sup>4</sup> filed a timely Notice of Appeal, in response to which, this Court ordered Defendant to file and serve upon the undersigned a Statement. See Order, 2/22/19. On March 15, 2019, Defendant filed a timely, counseled, Statement.

The underlying facts giving rise to Defendant's convictions are as follows: the charges in Term number CR-3666-2017 arise out of an incident which occurred over a period of several hours on June 28th and 29th of 2017. The incident occurred inside Defendant's apartment in Parkesburg Borough, Chester County, Pennsylvania. The victim in this case is a sixteen (16) year old girl who encountered Defendant at his residence when she was walking home from her friend's house. Upon making contact with Defendant outside of his residence, the victim agreed to accompany Defendant into his apartment to use and/or procure narcotics. Prior to this encounter, Defendant and the victim were complete strangers.

Once inside the apartment, the victim and Defendant smoked narcotics and drank alcohol together. When the victim attempted to leave the apartment and go home, Defendant demanded "payment" for the narcotics. The victim testified that she "blacked out" at this point and when she awoke, she was naked and Defendant was on top of her, penetrating her vaginally without her consent. The victim managed to grab her pocketknife and stabbed Defendant multiple times to finally end the assault.

See N.T., 10/16/18, pp 28-82; N.T., 1/17/19, pp. 10-17.

We write further to note that the crimes of Sexual Assault and Indecent Assault, based on the testimony presented at trial, merged for sentencing. However, the crimes of Sexual Assault, Unlawful Contact with a Minor and Corruption of Minors did not merge for sentencing.

<sup>&</sup>lt;sup>3</sup> Defendant has a 2004 conviction for the crime of Robbery from the Commonwealth of Virginia, under Virginia Code Section 18.2-58, for which he received a sentence of 20 years' incarceration with 16.5 of those years suspended. This Robbery conviction, a strike offense, for a crime of violence subjects Defendant to the mandatory sentencing provisions of 42 Pa.C.S.A. § 9714 for second and subsequent strike offenses. As such, the mandatory minimum and statutory maximum penalty for the conviction of Sexual Assault is 10 to 20 years of incarceration in a state correctional institution.

## DISCUSSION

In his concise statement, Defendant raises one (1) issue on appeal. In Defendant's own words, the sole issue presented on appeal is as follows:

The trial court erred in denying the defense Motion to Preclude Use of Defendant's Conviction or Release Under PA Rules of Evidence 609(b) and the same motion made verbally at trial on October 17, 2018. This issue is discussed at N.T., 10/17/18, pp. 319-329.

See Concise Statement, 3/15/19, unpaginated.

As we will explain, Defendant's argument is misplaced and can form no successful basis for appeal. Impeachment by evidence of a criminal conviction is governed by Rule of Evidence No. 609. Pa.R.E. states in relevant part:

## Rule 609. Impeachment by Evidence of a Criminal Conviction

(a) In General. For the purpose of attacking the credibility of any witness, evidence that the witness has been convicted of a crime, whether by verdict or by plea of guilty or nolo contendere, must be admitted if it involved dishonesty or false statement.

(b) Limit on Using the Evidence After 10 Years. This subdivision (b) applies if more than 10 years have passed since the witness's conviction or release from confinement for it, whichever is later. Evidence of the conviction is admissible only if:

(1) its probative value substantially outweighs its prejudicial effect; and

(2) the proponent gives an adverse party reasonable written notice of the intent to use it so that the party has a fair opportunity to contest its use.

Pa.R.E. 609.

Before reviewing Defendant's claim on the merits, we note that this issue was not properly preserved for appeal. In order to preserve issues for appeal, objections to the error or offense must be made in a timely fashion. <u>Commonwealth v.</u> <u>Baumhammers</u>, 960 A.2d 59 (Pa. 2008), <u>cert. denied</u>, <u>Baumhammers v. Pennsylvania</u>, 130 S.Ct. 104 (U.S. Pa. 2009). If an objection is not timely made on the record, it is considered waived, even if it has been raised in a post-sentence motion. <u>Id</u>. Here, Defendant fails to indicate where in the trial Defendant was impeached with the Virginia robbery conviction or how it prevented him from testifying or where in the record defense counsel objected to the prosecutor impeaching Defendant with the evidence at trial testimony. Because Defendant testified at trial and the prosecutor did not impeach Defendant with the conviction, then there is not a

cognizable issue to appeal. <u>See</u> Pa. R.A.P. 302(a) (stating that only issues that are properly raised and preserved in the trial court may be considered on appeal).

Alternatively, if the Superior Court determines the filing of Defendant's motion *in limine* coupled with the oral motion at trial properly preserved this issue; it would still lack arguable merit. In reviewing this claim, we are mindful that Defendant fails to articulate how the Court's ruling resulted in actual prejudice at trial. Boilerplate allegations without more can from no successful basis on appeal.

In fact, Defendant's claimed error is clearly belied by the record. Furthermore, the record establishes that Defendant's perceived error is clearly harmless in light of the fact that he testified at trial and was not impeached with the robbery conviction at issue. It is well settled that "an appellate court has the ability to affirm a valid judgment or verdict for any reason appearing as of record." <u>Commonwealth v. Parker</u>, 919 A.2d 943, 948 (Pa. 2007) (citing <u>Commonwealth v. Katze</u>, 658 A.2d 345 (Pa. 1995).

> The doctrine of harmless error is a technique of appellate review designed to advance judicial economy by obviating the necessity for a retrial where the appellate court is convinced that a trial error was harmless beyond a reasonable doubt. Its purpose is premised on the well-settled proposition that "[a] defendant is entitled to a fair trial but not a perfect one.

<u>Commonwealth v. Thornton</u>, 431 A.2d 248, 251 (Pa. 1981). The Superior Court may affirm a judgment based on harmless error even if such an argument is not raised by the parties. <u>Commonwealth v. Allshouse</u>, 36 A.3d 163, 182 (Pa. 2012). Stated differently, the Pennsylvania Supreme Court has stated that an error may be harmless where the properly admitted evidence of guilt is so overwhelming and the prejudicial effect of the error is so insignificant by comparison that it is clear beyond a reasonable doubt that the error could not have contributed to the verdict. <u>Commonwealth v. Story</u>, 383 A.2d 155, 166 (Pa. 1978) (internal citations omitted).

Here, logic dictates that because neither the prosecutor nor defense attorney introduced evidence of Defendant's prior robbery conviction to the jury, the Court's ruling concerning the admissibility of the evidence could not have prejudiced Defendant. Moreover, the claimed error is harmless in light of the overwhelming evidence presented against Defendant at trial. Accordingly, it is a waste of valuable public resources for defense counsel to now raise this frivolous, self-serving, argument on appeal.

Finally, the trial court's ruling in permitting the Commonwealth to use the prior 10.5 year old robbery conviction to impeach Defendant was correct. See N.T., 10/17/18, pp. 319-329.

For the reasons set forth above, it is respectfully requested that the decisions of this Court be affirmed.
