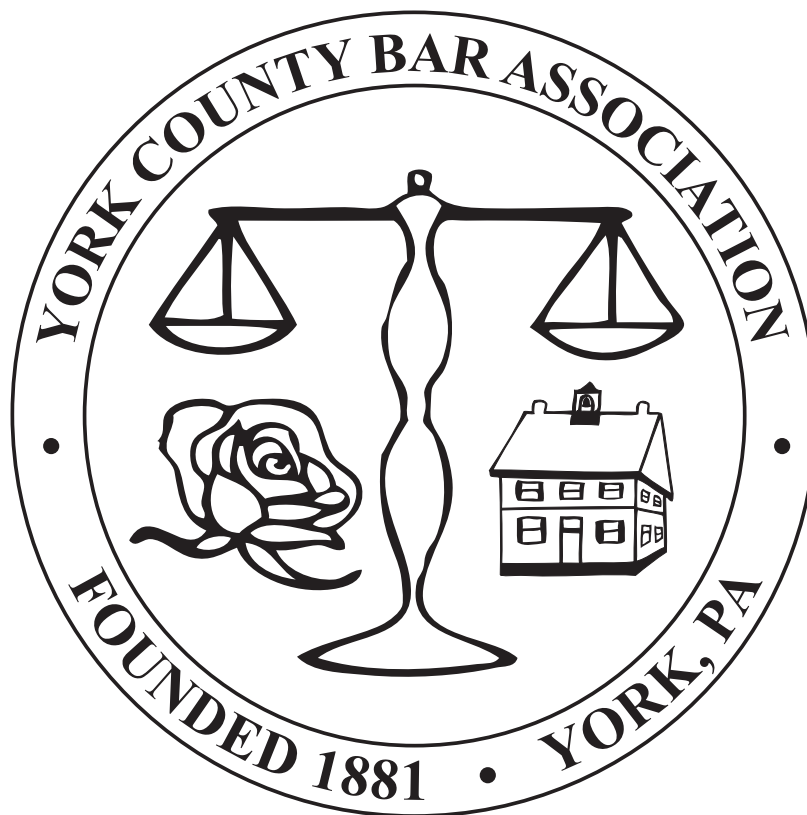

Summary Judgment – Action in Ejectment

1. BP Real Estate Investment Group, LP filed a Motion for Summary Judgment in response to Defendant's Answer to Complaint in Ejectment.
2. In his answer, Defendant either admits or provides a general denial of all averments.
3. In an ejectment action, a party must set forth the abstract of title upon which he relies in order to recover possession, unless superior title is shown by the adverse party.
4. In the instant matter, Plaintiff has provided documentary proof of their title to the property and their right to immediate possession.
5. Defendant's sole viable defense—that of superior title or right to the property at issue—is not raised in any substantial form. There is clearly no genuine issue of material fact in this case as it pertains to the claim for ejectment.
6. Plaintiff's Motion for Summary Judgment as to the claim for Ejectment was granted.

OPINION

Presently before the Court is a Motion for Summary Judgment filed by BP Real Estate Investment Group, LP (hereinafter "Plaintiff") in response to Defendant's Answer to Complaint in Ejectment filed by Thomas James Edward Soul, a/k/a Thomas Soul or Thomas J.E. Soul (hereinafter "Defendant").

For the following reasons, Plaintiff's Motion is **GRANTED** as to the claim for ejectment.

BACKGROUND

This action involves property located at 92B Cemetery Avenue, Stewartstown, York County, Pennsylvania. A Complaint in Ejectment was filed by Plaintiff on January 14, 2020, seeking ejectment of Defendant from the premises and raising a claim of unjust enrichment. Plaintiff seeks to recover possession of premises purchased by Plaintiff at Sheriff's Sale as evidenced by a deed filed on September 16, 2019.

Defendant's Answer was filed on April 6, 2020. Plaintiff then filed a Motion for Partial Summary Judgment on April 27, 2020 together with a Brief in support solely on the issue of ejectment. Defendant has not filed a response. On June 8, 2020, a Praecipe to List for One-Judge Disposition was filed and the matter was assigned to the undersigned on June 9, 2020. The matter is now ripe for decision.

DISCUSSION

After the relevant pleadings are closed, but within such time as not to unreasonably delay the trial, any party may move for judgment on the pleadings. Pa.R.C.P. 1034(a). In considering motion for judgment on the pleadings, all properly pled averments of fact and every reasonable inference that the court can draw therefrom, must be taken as true, or as admitted, unless their falsity is apparent from the record. *Pocono Summit Realty, LLC v. Ahmad Amer, LLC*, 52 A.3d 261 (Pa.Super. 2012). Averments of fact which are material and relevant are accepted as true, even though denied, in considering a motion for judgment on the pleadings. *Id.*

In conducting its inquiry on a motion for judgment on the pleadings, a court should confine itself to the pleadings themselves and any documents or exhibits properly attached to them, and it may not consider inadmissible evidence. *Integrated Project Services v. HMS Interiors, Inc.*, 931 A.2d 724 (Pa.Super. 2007). A motion for judgment on the pleadings is similar to a demurrer in that it may be entered when there are no disputed issues of material fact and the moving party is entitled to judgment as a matter of law. *Miller v. Nelson*, 768 A.2d 858, 860 (Pa. Super. 2001) (citing *Citicorp North American, Inc. v. Thornton*, 707 A.2d 536, 538 (Pa. Super. 1998) (citations omitted)).¹

"[T]o support an action in ejectment, the evidence must be sufficient to identify the land in dispute and establish the plaintiff's right to possession thereof." *Hallman v. Turns*, 482 A.2d 1284, 1288 (Pa. Super. 1984). "The crux of an ejectment action, therefore, rests with the plaintiffs' ability to identify, by a preponderance of the evidence, the boundaries of a parcel of land to which they are out of possession but for which they maintain paramount title." *Doman v. Brogan*, 592 A.2d 104, 108 (Pa.Super. 1991)(citations omitted). Once the plaintiff establishes a prima facie case, the Defendant must offer proof of his title to defeat a plaintiff's ownership. *Id.* Pennsylvania Rule of Civil Procedure 1054(b) provides that in an ejectment action, a party must set forth the abstract of title upon which he relies in order to recover possession, unless superior title is shown by the adverse party.

In the instant matter, Plaintiff has provided documentary proof of their title to the property and their right to immediate possession. Attached to its Complaint is a Sheriff's Deed conveying located at 92B Cemetery Avenue, Stewartstown, York County, Pennsylvania to Plaintiff for the sum of \$54,781.00 paid together with a certification of recording from the York County Recorder of Deeds, which indicates the Sheriff's Deed was recorded on September 16, 2019. *Complaint, Exhibit A.* A purchaser of real estate at a Sheriff's sale acquires title to the property, and upon the Sheriff's Deed becoming acknowledged and recorded, the purchaser has a right to immediate possession. *Wells Fargo Bank, N.A. v. Long*, 934 A.2d 76 (Pa.Super. 2007).

In order to refute Plaintiff's right to possession, Defendants must show superior title or right to the property. Pa. R.C.P. 1054(b). However, Defendant's Answer consists of either admissions or general denials. Though Defendant denies that he has willfully remained in possession, he does not deny the allegation that he remains in the house. Instead, he alleges that his circumstances render him unable to obtain alternative housing. Plaintiff is the "record owner" of the property, the law is clear that a purchaser at Sheriff's sale becomes the record owner once the Sheriff's deed is recorded. *Id.* The Sheriff's Deed was recorded on September 16, 2019 and on that date Plaintiff did, in fact, become the record owner of the property.

Plaintiff only seeks partial judgment on pleadings for the ejectment claim, reserving the issue of unjust enrichment for trial. In response, Defendant either admits or provides a general denial of all averments. Defendant's sole viable defense—that of superior title or right to the property at issue—is not raised in any substantial form. There is clearly no genuine issue of material fact in this case as it pertains to the claim for ejectment.

CONCLUSION

Plaintiff has shown through its deed, recorded in York County, Pennsylvania, to be the owner of the property and to be entitled to exclusive and immediate possession of said property. Defendant has not provided evidence to the contrary. Plaintiff has met its burden to support partial judgment on pleadings as, viewing the record in a light most favorable to Defendant, there is no genuine issue of material fact regarding the complaint in ejectment.

For the foregoing reasons, the Court will **GRANT** partial judgment on pleadings as to the claim for ejectment. The issue of unjust enrichment will be remanded for further proceedings. The appropriate Order follows.

DEP Finalizes New CAFO General Permit

The Pennsylvania Department of Environmental Protection has announced the availability of its new General Permit for Operation of Concentrated Animal Feeding Operations (PAG-12).

The PAG-12 General Permit is intended to provide coverage under the National Pollutant Discharge Elimination System to those operating Concentrated Animal Feeding Operations (CAFOs) where those operations meet the eligibility requirements of the PAG-12 permit, according to a recent DEP posting in the Pennsylvania Bulletin at 50 Pa.B. 6060, published on Saturday, October 31, 2020.

The amended PAG-12 permit includes changes intended to correct errors and reduce administrative burdens, including some that became effective in April 2018.

According to the DEP post, the changes include:

- Coverage expiration date. All coverage under the amended general permit expires on the same date. CAFOs are expected to submit a timely notice of intent (NOI) for continuation of coverage under a reissued general permit prior to expiration of their existing coverage. The DEP will provide information on what will be expected of CAFOs for future permit coverage at a later date.
- Annual report serving as NOI: CAFO annual reports are no longer considered notice of intent for continuation of coverage, but the completed reports still must be submitted in a timely fashion each year as of January 1, 2021.
- Removal of automatic expiration of coverage language: The amended general permit states that failure to submit the CAFO annual report and the annual NOI installment fee payment may result in enforcement action or revocation of coverage, and the DEP will determine the enforcement action. Previous language said without those timely submissions, coverage would be expired.
- Daily water line inspections: The permit now has specific requirements for daily water line inspections for certain operations that inadvertently hadn't been included previously. The previous permit only mentioned operations with a certain amount of cattle or cows, but now includes all large CAFO operations except ones with certain animals.
