At its regular meeting of February 22, 2024, the Board of Supervisors of Marion Township, Butler County, Pennsylvania passed a Resolution signifying Marion Township's intent to join the Pine-Harrisville Authority pursuant to the provisions of the Municipal Authorities Act of June 19, 2001, P.L. 287, as amended, and requesting the Pine-Harrisville Authority to consent to said Joinder and authorizing the filing of an Application with the Secretary of the Commonwealth of Pennsylvania allowing Marion Township to become a member of the Pine-Harrisville Authority and authorizing the proper officers of Marion Township to execute any and all necessary documents to effectuate the same.

Marion Township will file said Application to Join the Pine-Harrisville Authority with the Secretary of the Commonwealth of Pennsylvania on May 14, 2024.
