SUMMARY OF OPINION:

Debtors/Mortgagors filed a breach of fiduciary action against an investment management group for purportedly liquidating their investment management accounts without their authorization, and defendant filed a motion *in limine* involving the proper measure of damages for the intentional or negligent conversion of stocks, bonds, or other like property of fluctuating value. Section 8335 of the Judicial Code limits any such recovery to the difference between the proceeds of the wrongful conversion and the higher value that the property may have reached within a "reasonable time" after the owner received notice of the conversion, and that statute further provides where the relevant facts are not in dispute, the "reasonable time" period "shall be fixed by the court as a matter of law." Appellate precedent in Pennsylvania has definitively established that "reasonable time" under Section 8335 in terms of days or weeks rather than years.

Defendant maintains that the accounts' authorized owner instructed it to gradually liquidate the accounts in early August 2008 due to the turnultuous financial market, whereas the owner denied having issued that directive. It was undisputed that the accounts were liquidated from August 2008 to April 2009, and that although the progressive liquidation of those accounts was reflected on the monthly statements that the owners received, the owners contended that they first became aware of that liquidation in early April 2009. It was also uncontested that on April 20, 2009, the account owners instructed the defendant in writing to apply the liquidation proceeds to the owners' outstanding debt balance, and that the owners later defaulted by failing to pay the net balance by its due date of June 30, 3009.

The "reasonable time" under 42 Pa.C.S. § 8335 reflected the period within which the owners had a fair opportunity to disaffirm the unauthorized sale, to re-enter the market, and to repurchase the stocks or securities that were allegedly converted. Defendants' expert has calculated those damages utilizing a "reasonable time" date ranging between April 20, 2009 (the date of the instruction to apply the proceeds to the outstanding indebtedness) and June 30, 2009 (the date the debt was to be paid in full). The owners' expert intended to use the date of trial (late February 2018) as the comparison date under Section 8335. No court applying Section 8335 has ever fixed the "reasonable time" period as greater than 30 days and the owners' proffered use of a date almost nine years after the owners admittedly received notice of the conversion conflicts with that well-settled law. Therefore, the motion *in limine* to preclude a "reasonable time" date after June 30, 2009, was granted.

SUMMARY OF OPINION:

The parents of a brain-damaged child filed an action against Luzerne County and Lackawanna County health care providers alleging obstetrical, nursing, and institutional negligence. The Luzerne County hospital and Lackawanna County hospital filed preliminary objections asserting improper venue under Pa.R.C.P. 1006(a.1), which provides that a medical professional liability action may be brought "only in a county in which the cause of action arose." The hospitals contended that the allegedly negligent health care services were furnished in Luzerne County, whereas Lackawanna County had merely "tangential" or "peripheral" contact with the torts claims since the resulting injuries merely occurred there.

In addition to asserting the failure to properly interpret fetal heart tracings and to promptly perform a cesarean section delivery in Luzerne County which caused the infant to experience perinatal asphyxia, the parents further alleged that after the newborn was transferred to the Lackawanna County hospital, those medical professionals deviated from the standard of care by neglecting to timely initiate therapeutic hypothermia and to request a pediatric neurology consultation "during a critical window within which the catastrophic consequences of the initial insult would have been avoided or minimized." Since the parents alleged that negligent health care services were furnished in Lackawanna County, the malpractice claim against the Lackawanna County hospital arose in this forum, and in light of the parents' assertion of joint and several liability against the Luzerne and Lackawanna County health care providers, venue was found to be proper in Lackawanna County pursuant to Pa.R.C.P. 1006(c)(2).
