

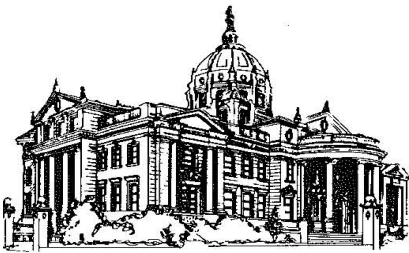

## Obiter Dictum

From the *ABA Journal Daily Newsletter*: [1] The U.S. Supreme Court has ruled that the City of Philadelphia violated the Free Exercise of Religion Clause when it refused to contract with a Catholic foster care agency that refuses to place children with same sex couples. The decision was unanimous, with three justices concurring in the decision rather than joining the opinion authored by Chief Justice Roberts. According to the majority opinion, Chief Justice Roberts noted that Catholic Social Services, “seeks only an accommodation that will allow it to continue serving the children of Philadelphia in a manner consistent with its religious beliefs; it does not seek to impose those beliefs on anyone else.” [2] A Franklin County, Ohio judge is requiring some criminal defendants to get the Covid-19 vaccine as a condition of probation. To date, none of the defendants raised philosophical, medical, or religious objections. A lobbyist with the American Civil Liberties Union, however, has said that the probation condition is problematic. [3] The U.S. Supreme Court confirmed Friday that Justice Breyer has hired a full complement of law clerks in what *Bloomberg* calls “a possible signal that he doesn’t have any immediate plans to retire.” A prior story by *Original Jurisdiction* on the clerk hiring speculated that there is a 70-30 chance that Justice Breyer will remain on the Supreme Court for at least one more term. [4] A federal appeals court recently ruled that the mandatory State Bar in Texas violates lawyers First Amendments rights because of its political and ideological activities. As such, the U.S. Court of Appeals for the Fifth Circuit ruled in favor of three lawyers who filed the challenge, holding that their First Amendment rights were violated because most of the Bar’s legislative lobbying was not relevant to regulation of the legal profession or improving the quality of legal services. The Court further held that plaintiffs cannot be compelled to be members of the State Bar of Texas pending resolution of the law suit’s remedy phase. [5] The Boy Scouts of America has agreed to pay \$850 million to settle sex abuse claims by about 60,000 people. The group says the deal would allow it to emerge from Chapter 11 bankruptcy protection later this year. However, some commentators have raised concerns that lawyers for abuse victims have too much input in crafting this settlement. [6] The “ministerial exception,” which protects religious organizations from discrimination lawsuits brought by employees who qualify as ministers, has been held by the U. S. Court of Appeals for the 7<sup>th</sup> Circuit, to apply to hostile work environment claims.

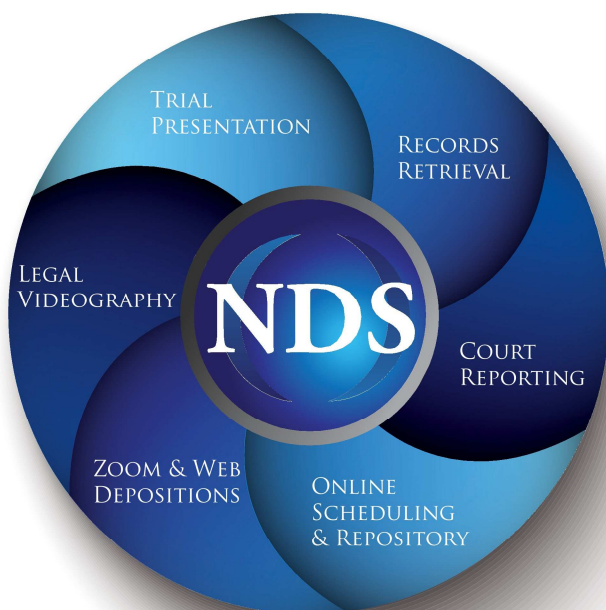
