SUMMARY

Before the Court is Defendant's Motion to Dismiss for Failure of a Speedy Trial. A Hearing was held on November 4, 2021. For the following reasons, Defendant's Motion is denied.

BACKGROUND

A criminal complaint was filed against Defendant, Lamontaz Vales, on May 17, 2020, wherein the Defendant is charged with Aggravated Assault, Possession of a Firearm Prohibited, and Harassment.

On November 30, 2020, Mr. Vales filed an Omnibus Pretrial Motion. Included in that Motion was a Writ of Habeas Corpus arguing that that the Commonwealth failed to establish a prima facie case against Mr. Vales, and a Motion to Suppress. After a hearing on the matter, the Defendant's Omnibus Pretrial Motion was denied on January 28, 2021, by Order of The Honorable Judge Joseph M. George.

On March 16, 2020, the Pennsylvania Supreme Court declared a Judicial Emergency because of the Coronavirus pandemic. The statewide Judicial Emergency was extended multiple times until it ended on June 1, 2020. For the period of time during which it was in force, the Judicial Emergency also suspended Pennsylvania Rule of Criminal Procedure 600, which requires that the Commonwealth bring defendants to trial within a certain period of time-either 180 days for an incarcerated defendant or 365 days for a defendant who is out on bail. See, Pa.R.Crim.P. 600.

As a result of Pennsylvania's Judicial Emergency, criminal jury trials were not held in April or May of 2020.

On June 2, 2020, the Honorable John F. Wagner, Jr., President Judge of the Fayette County Court of Common Pleas, issued an Order declaring that jury trials would not be held for that month because of the pandemic. In July of 2020, the Honorable John F.

Wagner, Jr. again ordered that jury trials would not be held for that month, with only a few delineated exceptions for defendants who were incarcerated and had been quarantined. In August of 2020, the Honorable John F. Wagner, Jr. again ordered that jury trials would not be held for that month, as a result of an outbreak of COVID-19 within the Fayette County Sheriffs Office.

Criminal Jury trials resumed in September and October of 2020, with certain precautions in place to protect jurors, members of the press, court staff, defendants, law enforcement officers, and prosecutors. Among those precautions included social distancing, mandatory mask wearing, and sanitizing surfaces and seats. The precautions also included the use of only three of the six courtrooms in the Fayette County Courthouse-only the largest three courtrooms permitted enough space to provide appropriate social-distancing measures. Fewer jurors were brought in for trials and were staggered throughout the week. Jurys deliberated in the courtrooms after the trials rather than in the confines of the jury rooms, which were not designed with the idea of social distancing in mind.

On October 19, 2021, Defendant filed the Motion to Dismiss that is currently before the Court. The Court held a hearing on November 4, 2021.

DISCUSSION

The issue before this Court is whether the Commonwealth has failed to prosecute this action in violation of Defendant's right to a speedy trial, a right recognized by both the Pennsylvania and United States Constitutions. Counsel for the Defendant specifically argues that the State Supreme Court Order reopened the courts in Pennsylvania on June 1, 2020. However, this does not account for local orders issued by President Judge Wagner that precluded criminal jury trials in Fayette County.

Here, the Criminal Complaint was filed on May 17, 2020.

On March 16, 2020, the Pennsylvania Supreme Court issued a Judicial Emergency because of the Coronavirus pandemic. The statewide Judicial Emergency lasted until June 1, 2020.

As mentioned supra, the President Judge John F. Wagner, Jr. issued orders in June, July, and August of 2020 declaring that there would not be criminal jury trials for those months as a result of the ongoing pandemic, save for a few select trials in July for incarcerated defendants who had been quarantined. These orders effectively meant that the Commonwealth could not call Mr. Vales' case between June 2, 2020 and September 8, 2020, which is when criminal jury trials resumed in Fayette County. This added an additional 98 days to Defendant's Adjusted Run Date.

Criminal jury trials were again suspended in Fayette County in December of 2020 and January of 2021 due to the pandemic.

Further, even though criminal jury trials were held in July, September, October, and November of 2020, there were many precautions set in place for those trials in order to adhere to state and federal public-health recommendations. Those state and federal rec-

ommendations were in turn set in place in order to stop the spread of a deadly, highlycontagious, airborne virus. The precautions also had the effect of limiting the number of criminal jury trials that could be held for those months. Fewer jurors were brought in each month. Only three of the six courtrooms were used. With jurors deliberating in the courtrooms instead of the jury rooms, those courtrooms in turn became unavailable to hold a subsequent trial.

The additional precautions also meant that the trials that were held took longer. Sanitizing surfaces and seats takes time. Masks make it harder to hear, so people have to repeat themselves-both during voir dire and during trial testimony. Social distancing requires that people are seated in specific seats in the courtroom with enough space in between them, which then takes longer to bring jurors in and out of the courtrooms. The longer trials further limited the number of cases the Commonwealth could call during those months.

The limited number of trials taking place from April 2020 until January 2021 was not the result of any delay caused by the Commonwealth, but was the result of an unprecedented public-health crisis. Although the pandemic does not deprive defendants of their constitutional right to a speedy trial, it did make it impossible for the Commonwealth to call cases to trial for five months in 2020 and limited the number of trials called for four months in 2020.

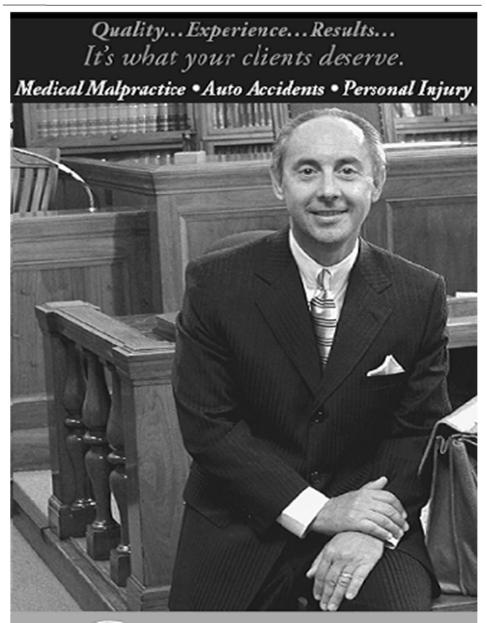
The Commonwealth presented a Rule 600 calculator (Exhibit 1), and this Court finds that the run date was properly calculated, with the new Rule 600 Run date to be November 14, 2021. Defendant's Motion to Dismiss under rule 600 was filed October 19, 2021, thereby extending the Adjusted Run Date by 20 days, to December 4, 2021.

CONCLUSION

For the foregoing reasons, Defendant's Motion is denied. This case shall be listed for trial, and the expiration date under Rule 600 is December 4, 2021. This case shall be called during the December term of criminal jury trials.
