NOTICE IS HEREBY GIVEN, pur-
suant to Section 4(a) of the Pennsyl-
vania Economic Development Financ-
ing Law, Act of Aug. 23, 1967, P.L.
251, No. 102, as amended (the "Act"),
that on March 1, 2016, the Township
of Springfield, Mercer County, Penn-
sylvania (the "Township") has duly
adopted a Resolution (the "Resolu-
tion") approving the formation of an
economic development authority

under the Act to be known as the
Springfield Township Economic
