COMMONWEALTH OF PENNSYLVANIA DAMIEN CLAGON

OPINION

On November 5, 2020, Damien Clagon ("Clagon") filed a pro se "Petition to Revisit Per Unfounded Offense and Unlawful Confinement" ("Petition"), which the Court deems to be Clagon's fifteenth petition in the nature of a request for post conviction collateral relief pursuant to the Post Conviction Relief Act (PCRA), 42 Pa.C.S.A. §§ 9541-9546.² After an initial review of the matters of record relating to Clagon's claims, the Court found the petition was not timely filed pursuant to 42 Pa. C.S.A. § 9545 and Clagon failed to prove any of the exceptions set forth in § 9545(b)(1)(i)-(iii) to the timeliness requirement. Accordingly, on November 24, 2020, the Court filed a Notice, pursuant to Pa. R.Crim.P. 907(1), of its intent to dismiss the pro se Petition without the appointment of counsel³ and without a hearing.⁴ The Court allowed Clagon twenty days from the date of the Notice to file an amended petition in response to the Notice. Clagon filed a timely response on December 3, 2020,⁵ titled "In Response to This Honorable Courts Notice [11.24.20] Pursuant to Pa. R.Crim.P. 907" ("Response"). This matter is now ripe for disposition.

I. Background

1The pleading is deemed filed on the date of mailing, November 5, 2020, rather than the date of docketing, November 9, 2020, pursuant to the "prisoner mailbox rule." Commonwealth v. Crawford, 17 A.3d 1279, 1281 (Pa. Super. 2011) ("Under the prisoner mailbox rule, we deem a pro se document filed on the date it is

2 This petition must be treated as yet another PCRA petition. The PCRA is the sole means of obtaining collateral relief. See 42 Pa. C.S.A. § 9542. Pennsylvania courts have consistently held that, so long as it falls within the ambit of the PCRA, any petition filed after the judgment of sentence is final is to be treated as a PCRA petition. See Commonwealth v. Jackson, 30 A.3d 516, 521 [Pa. Super. 2011) (stating that the Superior Court has "repeatedly held that any petition filed after the judgment of sentence becomes final will be treated as a PCRA petition") (citation and ellipses omitted); see also Commonwealth v. Pagan, 864 A.2d 1231, 1233 (Pa. Super. 2004) (stating that "[u]nder the plain words of the [PCRA], if the underlying substantive claim is one that could potentially be remedied under the PCRA, that claim is exclusive to the PCRA" (emphasis in original). That Clagon has attempted to frame his most recent pleading as a "Petition to Revisit Per Unfounded Offense and Unlawful Confinement" does not change the applicability of the PCRA. See Commonwealth v. Kutnyak, 781 A.2d 1259, 1261 [Pa. Super. 2001) (holding that, regardless of what a defendant titles his petition, "the PCRA is the exclusive vehicle for obtaining post-conviction collateral relief."]. Accordingly, this pro se petition must be treated as Clagon's fifteenth serial PCRA petition.

3 A criminal defendant does not have a constitutional right to counsel in a state collateral proceeding. Pennsylvania v. Finley, 481 U.S. 551, 555 (1987); Commonwealth v. Beasley, 544 Pa. 554, 564, 678 A.2d 773, 778 (1996). He has a statutory right under the 1995 amendments to the PCRA to the appointment of counsel for his first PCRA petition where he can satisfy the judge that he is unable to afford o

hearing is required.

⁴ Under Rule 907 of the Pennsylvania Rules of Criminal Procedure, a PCRA court may dispose of post conviction collateral relief petitions without a hearing if it is satisfied after reviewing the materials submitted that no genuine issues of material fact exist and that the petitioner is not entitled to post conviction relief. 5 Time stamped and docketed by the Court on December 11, 2020.

The procedural and factual background of this murder case has been set forth repeatedly and at length in this Court's previous opinions, and will therefore only be summarized briefly here for the sake of clarity. On November 9, 2004, Clagon was convicted by a jury of first degree murder and firearms not to be carried without a license in connection with the March 28, 2003, shooting death of Joseph Meikle in the City of Lancaster. On January 7, 2005, Clagon was sentenced to life in prison. The Superior Court affirmed the judgment of sentence. Commonwealth v. Clagon, 890 A.2d 1094 (Pa. Super. Nov. 29, 2005) (unpublished memorandum). Clagon did not appeal to the Pennsylvania Supreme Court.

On January 3, 2006, Clagon sought an appeal nunc pro tunc under the PCRA. On January 4, 2006, Clagon's appellate rights were reinstated nunc pro tunc and he filed a petition for allowance of appeal in the Pennsylvania Supreme Court. This request was denied on June 28, 2006. Commonwealth v. Clagon, 588 Pa. 747, 902 A.2d 1239 (table). Clagon did not petition for writ of certiorari in the United States Supreme Court.

On November 21, 2006, Clagon filed his first PCRA petition. Court-appointed counsel filed an amended petition on April 26, 2007. Clagon's amended petition was denied on July 17, 2007. On April 16, 2008, the Superior Court affirmed the denial of Clagon's first PCRA petition. Commonwealth v. Clagon, 953 A.2d 825 (Pa. Super. Apr. 16, 2008) (unpublished memorandum). Clagon's request for allowance of appeal to the Pennsylvania Supreme Court was denied on December 5, 2008. Commonwealth v. Clagon, 600 Pa. 727, 963 A.2d 467 (2008) (table). Clagon's petition for re-hearing was dismissed as untimely by the Supreme Court on January 2, 2009. Clagon did not seek a writ of certiorari from the United States Supreme Court.

After failing to find relief in the Pennsylvania courts, Clagon filed a federal petition for writ of habeas corpus in the United States District Court for the Eastern District of Pennsylvania on January 21, 2009. On August 13, 2009, the District Court dismissed the petition, in part, as procedurally defective, and denied the petition, in part, for failure to state a meritorious claim. Clagon v. DiGugliemo, 2009 WL 2496433 (E.D.Pa. Aug. 14, 2009). Clagon's appeal to the United States Court of Appeals for the Third Circuit was denied on November 16, 2009. A subsequent petition for re-hearing was denied on December 21, 2009. Clagon did not file for writ of certiorari with the Supreme Court of the United States.

On December 10, 2010, Clagon filed a pro se "State Writ of Habeas Corpus." This Court found that petition was properly characterized as a petition for post conviction collateral relief, and dismissed it as untimely filed. That dismissal was affirmed by the Superior Court on April 11, 2012. Commonwealth v. Clagon, 48 A.3d 474 (Pa. Super. April 11, 2012) (unpublished memorandum). No petition for allowance of appeal was filed with the Supreme Court of Pennsylvania.

⁶ See Trial Court Opinions of: April 19, 2005, July 17, 2007, December 22, 2010, and October 23, 2012. 7 18 Pa.C.S.A. § 2501(a) and 18 Pa.C.S.A. § 6106, respectively.

Over the ensuing years, Clagon has filed multiple pro se pleadings which this Court has determined to be petitions in the nature of requests for post collateral relief. They have all been dismissed as untimely. The last such petition was filed on February 3, 2017. Because the petition was untimely and Petitioner failed to plead and prove any of the exceptions to the timeliness requirement, the Court dismissed the petition by Order dated March 2, 2017. Clagon filed a notice of appeal to the Superior Court from that decision, however he failed to file a timely appellate brief and the Superior Court dismissed the appeal on August 5, 2017. Commonwealth v. Clagon (No. 631 MDA 2017).

With the filing of this latest Petition and Response, Clagon has launched his fifteenth attempt at obtaining post conviction collateral relief. On November 24, 2020, after a review of the matters of record relating to Clagon's stated claims, the Court issued a Notice, pursuant to Pa. R.Crim.P. 907(1), of its intent to dismiss Clagon's Petition because it was untimely pursuant to 42 Pa.C.S.A. § 9545(b) and although Clagon claimed to have found new evidence, he failed to produce it with the Petition and thus failed to prove any exception to the timeliness requirements. ⁸ Clagon was given twenty days from the date of the Notice to file an amended petition in which he either produced the claimed new evidence and/or otherwise responded to the Rule 907 Notice. Clagon filed a timely response on December 3, 2020, on thich he attached what appears to be the printout of an email from trial witness Trevar Bailey ("Bailey"), dated September 6, 2020.

II. Discussion

Under the PCRA, all petitions, including a second or subsequent petition, must be filed within one year of the date that the petitioner's judgment became final, unless one of three statutory exceptions applies. 42 Pa.C.S.A. § 9545(b)(1); Commonwealth v. Chester, 586 Pa. 468, 471, 895 A.2d 520, 522 (2006); Commonwealth v. Johnson, 803 A.2d 1291, 1294 (Pa. Super. 2002). For purposes of the PCRA, a judgment becomes final at the conclusion of direct review. 42 Pa. C.S.A. § 9545(b)(3). A petition must comply with the PCRA's time restrictions, which are jurisdictional in nature, and go to a court's right or competency to adjudicate a controversy. Commonwealth v. Fahy, 558 Pa. 313, 328-29, 737 A.2d 214, 222 (1999). These timeliness requirements are mandatory, strict and absolute, and a trial court does not have jurisdiction to hear a PCRA petition if the petition was untimely filed. Id.; Commonwealth v. Rienzi, 573 Pa. 503, 506, 827 A.2d 369, 371 (2003).

This Court sentenced Clagon on January 7, 2005. Following direct review in the Superior Court, our Supreme Court denied allowance of appeal on June 28, 2006. Therefore, Clagon's judgment of sentence became final on September 26, 2006, upon expiration of the time to file a petition for writ of certiorari with the United States Supreme Court. See

⁸ Clagon claimed in his Petition to have "after-discovered" evidence in the form of an electronic communication, yet he failed to produce with the Petition a copy of the alleged communication or to detail any specifics
about it, such as the identity of the sender of the communication, the identity of the person to whom it was
sent, or any other specifics regarding the content of the alleged communication. Nor did Clagon explain how
the alleged communication could be construed as newly discovered evidence previously unavailable to him
when he filed his multitude of past PCRA petitions.

U.S.Sup.Ct.R. 13 (allowing 90 days to file petition for writ of certiorari with Supreme Court). Clagon filed the instant Petition on November 5, 2020, some fourteen years after his sentence became final. Thus, the Petition is untimely on its face and the Court lacks jurisdiction to rule on the merits unless the petition alleges and Clagon is able to prove at least one of the statutory exceptions:

- (i) the failure to raise the claim previously was the result of interference by government officials with the presentation of the claim in violation of the Constitution or laws of the United States;
- (ii) the facts upon which the claim is predicated were unknown to the petitioner and could not have been ascertained by the exercise of due diligence; or
- (iii) the right asserted is a constitutional right that was recognized by

the Supreme Court of the United States or the Supreme Court of

Pennsylvania after the time period provided in this section and has

been held by that court to apply retroactively.

42 Pa. C.S.A. § 9545(b)(1).

The first issue Clagon raises, captioned "FACTS IN RECORD IN PROOF OF UNFOUNDED OFFENSE OF MURDER," is essentially an effort to relitigate the sufficiency of the evidence for the first degree murder conviction. He offers no explanation for why the Court would have jurisdiction to consider this untimely claim and the Court's independent review of the record reveals nothing that would justify invoking any of the three enumerated statutory exceptions to the timeliness requirements for this claim. Clagon's sufficiency claim is barred not only by its untimeliness, but also by the fact he has previously litigated this issue to no effect at trial, on appeal, and in post collateral relief proceedings before both this Court and the Superior Court. Clagon has offered nothing new that would provide a basis for this Court to exercise jurisdiction to hear this untimely claim.

The second issue Clagon raises in the Petition is captioned "AF-TER DISCOVERED TIMELINESS EXCEPTION." Here, Clagon alleges he is in possession of "new" evidence purportedly showing that trial witness

¹⁰ A petitioner seeking relief pursuant to the PCRA is eligible only if he pleads and proves, by a preponderance of the evidence, that he has not previously litigated the issues he raises. 42 Pa. C.S.A. § 9543(a) (2)-(4). A petitioner has previously litigated an issue if (1) the highest appellate court in which a petitioner could have had review as a matter of right has ruled on the merits of the issue, Commonwealth v. Spotz, 47 A.3d 63, 76 (2012), or (2) the issue has been raised and decided in a proceeding collaterally attacking the conviction or sentence. 42 Pa. C.S.A. § 9544(a); Commonwealth v. Phillips, 31 A.3d 317, 320 (Pa. Super. 2011). In this case, Petitioner litigated the issue of his conviction through the Superior Court and then again through collateral proceedings in this Court and the Superior Court as well.

¹¹ To the extent that Clagon claims the newly offered email printout would render the Commonwealth's evidence of first degree murder insufficient, the Court will address this matter with Clagon's second claim, infra.

Bailey offered perjured testimony at Clagon's 2004 trial.¹² Specifically, Clagon alleges the following:

On 9.8.20, via the Department of Corrections electronic mail (e-mail); GTL Communications system, Petitioner was informed that the Commonwealth; prosecution knowingly used false testimony to convict Petitioner, whereas its witness, jailhouse informant TREVAR BAILEY, testified insidiously, admittedly stating he offered false testimony [intentionally disinforming the jury and subverting the truth determining process of the instant case] in efforts to curry favor from the COMMONWEALTH with pending criminal charges.

Petition at I¹³ (parentheticals and punctuation in the original). Clagon further claimed to have new evidence of Bailey's "disclosed truth" on his personal email device, but did not attach a copy of any documents to the initial Petition. In his Response to the Court, however, Clagon attached an exhibit purporting to be a printout of the referenced email, which states as follows:

what's up Dee? If you don't know who this is this is Lex, AKA Trevar Bailey. I'm sending you this email because there is something that I need to say to you. I don't know if it'll mean anything to you but I need to say it because its been bothering g [sic] me for years. I'm [sorry] I lied at your trial. I made false statements about what I knew and what you told me. You never told me you committed a crime, actually you told me several times while we were cellies that you didn't kill dude and that that crack head dude was lying on you to get out of his charges for robbing them stores! I tried to use your situation to get out of my situation. I wasn't coached by anybody and that's why my story was not accurate. Once again if this will mean anything to you but that's why I'm reaching out to you. If you need my help somehow please let me know and I'm willing to help any way I can. And just for the record I'm not being threatened nor have I been offered anything for saying this! I was wrong and I lied and I just want to do the right thing. Let me know

See Attachment to Response, December 3, 2020. Clagon alleges this 12 Clagon was at one time prior to his trial housed with Bailey in prison; Bailey testified against Clagon at the trial, offering incriminating statements Clagon made to him regarding the murder.

13 In his Petition, Clagon utilizes cardinal numbers for pages relating to the first issue, but Roman numerals for pages relating to the second issue.

email constitutes "new evidence" of Bailey's perjury that entitles Clagon "to relief from culpability for an offense of murder, and/or entitled to appointed counsel and a hearing to determine such, to determine the wrongful conviction for said unfounded offense of murder; falsely presented offense of murder." Response at 8 (unpaginated).

The Court notes that in seven of his prior PCRA petitions, Clagon has raised and the Court has denied or dismissed Clagon's claims that Bailey's testimony was perjured, that the Commonwealth knowingly offered the perjured testimony, and that the jury would not have found Clagon guilty of first degree murder absent Bailey's perjured testimony. Having thoroughly reviewed and considered the instant Petition, the Response, and the printout of the email, the Court concludes that even with the addition of this email, Clagon still cannot meet his burden of proof as required for the "newly discovered fact" exception to the time bar set forth in section 545(b)(1)(ii).

To be entitled to relief under the PCRA on the basis of "newly discovered" evidence, the petitioner must plead and prove by a preponderance of the evidence "[t]he unavailability at the time of trial of exculpatory evidence that has subsequently become available and would have changed the outcome of the trial if it had been introduced." 42 Pa. C.S.A. § 9543(a)(2)(vi). The focus of this exception "is on the newly discovered facts, not on a newly discovered or newly willing source for previously known facts." Commonwealth v. Marshall, 596 Pa. 587, 596, 947 A.2d 714, 720 (2008). Credibility determinations regarding alleged after-discovered evidence are "best left to the trial court." Commonwealth v. Perrin, 59 A.3d 663, 669 (Pa. Super. 2013) (Wecht, J. concurring).

Our Supreme Court has addressed a factual scenario similar to that before us now, where a petitioner in post-collateral proceedings offered recantation testimony in the form of an affidavit in an effort at winning a new trial. In the case of Commonwealth v. Small, 647 Pa. 423, 189 A.3d 961 (2018), the Supreme Court thoroughly explains the need for caution when reviewing recantation testimony in post collateral proceedings. Discussing an affidavit of recantation, the Supreme Court highlights

the limitations inherent in recantation testimony, which has been characterized as extremely unreliable . . . In fact, we have remarked that there is no less reliable form of proof, especially where it involves an admission of perjury. For that reason, we have emphasized that, when addressing an after-discovered evidence claim

¹⁴ See Clagon's prior PCRA petitions filed May 2014, March 2015, September 2015, February 2016, May 2016, and February 27, 2017. Previously, Clagon based his claim solely on his own belief that Bailey's testimony was inconsistent with the other trial evidence. As the claim did not present new evidence, it did not come within the purview of any of the three timeliness exceptions in § 9545(b)[1](i-iii), and the Court routinely dismissed it as untimely. Nonetheless, in prior rulings, the Court has briefly addressed the merits and determined consistently that even assuming, arguendo, that Bailey did perjure himself and that the Commonwealth did knowingly present this false and misleading testimony, such did not impact the verdict, as Bailey's credibility was challenged extensively during cross-examination. premised on recantation testimony, the PCRA court must, in the first instance, assess the credibility and significance of the recantation in light of the evidence as a whole. Unless the [PCRA] court is satisfied that the recantation is true, it should deny a new trial.

Id. at 977 (internal quotations and citations omitted) (emphasis added) (overruling trial court's grant of new trial based on recantation affidavit).

The new evidence Clagon presents in the form of an unauthenticated email is inherently not credible and therefore problematic. The proffered email is not a sworn affidavit.15 In fact, Clagon makes no assertion that Bailey himself would be available and willing to subject himself to the criminal charge of perjury by testifying to this recantation under oath.16 As such, the printout of the email itself is the extent of Clagon's "new" evidence and the email itself lacks any indicia of credibility. No email addresses appear on the printout, making it impossible to know whether Bailey himself actually sent the email and to whom it was sent. Damien Clagon's name is never mentioned in the body of the email. Clagon offers nothing other than his own assertions that the email was actually written by Bailey and that the recantation is, in fact, authentic. In our electronic age, this evidence could have been fabricated by anyone and made to appear to have come from Bailey. The Court finds it highly unlikely that Bailey, who admitted on cross-examination at trial to testifying in hopes of receiving favorable treatment from the Commonwealth on his own pending criminal charges, 17 would at this late date subject himself to a charge of perjury on Clagon's behalf.

Even assuming arguendo the Court could find credibility in this email, the jury's knowledge of its content would not have changed the outcome of the verdict. Clagon does not claim innocence based on this recantation;¹⁸ rather, he states that "[p]er clarification, Petitioner does not argue his proven guilt for criminal homicide in the instant case, only that the homicide as presented in the instant trial fails to reflect an offense of murder." Response at 6 (unpaginated). As he admittedly is not claiming innocence, most of the email's content is therefore irrelevant. The only arguably relevant statements would be: "I'm s[or]ry I

¹⁵ Although the printed email does have a notary's seal at the bottom, Clagon provides no explanation for why this notarization appears and whose handwriting or signature seems to have been placed at the bottom. It would be pure conjecture for the Court to assign any meaning to this signature and notarization.

16 Although the email states "I'm willing to help any way I can," nowhere does the sender offer to testify under oath. A significant difference exists between a willingness to write an email with a recantation and a willingness to expose oneself to criminal prosecution by admitting under oath that one has previously lied under oath. under oath.

under oath. 17 For example, see Notes of Transcript ("N.T.") for the trial, where Clagon's attorney cross examined Bailey regarding his pending criminal charges: "Do you hope to get help with charges in exchange for your testimony?" Bailey responded: "I was hoping that it would be taken into consideration." (N.T., Trial at 337.) This testimony establishes that in 2004 Clagon knew (1) Bailey had criminal charges pending against him at the time of his testimony against Clagon, and (2) Bailey and the Commonwealth had no agreement regarding those pending charges in exchange for his testimony, but that Bailey hoped for some consideration. 18 It should be noted that in the initial Petition, Clagon does assert at one point that "by refusing entertainment of the instant PETITION TO REVISIT, and/or allotted relief, this honorable court would thereby require an individual who is actually innocent of that he was actually tried for remain unjustly imprisoned." Petition at 11 (capitalization and punctuation original). The Court interprets this assertion in conjunction with Clagon's subsequently filed Response, where he states, "[p]er clarification, Petitioner does not argue his proven guilt for criminal homicide in the instant trial fails to reflect an offense of murder." Response at 6 (unpaginated). Read together, the clauses indicate that Clagon's first assertion refers to an assertion of actual innocence of the charge of first degree murder as opposed to some lesser degree of homicide and not to actual innocence of criminal homicide. opposed to some lesser degree of homicide and not to actual innocence of criminal homicide.

lied at your trial. I made false statements about what I knew and what you told me" and "I tried to use your situation to get out of my situation." Bailey's self-serving motivation for testifying was made known to the jury through Bailey's testimony on cross-examination at trial. Thus, the only real "new" facts contained in the email would be Bailey's admission that he lied. Clagon simply cannot show that such evidence, even if known and believed, would have resulted in a verdict other than first degree murder. The recantation, if believed, would at best practically serve to remove Bailey as a Commonwealth witness such that the jury would have heard none of his testimony. The Court has examined the entire record on numerous prior occasions over the years and consistently found that even without any testimony from Bailey whatsoever, the Commonwealth presented substantial additional evidence, both physical and circumstantial, of Clagon's guilt to prove beyond a reasonable doubt that Clagon is guilty of first degree murder. 19 The Superior Court has affirmed this finding,²⁰ and this Court finds now that the inherently unreliable email evidence, utterly devoid of any semblance of credibility, does nothing to change the Court's opinion in this regard.

III. Conclusion

For the reasons set forth above, the Court finds that Clagon's pro se "Petition to Revisit Per Unfounded Offense and Unlawful Confinement" qualifies as a PCRA petition, that said Petition is untimely on its face, and that Petitioner Damien Clagon has failed to prove that his Petition meets the requirements of the statutory exceptions to the PCRA's jurisdictional time-bar. This Court, therefore, lacks jurisdiction to consider Petitioner's substantive claims.

Accordingly, I enter the following:

Pursuant to Pa. R.Crim.P. 907(4), this Court advises Petitioner that he has the right to appeal from this Order. Petitioner shall have 30 days from the date of this final Order to appeal to the Superior Court of Pennsylvania. Failure to appeal within 30 days will result in the loss of appellate rights.

Once you make a bid, which is accepted as the highest bid, you have bought whatever interests the defendants have, if any, in that property and you must pay that sum of money to the Sheriff's Office regardless of what you later find out about the title. You must know what you are bidding on before you bid and NOT

after. All sales are FINAL after the property has been struck off to you as the highest bidder, and no adjustments will be made thereafter.

Payment for properties must be in the form of lawful money of the United States, a certified or cashier's check from a bank, or a Lancaster County attorney's check. The Sheriff's Office will NOT accept any other form of payment.

In order to expedite the sale, the Sheriff's Office encourages, but does not require, plaintiffs to announce an "upset" price, which is the least amount the plaintiff will accept for a property. Any bidding above the plaintiff's opening costs bid for such property will begin at that stated upset price. Subsequent bids shall be in no less than \$1000 increments. Plaintiffs may withdraw a property from sale any time before the property is struck off as sold to the highest bidder.

Immediately upon a property being struck off to the highest bidder, the buyer must state the buyer's name (unless buying the property on behalf of the plaintiff for costs only) and come forward to settle with the clerks. The buyer must present a legal picture identification acceptable to the Sheriff's Office, such as a driver's license, and immediately pay 20% of their bid as a down payment to the Sheriff's Office. The buyer must subsequently pay the balance of their bid within 30 days after the sale date.

Each buyer shall file a properly completed and signed Pennsylvania Realty Transfer Tax Statement of Value in duplicate with the Sheriff's Office within 15 days after the sale date. All applicable

realty transfer taxes will be fully paid from the sale proceeds by the Sheriff's Office. If the proceeds are insufficient to pay all the sale costs, realty transfer taxes, and priority liens, then the buyer shall pay the balance of such amounts to the Sheriff's Office within 30 days after the sale date.

If no petition has been filed to set aside a property sale, the Sheriff will execute and record a deed 20 days or more after filing a proposed Schedule of Distribution with the Prothonotary's Office, conveying all the real estate rights, title, & interests of the defendants in the property. Distribution of the sale proceeds will be made per the proposed Schedule of Distribution 11 or more days after the filing of such Schedule, provided no exceptions are filed regarding the proposed distribution.

The Sheriff's Office may hold agents responsible for their winning bids if their principal fails to comply with these Conditions of Sale, unless the agent has a notarized agency agreement and presents same to the Sheriff's Office prior to the beginning of the sale.

If a buyer breaches or otherwise fails to comply with these Conditions of Sale, the buyer shall forfeit their down payment to the Sheriff's Office in its entirety as liquidated damages, and the buyer also shall be liable to the Sheriff's Office for all costs, expenses, losses, and damages (including, without limitation, attorney fees) suffered or incurred by the Sheriff's Office (1) to resell the property or (2) above and beyond such down payment amount, or both of the foregoing.

The Sheriff's Office reserves the

right to alter or modify these conditions of sale during or before each sale, or on a case by case basis. The Sheriff's Office decision shall be final regarding all sale issues and disputes.
