

Legal History & Changes By Leo E. Gribbin

By request, I am sharing my perspective of local legal history and changes to the practice of law. Over the years many changes have occurred, quite a few of which are too numerous for inclusion here

I was admitted in 1958 (a class of two with Bob Wire) when the annual bar exam passed about 35% of those taking it. Novice lawyers were required to serve a six-month clerkship. This was a statewide requirement often fulfilled in the office of a practicing attorney or firm. Many local bar associations, including York, also required applicant lawyers to appear before a committee for review and approval. Some horror stories existed about several

who were rejected. Fortunately, both these requirements are in the legal graveyard. Some counties enforced a rule on out-of-county lawyers who were required to use a local attorney in various practice areas. The adoption of statewide practice by the Supreme Court revoked this.

The York Bar was much smaller then, approximately 100 members. Jane Alexander was the only female attorney. There would have been two lady lawyers, but Mary Jane Yohe died in 1954. Socially, there was an annual dance, a picnic at the river, a golf outing locally with dinner, and a separate golf match with Adams County and sometimes with Lebanon. The Bar provided free coffee on the third floor of the old courthouse in the Lawyers Reading Room, also known as the lounge, where the Judges and lawyers socialized, exchanged experiences, some of which were true, gossiped, and many times, settled cases. A sizable number of lawyers ate lunch at the Yorktowne Hotel coffee shop which reserved a large section to accommodate them.

The Bench was comprised of three judges: Anderson, Atkins, and Kohler, all very able. On 1/1/1958, Atkins and Kohler replaced Judges Sherwood and Gross. Judge Kohler told me our local court was held in high esteem statewide and had never been reversed. An enjoyable part of practice permitted attorneys to discuss legal matters with Judges if there was no opposing counsel. Most lawyers knew each other and, in general, got along well. Through the years, the Bar has grown to its present size (528). With specialization and paralegals, lawyers have fewer contacts with each other, and, in some respects, practice is more impersonal.

CLE was not yet mandatory to retain your license. Lawyers search their clients' titles, a substantial source of income for many. Banks accepted lawyers' title certificates. Title insurance was a rarity. The majority of lawyers were general practitioners. Specialization had not yet infringed on that area of practice.

The practice today is confronted with new and expanded fields including, but not limited to, Zoom, elder care, Medicare, family law, credit card fraud, cybersecurity, guardianship, power of attorney, COVID-19 statutes, practice from home, etc., etc.

The Bar Stools and the Bar Foundation are laudable developments for their outstanding contributions, especially financial, to the community. The membership can be justly proud of them. A major change in practice, advertising, has created an ongoing debate: whether the practice is still a profession or has become too commercialized. What do you think?
