Bail: \$10,000 unsecured

Next Court appearance: Central Court, Wednesday, November 26, 2025 **Editorial** (according to the criminal complaint):

In October 2025, an investigation revealed that the Juliana Morse, a Food Service Instructor at a state correctional institution, was involved in bringing contraband into the facility. Recorded inmate phone calls showed repeated discussions about football schedule papers the defendant delivered, which were later found saturated with synthetic cannabinoids. Officers recovered several of these papers during searches, all of which were confirmed by forensic testing to contain Schedule I controlled substances.

Interviews with involved inmates established that the defendant brought three papers into the institution and received payment for them. Additional statements and lab results confirmed the papers were redistributed inside the facility and used as a vehicle for controlled substances. Based on these findings, investigators concluded that the defendant played a direct role in introducing contraband and requested that she be brought before the court to answer the charges.

The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.
