Preliminary objections - Striking of complaint - Foreclosure complaint

- 1. Pursuant to Pa.R.C.P. No. 1147, a complaint in mortgage foreclosure must state the parties to and the date of and the place of record of any assignment of the mortgage.
- 2. The failure of the assignment to have been recorded is not fatal to plaintiff's claim but, in that event, Pa.R.C.P. No. 1019(i) applies and plaintiff must attach a copy of an unrecorded assignment to the complaint unless "the writing or copy is not accessible to the pleader."
- 3. Plaintiff attached a copy of the assignment to its response to defendant's preliminary objections which forecloses any argument that a copy of the assignment is not accessible to the plaintiff.
- 4. Attaching a document to a response to preliminary objections does not make that document part of the complaint. Upon consideration of defendants' preliminary objections, this Court <u>Held</u> that the preliminary objections are sustained in part and overruled in part, the complaint is stricken and pursuant to Pa.R.C.P. No. 1028(e), plaintiff shall have the right to file an amended complaint within twenty (20) days.

ORDER

AND NOW, this 22nd day of August, 2011, upon consideration of defendants' preliminary objections to plaintiff's amended complaint and plaintiff's response thereto, it is hereby ORDERED that the preliminary objections are SUSTAINED in part and, for the reasons set forth in footnote 1, *supra*, the amended complaint is STRICKEN. Otherwise the preliminary objections are overruled. Pursuant to Pa.R.C.P. No. 1028(e), plaintiff shall have the right to file an amended complaint within twenty (20) days from the date of this order.

¹ Pursuant to Pa.R.C.P. No. 1147, a complaint in mortgage foreclosure must state the parties to and the date of and the place of record of any assignment of the mortgage. We agree that the failure of the assignment to have been recorded is not fatal to plaintiff's claim but, in that event, we believe Pa.R.C.P. No. 1019(i) applies and plaintiff must attach a copy of an unrecorded assignment to the complaint unless "the writing or copy is not accessible to the pleader." Plaintiff argues that in this case neither requirement applies and relies upon *US Bank N.A. v. Mallory*, 982 A.2d 986 (Pa.Super. 2009) in support of its position. Such reliance is misplaced. In *Mallory* the Superior Court held that it was not error to refuse to strike a judgment even though no copy of an assignment was attached to the

complaint nor reference made to the place of recording and that the averments in plaintiff's complaint were sufficient to overcome the claim that there was a fatal defect apparent on the face of the record such that the default judgment should have been stricken. *Id* at 992. If judgment had been taken on this complaint, perhaps the judgment would have withstood a motion to strike. Plaintiff's argument that the distinction in the procedural posture of this case and *Mallory* is "of no moment" is not supported by any logic or argument. Furthermore, germane to the decision of the Superior Court in Mallory was that the complaint sufficiently set forth why the assignment was not available to the plaintiff. In this case, however, the assignment was in writing and in existence prior to the filing of the amended complaint. (The amended complaint was filed on June 10, 2011, and verified on June 7, 2011. The assignment is dated May 24, 2011.) Plaintiff has attached a copy of the assignment to its response to defendant's preliminary objections which rather forecloses any argument that a copy of the assignment is not accessible to the plaintiff. Attaching a document to a response to preliminary objections does not make that document part of the complaint. It might well have been the wiser course of action for plaintiff to have filed a 2nd amended complaint attaching a copy of the assignment, a course of action that plaintiff will now almost certainly pursue.



The estimated revenue to be derived from the tax during 2012 is \$1,421,327.
