OPINION AND ORDER

No. 464 of 2024

VERNON, J. June 3, 2025

Before the Court is the Omnibus Pretrial Motion filed by Defendant, Joseph Glenn Hardin, moving to suppress his statements made in a post-polygraph interview. Defendant argues that he informed officers that he could not read, was uncomfortable, and suffering from chest pain; that he was not further informed of his Miranda warnings prior to the polygraph examination or post-polygraph interview; that he did not complete a knowing, voluntary, and intelligent waiver of his Miranda rights; and that during the post-polygraph interview that Defendant indicated he wanted counsel yet the troopers continued to interrogate him.

At the time set for hearing, the Commonwealth presented the testimony of the officer who performed the polygraph examination, and submitted as exhibits the video with audio recordings of the pre-interview, polygraph examination, and post-interview. During testimony of the polygraph examiner, Defendant suffered chest pains in court and was taken by ambulance from the hearing. The Court has fully reviewed the same.

The pre-polygraph interview recording begins with the officer telling Defendant,

I will explain everything to you beforehand. [...] First thing we are going through is a consent form. This is completely voluntarily. You don't have to do this. Nobody can force you to do this. It can't be held against you if you don't do this. It has to be completely voluntary for you to do this exam.

The officer then presented Defendant with a consent form to which Defendant responded advising the officer that he was unable to read and was nervous. The trooper mitigated concerns regarding Defendant's illiteracy by reading the consent form aloud to him, which included his Miranda warnings. Upon hearing the Miranda warnings, Defendant stated, "Sounds like I'm being arrested." The officer responded,

You are not in custody. You are free to leave here any time you want to. This is a voluntary process. You can't be forced to take this thing. You can't be forced to answer any questions or anything like that. That's why it has to be completely vol-

untary on your part to take this examination.

Defendant responded in the affirmative indicating he understood. The officer then stated, "If you decide to answer any questions, you may stop at any time you wish. [...] Do you understand the things I read to you?" Defendant responded, "Yes, sir" then initialed the consent form. The pre-polygraph interview and polygraph examination occurred without incident.

In the post-polygraph interview, at 12:55 p.m., Defendant was questioned about the truthfulness of his polygraph examination.

First Officer: We asked you a pretty direct question about it and obviously you weren't telling the truth about it. So you gotta fill me in on how you can't tell the truth on that portion of it. That's the only reason we're here today. Remember, I don't work here. I'm unbiased. The only thing I get is the truth that

Defendant: So you're saying I can come back with a lawyer and talk to you guys?

First Officer: You can do whatever you like. I just like to know the truth in regards to this incident. Because I know at the beginning you were forthcoming with me. Okay?

Defendant: I'm thinking about picking the lawyer option.

Officer. Okay, are you requesting a lawyer?

Second Officer: We don't give advice on a lawyer. You saying you do want one or you're thinking [...]

Defendant: [interrupting] I know a lawyer sounds like I'm making the wrong decision.

Second Officer: You have the right to an attorney. We even told you that in the beginning. If you want to continue to talk about it... If I just understood you correctly, did you say you're thinking about an attorney, getting a lawyer?

Defendant: I know what I did and didn't do and this test [...]

Second Officer: You didn't say that you want an attorney. You said that you're thinking about an attorney.

Defendant: It's like making me nervous about it.

Second Officer: A person saying they're thinking about an attorney and the fact that you haven't made a decision yet to invoke your right to an attorney makes us think that maybe you do want to talk about it a little more. I'm going to have to guess what's holding you back from talking about it more is you keep bringing up one thing and that's your fear of the father and his nuttiness or whatever you want to call it. You said he's crazy or whatever. He's not here right now.

Defendant: I know.

Second Officer: I think what would be best at this point is to get it all out and to show that you're remorseful for what's gone on and that you've been truthful. And until we get all of the truth, you've been giving us bits and pieces. Cause the way we started off today you said there's no touching, no sexual [...]

Defendant: I did not stick my dick in her. That's the thing though.

Second officer: So you said that she cupped you. Can you tell us what that means?

Defendant: Like put her hands underneath my pants where my dick and balls are at.

Second officer: Inside your pants or over top?

Defendant: No, just pants. Over top pants.

Second officer: Okay and you touched her vagina.

Defendant: Over top the pants. That's it.

The officers' questioning then continued for approximately four more minutes with Defendant making incriminating statements during that time. At 1:00 p.m., Defendant asked, "Can I be done please?" The officer responded, "If you want to be done, absolutely. Like I said if you want an attorney, you have the right to invoke your right to an attorney." Defendant huddled over and began crying stating, "I'm done. I'm leaving."

Effective assertion of the Fifth Amendment right to counsel "requires, at a minimum, some statement that can reasonably be construed to be an expression of a desire for the assistance of an attorney in dealing with custodial interrogation by the police." McNeil v. Wisconsin, 501 U.S. 171 (1991). For the Miranda rule to apply, there must be an unequivocal invocation of the right to counsel. Commonwealth v. Champney, 65 A.3d 386, 387 (Pa. 2013). The suspect must "articulate his desire to have counsel present sufficiently clearly that a reasonable police officer in the circumstances would understand the statement to be a request for an attorney." Davis v. United States, 512 U.S. 452 (1994).

Here, Defendant stated, "So you're saying I can come back with a lawyer and talk to you guys?" and then, "I'm thinking about picking the lawyer option." Rather than getting clarification on whether Defendant was invoking his Fifth Amendment right to counsel, the officer encouraged Defendant to continue talking, "I think what would be best at this point is to get it all out and to show that you're remorseful for what's gone on and that you've been truthful." The officer continued his questioning without any definitive answer from Defendant on his request for an attorney.

The Supreme Court was equally divided on the question of whether the words "I think" prior to a request for counsel rendered that request unambiguous. Commonwealth v. Champney, 65 A.3d 386 (Pa. 2013). The Opinion in Support of Affirmance found

dispositive that the defendant did not provide a second statement contradicting his initial desire to speak with counsel and rejected the idea "that employment of the phrase 'I think,' in and of itself renders [Defendant's] statement equivocal, as such term can be colloquially used to express one's beliefs and not to suggest that one is pondering or contemplating an action." Id. at 388. The Opinion in Support of Reversal found, "If our Court could examine and characterize the tone, demeanor, emphasis, or body language of the declarant, we might be allowed to find the sentiment expressed by [Defendant] was other than ambiguous — but we are not afforded that opportunity." Id. at 404.

This Court was afforded the ability to observe Defendant's tone, demeanor, emphasis, and body language and we find that Defendant was under duress when he began to break down during the questioning and by the time he requested to be "done" he was huddled over crying. Even if the officers viewed the Defendant's first mention of a lawyer as ambiguous because it was phrased as a question and likewise deemed the second reference, which included the word "think," to be equivocal, the officers never received clarification and instead continued questioning.

Upon review of the video, we hold that Defendant's statement, "I'm thinking about picking the lawyer option" was unambiguous notwithstanding the fact it was prefaced by the phrase "thinking" as his tone and demeanor support his invocation of the Fifth Amendment. The Courts have long held "if an individual is given the Miranda warnings and responds that he wishes to exercise any of those rights, all interrogation must cease." Commonwealth v. Mercier, 302 A.2d 337, 339 (Pa. 1973).

WHEREFORE, we will enter the following Order suppressing all statements made after Defendant's invocation of the Fifth Amendment at 12:55 p.m. in his post-polygraph interview.

ORDER

AND NOW, this 3rd day of June, 2025, upon consideration of the Omnibus Pretrial Motion filed by Defendant, Joseph Glenn Hardin, and in accordance with the foregoing Opinion, it is hereby ORDERED and DECREED that the Motion is GRANTED in part and all statements made after Defendant's invocation of the Fifth Amendment at 12:55 p.m. in his post-polygraph interview are SUPPRESSED.

It is further ORDERED and DECREED that the Motion to Suppress is DENIED in all other respects.
