SUMMARY OF OPINION:

The defendant-property owners in this slip-and-fall action filed a motion for summary judgment on the ground that the plaintiff could not sustain his burden of proving that he slipped and fell on "hills and ridges" of ice on their sidewalk. To recover for a fall on an icy or snow-covered sidewalk under the hills and ridges doctrine, a plaintiff must prove that the snow or ice had accumulated on the sidewalk in ridges or elevations of such size and character as to unreasonably obstruct travel and constitute a danger to pedestrians. However, proof of hills and ridges is necessary only when the fall occurred at a time when general slippery conditions prevailed in the community, rather than on a localized patch of ice on a sidewalk that was otherwise free of ice and snow. Since the summary judgment record reflected triable issues of fact as to whether "general slippery conditions" existed throughout the community, as opposed to ice being present only on the defendants' sidewalk, the defendants had not established the absence of a genuine issue of material fact as to the application of the hills and ridges doctrine or their entitlement to judgment in their favor based on that doctrine.

SUMMARY OF OPINION:

A podiatrist, whose employee forged the podiatrist's signature on medical insurance checks made payable to the podiatrist and thereafter deposited those checks into the employee's own account with the defendant-bank, instituted this action against that bank, which also served as the podiatrist's bank, alleging a failure to exercise ordinary care in negotiating those forged checks. A visiting senior judge previously dismissed the podiatrist's negligence claim as ostensibly barred by the gist of the action doctrine, and the bank thereafter filed a motion for summary judgment with regard to the podiatrist's remaining contract claim. The bank alternatively sought partial summary judgment based upon the four-year statute of limitations as to any claims for checks that were negotiated more than four years prior to the filing of suit.

Sections 3405(b) and 3406(b) of the Pennsylvania Uniform Commercial Code establish a customer's cause of action against a bank for failing to exercise ordinary care in negotiating a check, including instances of fraudulent indorsements by a customer's employee. Therefore, to the extent that the earlier ruling dismissed the customer's statutorily-based negligence claim on the ground that the bank's duty of care arose solely from the parties' contract rather than a societal duty created by Pennsylvania law, it was clearly erroneous and was required to be vacated under the coordinate jurisdiction doctrine. However, since the comprehensive remedial scheme set forth in the Code displaced all parallel common law claims, including a breach of contract claim, the bank's motion for summary judgment as to the podiatrist's contract claim was granted on that basis only. Moreover, inasmuch as 13 Pa.C.S.A. § 3118(g) imposes a three-year limitation period upon negligence claims under 13 Pa.C.S.A. §§ 3405-3406, which begins to run on the date that the check is negotiated, the podiatrist's damages claims for forged checks that were negotiated by the bank more than three years prior to the filing of suit were time-barred.
