Estate – Objection not raised is waived – Capacity/undue influence waived if no will contest

- 1. An objection not raised is waived.
- When one files Objections to the First and Final Account filed by the Executor
 of the Estate, references to an alleged lack of testamentary capacity or undue
 influence are waived if there is no will contest and no appeal from the Register's order was ever filed.
- 3. Decedent had an "Agent's Agreement" with State Farm that provided for Termination Payments and Life Termination Payments, payable to him or his legal representative. Under a private agreement between Decedent and his son Robert, who worked with Decedent, Robert was the beneficiary of the 5-year pay-out of Termination Payments. Decedent made "loans" during his life to both of his sons, Robert and Stephen; none of these "loans" were expected by the Decedent to be repaid by either son. Robert provided care for his father virtually every day for several years after the Decedent suffered a stroke. Decedent clearly preferred Robert over Stephen. The estate consisted of solely non-probate assets.

INTRODUCTION

This matter comes before the court on the objections filed by beneficiary, Stephen DiJoseph ("Stephen"), to the First and Final Account filed September 20, 2019 by his brother and Executor of the Estate, Robert DiJoseph ("Robert") (the "Account").

The court held two (2) days of hearings, November 4, 2020 and December 10, 2020, and now makes the following:

FINDINGS OF FACT

- 1. The Decedent, John DiJoseph Jr., died May 29, 2016.
- 2. Decedent's wife predeceased him in September 2012.
- 3. Decedent was survived by his two sons, Robert and Stephen, who are the parties here.
- 4. Decedent's Last Will and Testament dated December 14, 2012 (the "Will") was admitted to probate by the Register of Wills of Chester County on March 6, 2018.
 - 5. Robert was the named Executor under the Will. (Obj. Exh., p. 27).
- 6. Robert filed his First and Final Account for the Estate of John DiJoseph, Jr. on September 20, 2019.
 - 7. Stephen filed Objections thereto on February 5, 2020.

Decedent's Will

8. Decedent's Will disposed of the Estate's assets as follows:

SECOND: I give, bequeath and devise all of my estate of whatsoever kind, real and personal and wheresoever situate as follows:

- 1. I give and bequeath all of my interest in XYZ Management LLC, unto my beloved son, Robert DiJoseph.
- 2. I give and bequeath all of my business personal property located within the DiJoseph Agency, including but not limited to the bank account known as "DiJoseph Jr. DBA, DiJoseph Agency," unto my son, Robert DiJoseph, and

- 3. I give, bequeath and devise all the rest, residue and remainder of my estate of whatsoever kind, real and personal and wheresoever situate, as follows:
 - A) 70% of all my estate unto my beloved son, Robert DiJoseph, per stirpes;
 - B) 30% of all my estate unto my beloved son, Stephen DiJoseph, per stirpes.

The Power of Attorney

- 9. Decedent signed a Power of Attorney on December 14, 2020 naming Robert as his Agent.
- 10. At no time did Robert utilize the Power of Attorney to alter any bank accounts or other assets of the Decedent or the estate, which had previously been created by the Decedent.
- 11. Robert did not change beneficiary designations to favor himself to the detriment of Stephen, or in any other respect diminish the share which the Decedent had created for the benefit of Stephen.
- 12. All decisions made by the Decedent concerning his business and personal assets were made by him prior to his death.
- 13. At all times relevant hereto the Decedent had prior knowledge of and consented to any and all actions of Robert involving his business and personal assets.

Decedent's Insurance Business

- 14. For years, Decedent worked in the insurance business.
- 15. He operated a State Farm insurance agency, which he held as "XYZ Management, LLC" (the "Agency").
- 16. He held a bank account entitled "John DiJoseph DBA DiJoseph Insurance Agency" at Wells Fargo.
- 17. Robert and his father worked closely together in the Agency continuously from 1975 through the date the Agency closed in 2013.
- 18. Robert worked alongside his Father for the better part of forty (40) years at the insurance agency.
- 19. Decedent had an "Agent's Agreement" with State Farm that provided for Termination Payments and Life Termination Payments (the "Termination Payments"). The Termination Payments were payable to him or his legal representative for a five (5) year period following termination of the Agent's Agreement. (Objector's Exh., p. 86).
- 20. On May 1, 2001, Decedent and Robert executed a contract which established a private pension plan payable to Robert.

- 21. The "Contract of Employment Substitute Pension Plan," a private pension plan, included the Termination Payments. (Obj. Exh., p. 51).
- 22. Under their private agreement, Robert was the beneficiary of the five (5) year pay-out of Termination Payments, even if the Decedent died prior to the completion of those payments.
- 23. State Farm calculated the Termination Payments based on a number of factors.
- 24. State Farm ultimately calculated the Termination Payments due as \$89,067.00.
- 25. Robert received this payment as a lump sum several months after Decedent died

The "Loan"

- 26. In a communication of Robert to the Decedent twenty (20) years ago (2001), reference is made to a \$147,000.00 "loan."
- 27. The monies referenced, however, were not considered an actual loan by Decedent.
- 28. The monies were similar to other "loans" the Decedent made during his life to both Robert and Stephen.
- 29. None of these "loans" were expected by the Decedent to be repaid by either son.

The Family Relationships

- 30. Robert worked alongside Decedent for the better part of forty (40) years.
- 31. Robert was in daily communication with the Decedent, in person or by phone, for all that time.
- 32. His care grew more than ever after the passing of Decedent's wife in 2012.
- 33. Decedent sold his family residence on Country Club Drive in March 2013, after his wife passed away, and moved to Freedom Village.
- 34. Part of the net proceeds from the home sale were used to finance his move to, and residency at, Freedom Village.
- 35. Robert lived only a mile away from Freedom Village. He and Decedent would have breakfast, lunch or dinner together multiple times weekly.
 - 36. Decedent routinely gave Robert instructions concerning finances.
- 37. Following a stroke in 2013, Robert spent practically every day caring for his father and advocating his needs with Freedom Village Skilled Care.
 - 38. The contrast to Stephen's interaction with Decedent could not be greater.
- 39. There was brief testimony that Stephen "wasn't there when they needed him" that Stephen was "not around" for his parents.
- 40. There is no question that the Decedent preferred one son, Robert, over the other, Stephen.

The Estate Administration

- 41. Both prior and subsequent to his accounting, Robert provided his brother, Stephen, or his counsel, with voluminous documentation and other information fully describing his actions on behalf of their father, both in the State Farm Insurance Agency and as Executor.
- 42. The Executor's Accounting includes the Decedent's interest in a jointly held Wells Fargo checking account in the gross amount of \$4,623.00, the Decedent's portion of which, as stated on pages 3 and 5 of the Accounting, is \$2,311.00. This is the same amount disclosed by the Executor on Schedule F of the Estate's Inheritance Tax Return.
- 43. During the hearing, Robert noted that he needed to (1) supplement the Inheritance Tax Return in respect to the \$89,890 payment, and (2) amend Schedule F to the business checking account ending in 4673.

CONCLUSIONS OF LAW

- 1. The questioned \$147,000 "loan" was a gift to Robert from Decedent.
- 2. Under Article SECOND, paragraphs 1 and 2 of the Will, Decedent's business interests were bequeathed to Robert.
- 3. Robert is the named beneficiary in the business contract dated May 1, 2001.
- 4. The Termination Payments were payable contractually to Robert and were not probate assets.
- 5. The referenced 70% / 30% split in the Will pertained to any probate assets remaining in the Estate.
- 6. Even if the Termination Payments were a probate asset, the assets would ultimately pass 100% to Robert to whom specifically bequeathed under Article SECOND, paragraphs 1 and 2; Stephen's share would be 0%.
 - 7. The estate consisted solely of non-probate assets.
- 8. The Executor has provided an accurate and complete Accounting of his administration, and also as Agent of the Decedent from 2012 to the date of the Decedent's death in May of 2016.
- 9. The Executor's Account is otherwise accurate, complete, and consistent with the Estate Probate and Fiduciary's Code, and as otherwise may be required by Pennsylvania Law. (Pa.O.C.Rule 2.1; 2.4).
- 10. Stephen failed to raise an objection regarding attorneys' fees as part of his filed Objections. He has thus waived such an objection.
- 11. Even if the issue of attorney's fees had not been waived, Stephen failed to present any evidence or demonstrate at the hearing that such fees were unreasonable.
- 12. Although referenced in one-paragraph of his post-hearing briefing, the submission is not evidence of record.

- 13. Stephen's averments and allegations concerning inappropriate or unlawful actions of Robert during his tenure as an employee of his father's State Farm Agency, as Agent under his father's Power of Attorney, or as Executor of his father's estate, are baseless, and unfounded.
- 14. Stephen otherwise failed to present any credible evidence to support a surcharge.
- 15. Prior and subsequent to the Decedent's death, Robert took no action as an Agent under Decedent's Power of Attorney to deplete Stephen's assets or any beneficial interest in the estate.
- 16. Stephen failed to present any credible evidence necessary to establish the existence of any coercion.
- 17. Furthermore, this is not a will contest; no appeal from the Register's order was ever filed. Objector's reference to a lack of testamentary capacity or undue influence is irrelevant.
 - 18. Robert shall amend the inheritance tax returns as indicated.
 - 19. The Account will be adjudicated by the court under a separate order.
