## Commonwealth v. Benjamin Qaadir Morgan-Gibbs, Jr.

Pre-trial motion - Suppression - Probable cause - Odor of marijuana

- 1. The probable cause necessary for a warrantless search of a vehicle is the same as the probable cause required when seeking a warrant.
- 2. A determination of probable cause requires only that the totality of the circumstances demonstrates a fair probability that contraband or evidence of a crime will be found in a particular place.
- 3. Due to passage of the Medical Marijuana Act, there is a growing possibility that the odor of marijuana may not be evidence of a crime. Thus, odor of marijuana alone is no longer sufficient to support a finding of probable cause, but is one of the factors to weigh in a totality of the circumstances analysis.
- 4. The Commonwealth has the burden to show sufficient probable cause exists prior to searching a Defendant's vehicle.
- 5. Probable cause exists where the facts and circumstances within the affiant's knowledge and of which he has reasonably trustworthy information are sufficient in themselves to warrant a man of reasonable caution in the belief that a search should be conducted.
- The officer testified he had undergone training on recognizing "deceptive 6. behavior" by suspects. The officer observed a violation of the vehicle code and stopped Defendant's vehicle. The officer noted the odor of marijuana coming from the vehicle, requested Defendant to exit the vehicle and requested consent to search the vehicle. Defendant declined the request to search the vehicle. The officer testified the Defendant acted nervous, breathed heavily and paced. According to the officer, Defendant challenged the stop, lied about the traffic violation and looked back when asked if there was anything illegal in the car. This combination, according to the officer, indicated deceptive cues evidencing criminal activity and supporting probable cause to search. Additionally, the officer noted Defendant offered no explanation of the odor of marijuana other than to say he had not driven the car that morning. The Defendant also observed the progress of the search and fled when the firearm was discovered. The Court noted there was probable cause to stop the car for the traffic violation but the Court disagreed the officer had sufficient probable cause to make a warrantless search of the vehicle. Defendant filed a Pre-Trial Motion seeking suppression of evidence. The Court Held the Motion was granted and the firearm was suppressed.

## O R D E R

AND NOW, this 17th day of November 2020, upon consideration of Defendant's "Second Amended Omnibus Pre-Trial Motion" seeking suppression of evidence and a hearing, it is hereby ORDERED that Defendant's request for suppression of the firearm found in Defendant's vehicle is GRANTED.<sup>1</sup>

- 1. City of Coatesville Police Officer Jared Davis has been a full time patrol officer for six years. He has worked in law enforcement for a total of nine years. He testified that he has made approximately 10 arrests every month while on patrol in Coatesville. He has also undergone training on recognizing "deceptive behavior" when interacting with individuals suspected of criminal behavior.
- 2. On May 31, 2020, he was working with and training a new officer, Officer Alexander Ortiz. While on patrol in a marked patrol vehicle at the intersection of South 3rd Street and Lincoln Drive, Coates-ville, Chester County, he observed a vehicle coming the opposite direction and failing to yield the right of way to the vehicle in front of the patrol car. The officers followed the vehicle and immediately initiated a traffic stop. See CW's Exh. 1(B), MVR Video, 00min.00sec. 01min.12sec.
- Officer Ortiz approached the driver's side and the only occupant in the vehicle, Defendant. Officer Ortiz requested identification and registration, and told Defendant the reasons for the traffic stop. Defendant cooperated by supplying the requested documentation. See CW's Exh. 1(A), MVR Video, 00min.00sec. – 05min.00 sec.
- 4. The officers returned to their vehicle and discussed the presence of the odor of marijuana coming from the vehicle and again approached Defendant and requested he exit the vehicle. They requested

consent to search the vehicle and Defendant declined their request.

- 5. Officer Davis testified that, in addition to the odor of marijuana in the car, he observed Defendant act nervously, breath heavily, and begin to pace. Defendant challenged the stop, lied about the car waving him through when the car had to brake in order to avoid a collision, and looked back when asked if there was anything illegal in the car. Everything that Officer Davis observed was in his opinion deceptive non-verbal cues evidencing criminal activity and supporting a finding of probable cause to search.
- 6. Defendant offered no explanation as to the reason there was an odor of marijuana in his car. He simply stated that he did not drive his car that morning.
- 7. Officer Davis testified that he observed Defendant keep an eye on the progress of the car search and when Officer Ortiz discovered the firearm Defendant fled.

#### DISCUSSION

#### A. Traffic Stop - Probable Cause

Officer Davis testified that he and Officer Ortiz initiated a traffic stop after they observed Defendant fail to yield to oncoming traffic with the right-of-way in violation of the Motor Vehicle Code (75 Pa.C.S.A. §3322) (Vehicle Turning Left). We find this testimony credible and corroborated by the video showing the vehicle in front of the patrol car braking when Defendant made his left turn. We find the Commonwealth has met its burden to show sufficient probable cause to initiate a traffic stop. *See Commonwealth v. Johnson*, 202 A.3d 125 (Pa.Super. 2019) (*en banc*), *citing Brigham City, Utah v. Stuart*, 126 S. Ct. 1943 (U.S. 2006), and *Maryland v. Macon*, 472 U.S. 463, 105 S. Ct. 2778, 86 L. Ed. 2d 370 (U.S. 1985).

#### B. Vehicle Search - Probable Cause

In *Commonwealth v. Gary*, 91 A.3d 102, 138 (Pa. 2014) (plurality), the Pennsylvania Supreme Court determined that our state constitution does not afford greater protections than the 4th Amendment for a warrantless vehicle search. The *Gary* court also confirmed that:

[t]he prerequisite for a warrantless search of a motor vehicle is probable cause to search; no exigency beyond the inherent mobility of a motor vehicle is required. The consistent and firm requirement for probable cause is a strong and sufficient safeguard against illegal searches of motor vehicles, whose inherent mobility and the endless factual circumstances that such mobility engenders constitute a *per se* exigency allowing police officers to make the determination of probable cause in the first instance in the field. *Id*.

The probable cause necessary for a warrantless search of a vehicle is the same as that required when seeking a warrant.

Probable cause does not demand the certainty ... associate[d] with formal trials. Rather, a determination of probable cause requires only that the totality of the circumstances demonstrates a fair probability that contraband or evidence of a crime will be found in a particular place.

*Commonwealth v. Manuel*, 194 A.3d 1076, 1081 (Pa.Super. 2018) (*en banc*) (quoting *Commonwealth v. Otterson*, 947 A.2d 1239, 1244 (Pa.Super. 2008).

Prior to the passage of the Medical Marijuana Act ("MMA"), 35 P.S. § 10231.101 *et seq.* legalizing the medical use of marijuana, the courts in Pennsylvania held that the odor of marijuana alone established sufficient probable cause to search a vehicle without first obtaining a warrant. *See Commonwealth v. Stoner*, 344 A.2d 633, 635 (Pa.Super. 1975) (*citing United States v. Ventresca*, 380

U.S. 102 (1965). Due to the growing possibility that the odor of marijuana may not be evidence of a crime, odor alone is no longer sufficient to support a finding of probable cause. The odor of marijuana is one of the factors to weigh in a totality of the circumstances analysis. *Commonwealth v. Barr*, --- A.3d ----, 2020 WL 5742680 (Pa.Super. 09/25/2020).

It is the Commonwealth's burden to show sufficient probable cause existed prior to the search of Defendant's vehicle. Officer Davis testified to certain clues or "deceptive indicators" that he found to be concerning. He opined that all the indicators he observed establishes sufficient probable cause to make a warrantless search of the vehicle. We disagree.

"[P]robable cause exists where the facts and circumstances within the affiant's knowledge and of which he has reasonably trustworthy information are sufficient in themselves to warrant a man of reasonable caution in the belief that a search should be conducted." *Commonwealth v. Leed*, 646 Pa. 602, 186 A.3d 405 (2018). The Commonwealth argues that the deceptive factors recognized by Officer Davis are sufficient to meet that burden. The factors recognized by Officer Davis were the following:

- 1. Defendant challenged the stop.
- 2. Defendant acted nervous and was breathing heavy.
- 3. Defendant claimed the other driver waved him to go, an untruth.
- 4. Defendant brought his wallet and phone when exiting the vehicle.
- 5. Defendant was pacing outside the vehicle during questioning.
- 6. Defendant looked back at vehicle when asked if anything illegal was in the vehicle.
- 7. Defendant stated he just wanted to go home.

After reviewing the video produced by the Commonwealth from Officer Ortiz's body camera, we do not agree with the officer's characterizations of Defendant's behavior. Prior to the recently decided *Barr* case, the officer's would have had probable cause for the search based on the presence of the odor of marijuana in the vehicle. However, considering the totality of the circumstances pursuant to *Barr*, we do not find any of the other circumstances of the stop or Defendant's behavior establish probable cause for the warrantless search of Defendant's vehicle.
