OBITER DICTUM

From the ABA Journal Daily Newsletter: [1] According to a motion filed by the Iowa Supreme Court Attorney Disciplinary Board, a suspended Iowa lawyer cited at least one hallucinated case likely generated by artificial intelligence in his bid to return to law practice. Court filings by suspended Des Moine lawyer Royce David Turner include "what appears to be at least one AI-generated citation to a case that does not exist or does not stand for the proposition asserted in the filings. Turner cited the "imaginary case" In Re: Mears, in a July 5th brief supporting his application for reinstatement, and in two other court filings, according to a motion to strike the filings. The Iowa Supreme Court suspended Turner in 2018 and conditioned reinstatement on Turner providing an evaluation by a licensed mental health professional on his fitness to practice law as well as proof that he paid nearly \$8,000.00 in client refunds, fines and court costs. The state Supreme Court said he violated disciplinary rules through neglect, trust account violations and failure to provide competent representation and bankruptcy proceedings. [2] If you are unsure about how and when to cite content generated by artificial intelligence, a new citation rule is unlikely to clear up the confusion. The 22nd Edition of the Blue Book: A Uniform System of Citation, released in May, includes a new rule 18.3 for citing output from generative AI. Critics argue that the new rule "is fundamentally flawed in both conception and execution." Critics include Susan Tanner, a professor at the University of Louisville's Louis D. Brandeis School of Law, who called the new rule "bonkers." The rule requires that authors cite output from generative AI, such as Chat GPT, conversations or Google Search save a screen shot of that output as a pdf. The rule has three sections - for large language models, search results and AI generated content - and has slightly differing citation rules for each. One problem, Tanner said, is that the rule treats AI as a citable authority rather than a research tool. "What would a sensible approach to AI citation look like?" Tanner wrote: "First, recognize in 99% of cases, we shouldn't be citing AI at all. We should cite the verified sources AI helped us find." Other News: House Bill 414, the Uniform Deployed Parents Custody and Visitation Act, has passed the Pennsylvania House of Representatives and Pennsylvania Senate. The bill protects the child custody and visitation rights of service members by preventing any permanent custody changes while on deployment for no longer than 30 days. The bill passed with unanimous support and now awaits Governor Shapiro's signature.
