ber 24, 2019. The purpose of the Or-  
dinance was to approve the Articles of  
Incorporation of the Newville Borough  
Economic Development Authority.

1. The name of the Authority is  
the:

**NEWVILLE BOROUGH ECONOMIC  
DEVELOPMENT AUTHORITY**  
and its registered office is located at:  
4 West Street, Newville, Pennsylvania  
17241.

2. The Articles of Incorporation  
are being filed pursuant to the Mun-  
icipal Authorities Act, 53 Pa. C.S.  
Section 5601 et seq.

3. The Articles of Incorporation  
established the Authority's principal  
office at the Newville Borough Office,  
with the address as noted above.

4. The Authority's purpose is to  
finance working capital, acquire,  
hold, construct, improve, maintain,  
operate, own and lease either in the  
capacity of Lessor or Lessee projects  
to make business and economic im-

provements within the Borough and to provide and/or assist in providing administrative services, including but not limited to projects to retain or develop existing industries and businesses, and the development of new business and industries, the development and administration of business improvements and administration of services thereto, as defined in Section 5607(a)(17) of the Act; and for the purposes set forth in Sections 5607(a)(1), (2), (3), (4), (13) and (16) of the Act and powers in Section 5607(d) of the Act; and for such other purposes for which an authority may be formed or may exist under the laws of the Commonwealth. Further, the Authority shall have all powers conferred upon it by the Act and all other applicable laws of the Commonwealth.

5. The term of existence of the Authority shall be fifty (50) years from the date of, or approval of the Articles of Incorporation by the Secretary of the Commonwealth of Pennsylvania.

6. The Borough Council has retained the right to approve any plan of the Authority.

7. The Articles of Incorporation will be filed with the Secretary of the Commonwealth on May 28, 2020.
