

# **OPINION**

Plaintiff filed a Complaint on April 14, 2009, alleging that Plaintiff furnished credit to Defendant by means of a credit card. Defendant then filed Preliminary Objections on May 7, 2009, and a Brief in Support of Preliminary Objections on May 18, 2009. In response to Defendant's Preliminary Objections, Plaintiff filed an Answer to Preliminary Objections, but failed to file a Brief in Opposition to Defendant's Preliminary Objections. Pursuant to an Order dated June 19, 2010, Defendant's Preliminary Objections were sustained and Plaintiff's case was dismissed without prejudice.

On September 24, 2009, Plaintiff filed an Amended Complaint alleging that Defendant requested and obtained a credit account from Plaintiff. Plaintiff further alleges that Defendant used said credit card and made payments beginning on or about October 2007. Plaintiff also alleges that Defendant last made payment on or about January 2008. Plaintiff claims relief based upon an account stated theory of recovery for the sum of \$15,550.62, the amount listed in Exhibit A, which Defendant has allegedly failed to pay.

On May 24, 2010, Plaintiff filed a Praecipe for Entry of Judgment By Default for Failure to Plead. On May 28, 2010, Defendant filed a Motion to Strike Judgment, and on June 22, 2010, Defendant's Motion to Strike Judgment was granted, directing Defendant to file an appropriate pleading to the Amended Complaint within 20 days.

Defendant filed Preliminary Objections to Plaintiff's Amended Complaint on July 2, 2010 and a Brief in Support of its Preliminary Objections on July 9, 2010. Defendant argues that the Amended Complaint fails to conform to law or rule of court and that the Amended Complaint fails for insufficient specificity of a pleading. First, Defendant argues based on the amount allegedly due, \$15,550.62, that the initial credit card would have been furnished pursuant to a written agreement, and Plaintiff failed to attach written agreement between the parties, as required by Pa. R. Civ. P. 1019(i). Defendant also argues the Complaint is deficient because it does not contain allegations of sufficient specificity to meet the requirements of Pa. R. Civ. P. 1019(a). Specifically, Defendant argues that Plaintiff provided no confirmation that Defendant ever requested or applied for the credit card account, and that Plaintiff failed to attach a credit application signed by Defendant. Plaintiff also alleges that there is no indication that Defendant is the person who activated the credit card or how and when the credit card was activated.

On July 19, 2010, Plaintiff filed an Answer to Defendant's Preliminary Objections and a Motion to Strike Defendant's Preliminary Objections. Defendant filed a Response to Plaintiff's Answer to Preliminary Objections and Motion to Strike Preliminary Objections on July 29, 2010. Pursuant to an Order dated August 4, 2010, Plaintiff's Motion to Strike Preliminary Objections was denied, and Plaintiff was directed to file a Response and Brief in Opposition to Preliminary Objections within 10 days of said Order. Plaintiff filed an answer to Defendant's Preliminary Objections and Brief in Opposition to Defendant's Preliminary Objections on August 16, 2010. For the reasons stated below, Defendant's Preliminary Objections are granted in part and denied in part.

It is well established that in ruling on preliminary objections, the Court must accept as true all well-pleaded allegations of material fact as well as all inferences reasonably deducible from those facts. *Ballroom, LLC v. Commonwealth*, 984 A.2d 582, 586 (Pa. Cmwlth. 2009). Preliminary objections will be sustained only where the case is clear and free from doubt. *Rambo v. Greene*, 906 A.2d 1232, 1235 (Pa. Super. 2006).

An account stated is an "account in writing, examined and accepted by both parties, which acceptance need not be expressly so, but

may be implied from the circumstances." Robbins v. Weinstein, 17 A.2d 629, 634 (Pa. Super. 1941). To plead a cause of action for an account stated, plaintiff must sufficiently plead the following elements: (1) there has been a running account, (2) a balance remains due, (3) the account has been rendered upon the defendant, and (4) the defendant has assented to the account. Rush's Service Center, Inc. v. Genareo, 10 Pa. D. & C. 4th 445 (C.P. Lawr. June 24, 1991). Retention without objection by one party for an unreasonably long time of a statement of account rendered by the other party is a manifestation of assent to the amount shown as an accurate computation of the amount due. Donahue v. City of Philadelphia, 41 A.2d 879 (Pa. Super. 1945). A copy of the current statement must be attached to the Complaint showing a balance remains due, and the Complaint must state that the plaintiff mailed monthly statements to the defendant setting forth the details of the defendant's account. Citibank (S.D.) N.A. v. King, No. 2007-3412, 2007 WL 4967502 (C.P. Cent. Nov. 9, 2007).

In the present case, Defendant's argument regarding Plaintiff's failure to attach a written agreement pursuant to Pa. R. Civ. P. 1019(i) would be persuasive had Plaintiff pled a cause of action based on breach of contract. However, Plaintiff has set forth a cause of action based on an account stated theory of recovery, and based on that cause of action a written agreement need not be attached to the complaint. Therefore, Defendant's Preliminary Objection based on failure of a pleading to conform to law or rule of court is overruled.

Although Plaintiff sets forth a cause of action based on an account theory of recovery, Plaintiff has not pled facts sufficient to establish an account theory of recovery. Plaintiff alleges in its Amended Complaint that Defendant requested and obtained a Credit Account from Plaintiff, identified as account number 5424180793677110, that Plaintiff used such account and made payments, that Defendant last made payment on or about January 2008, and that the Defendant's balance is currently at \$15,550.62. To substantiate these claims, Plaintiff attached copies of several statements to its Amended Complaint that show numerous purchases and charges on account number 5424180806969116, allegedly made by Defendant during the period of November 27, 2007 through April 24, 2008. Plaintiff also attached a copy of a current statement of account number

5424180793677110, indicating a balance of \$15,550.62 as of May 26, 2009. However, Plaintiff's Amended Complaint fails to indicate whether Plaintiff mailed these monthly statements to Defendant setting forth the details of Defendant's account, which is crucial in a cause of action based on an account theory of recovery. Even more problematic is the fact that the statements attached by Plaintiff show two different account numbers, thus making it unclear which account is the basis for Plaintiff's cause of action. Therefore, Defendant's Preliminary Objection based on insufficient specificity in a pleading is sustained.

For the reasons stated herein, Defendant's Preliminary Objections are granted in part and denied in part.

# **ORDER**

AND NOW, this 29 day of September, 2010, Defendant's Preliminary Objections are granted in part and denied in part. Defendant's Preliminary Objection based on failure of a pleading to conform to law or rule of court is overruled. Defendant's Preliminary Objection based on insufficient specificity in a pleading is sustained. Plaintiff's Amended Complaint is hereby dismissed without prejudice. Plaintiff is granted twenty (20) days to file a Second Amended Complaint.
