**OPINION** 

Wagner, P.J.

February 7, 2022

Before the Court is the Statement of Matters Complained of on Appeal filed by the Appellant, Trey Zachery Holmes, after a trial held in absentia on May 4, 2021. At the trial, the Appellant was convicted of Possession of a Firearm Prohibited, Flight to Avoid Apprehension, Firearms Not to be Carried Without a License, Possession of a Controlled Substance, Possession of Paraphernalia, Tamper with Physical Evidence, Resisting Arrest, False Identification to Law Enforcement Officer, Disorderly Conduct and Driving Under Suspension-DUI related. Count 11 for Receiving Stolen Property was nolle prossed at the time of trial. On July 12, 2021, the Appellant was sentenced to seven (7) to fourteen (14) years incarceration at the charge of Possession of a Firearm Prohibited with an additional sentence of sixty (60) days confinement on the Driving Under Suspension-DUI related charge.

#### STATEMENT OF MATTERS COMPLAINED OF ON APPEAL

1. The trial court should not have proceeded with a trial in absentia.

#### FACTS OF THE CASE\*

Pursuant to the testimony presented at the time of the preliminary hearing, Trooper Adam Kezmarsky testified that on February 4, 2019, he had observed the Appellant and another person in a rental vehicle traveling in the opposite direction. (N.T. of 2/25/19 at pg. 3). The occupants of the vehicle "locked eyes" on the Trooper as he passed their vehicle. Id. The Trooper saw the vehicle parked in an alley with both occupants sitting in the vehicle. The Trooper stopped behind the vehicle without using his lights or siren. The passenger immediately left the vehicle rushed into a nearby residence. (N.T. at pg. 4). The driver started to exit the vehicle as the Trooper approached. The Trooper smelled a strong odor of marijuana emanating from the vehicle. Id. When asked for identification, the driver gave the name Devonte Lauderaugh, stated he did not have any identification on him, and could not give the Trooper his date of birth. Id. The Trooper observed dryer sheets in the air vents and black rubber bands in the front of the vehicle.

The Trooper testified that from his training and experience the rubber bands were used to secure stamp bags. (N.T. at pf. 6). The Trooper instructed him not to leave the scene and attempted to detain him.

The driver shoved the Trooper and took off running. The Trooper followed and ordered him to stop that he was under arrest. When the driver continued to flee the scene, the Trooper deployed his taser which stopped him. The driver refused to stand or willingly return to the State Police vehicle. (N.T. at pg. 7). After other officers arrived, the Trooper located the driver's identification and it identified him as the Appellant. (N.T. at pg. 8).

The Trooper located a loaded nine millimeter handgun in the Appellant's hoodie. Id. The Trooper determined that the Appellant was a person not to possess a firearm due to a prior felony conviction which also made him ineligible to obtain a license to carry a firearm. (N.T. at pg.9). After a search of the vehicle, the dryer sheets, rubber bands were noted but not removed from the vehicle. Id. At the State Police barracks, a search of the Appellant located cocaine all over the floor and further search located a baggie in Appellant's underwear of what was later determined to be cocaine. (N.T. at pg. 10).

Further investigation revealed that the nine millimeter gun had been reported stolen in 2016 (N.T. at pg. 11).

\*The facts of the case are based on the testimony presented at the Preliminary Hearing which was held on February 25. 2019 before the Honorable District Judge Richard Kasunic. Appellant's counsel, although indicating that a transcript had been requested on his Notice of Appeal, failed to request a transcript of the trial. The Court's law clerk contacted counsel to inform him that no transcript had been ordered several weeks prior to the date the record was to be sent to the Superior Court. No transcript was ordered.

#### PROCEDURAL ISSUES

On February 4, 2019, the Appellant was arrested on the above listed charges. On February 25, 2019, the charges were bound over to court after the preliminary hearing. An Omnibus Pretrial Motion was filed and denied on September 19, 2019. The Appellant continued his trial on October 8, 2019 until the January, 2020 trial term that ended on January 10, 2020. On February 4, 2020, the Honorable Joseph M. George, Jr. declared the defense unavailable for trial. Bond was posted on March 23, 2020. On November 30, 2020, the Appellant failed to appear for a Pre-Trial Conference, the Appellant's case was then listed for trial. At least three notices to appear for trial were sent to the Appellant at his listed address in Monessen, Pennsylvania. The Court recalls that at the time of trial, counsel for the Appellant, had no information as to why the Appellant failed to appear and that he might have an outstanding bench warrant.

On May 4-5, 2021, the Court determined that it was appropriate for the trial to proceed without the presence of the Appellant. After, the Appellant was convicted often of the eleven charges, sentencing was set for May 25, 2021. When the Appellant failed to appear for sentencing, a bench warrant was issued for the arrest of the Appellant. On July 8, 2021, the Appellant was apprehended and the warrant was lifted on July 12, 2021, when the Appellant was sentenced.

On July 21, 2021, current appellate counsel entered his appearance on behalf of the Appellant. On July 22, 2021, counsel filed with the Clerk of Courts a Post-Sentence Motion and Request for Hearing Thereon. Counsel failed to follow Fayette County Rules and the Post Sentence Motion was not presented for the Court's consideration. On December 6, 2021, Appellant's counsel filed a Notice of Appeal to the Superior Court asserting that the Appellant's judgment of sentence became final, by operation of law on November 20, 2021 as the Court did not decide the post sentence motion within 120 days. The statement that "A transcript has been ordered." was included in the Notice, but no such request was ever made by Appellant's counsel.

#### DISCUSSION

In order to provide a uniform means of presenting to the Court all matters which require action by the Court, "All applications for Court action, including motions, petitions, and any other applications shall be presented to the Court by following this Motions Court procedure." F.C.R. 575(b). The term motion includes every type of motion, petition or other application for action by the Court. F.C.R. 575(c). The moving party shall serve a copy of the original motion, a Certificate of Presentation, a Certificate of Service, including any attachments on the Court Administrator. F.C.R. 5750). Failure to comply with the information required by the Certificates of Presentation and Service may result in the matter not being listed by the Court Administrator for Motions Court.

If a post-sentence motion is filed, the notice of appeal must be filed within ten days after imposition of sentence. Pa.R.Crim.P. 720(A)(l). If a timely post-sentence motion is not filed, then the Notice of Appeal shall be filed within thirty days of imposition of sentence. Pa.R.Crim.P. 720 (A)(2)(a). If a post-sentence motion is not ruled on within one-hundred and twenty (120) days, the motion is deemed denied. Pa.R.Crim.P. 720(B) (3)(a).

In this case, the Post-Sentence Motion and Request for Hearing was timely filed but was not timely presented or ever presented correctly. As the filing did not conform to the local rules and procedures, the motion remained in the Clerk of Court's file but was not timely presented to the Court. The failure to comply with the local rules resulted in the Court never receiving notice that the inclusion of the motion in the Appellant's filed had even occurred. No contact was made about a time or date for a hearing. This Court had no opportunity to schedule a hearing or make any determination on the merits of the motion. As the filing of the motion failed to comply with both state and local rules, the post-sentence motion cannot be considered to be timely filed. Therefore, the appeal in this matter is untimely as it should have been filed within thirty (30) days of the date of imposition of sentence.

The Notice of Appeal to the Superior Court should include a request for transcript or a statement signed by counsel that either there is no verbatim record or the transcript has been lodged of record. Pa. R.A.P. 904(c) and 905(a)(l). To order a transcript for the trial, Appellant or his counsel makes a request on a standardized form and the form is presented to the Administrative Office of the Fayette County Courts. FCR 4007. The Administrative Office obtains an estimate of the cost for the transcript which is provided to the person making the request. Then a partial payment of the estimated cost of the transcript is forwarded to the Administrative Office. In this case, counsel avers that a

transcript was ordered. No request for a transcript was ever made nor were any funds presented. Therefore, no transcript has been prepared. While the Appellant is incarcerated, he is currently represented by privately retained counsel and no in forma pauperis has been filed.

An accused has a constitutional right pursuant to the Sixth Amendment of the United States Constitution and Article 1, § 9 of the Pennsylvania Constitution to be present at every stage of a criminal trial. The right to be present in the courtroom for trial is not absolute. Commonwealth v. Boyle, 447 A.2d 250 (Pa. 1992). A defendant may expressly or implicitly waive the right to be present at any stage of the trial. The defendant's absence without cause at the time scheduled for the start of trial or during trial shall not preclude proceeding with the trial, including the return of the verdict and the imposition of sentence. Pa.R.Crim.P. 602(A). A defendant who is absent without cause at the start of trial may be tried in absentia. Commonwealth v. Wilson, 712 A.2d 227 (Pa. 1998). A defendant's presence may be deemed waived by the defendant intentionally failing to appear at trial. A waiver of the right to be present must be knowing and voluntary. Id.

A defendant who is released on bail before trial gives the court his assurance that he will stand trial and submit to sentencing. Id. Unless the defendant is prevented from attending the proceedings for reasons beyond his control, then he is expected to be present at trial. The defendant has an affirmative duty to advise the court if he will be absent. Id. The defendant has the responsibility to keep the court, his attorney and his bondsman of his address.

In the current case, the Appellant bonded out on this and another case on March 23, 2020. A bench warrant was issued for the Appellant at the second case in November, 2020.

The Court has no clear recollection or notes as to the exact statements presented by defense counsel, who has also stated that he does not have a clear recollection as to what exactly was mentioned prior to or at trial. There was mention that the Appellant had an outstanding bench warrant at another case. (A bench warrant was issued on November 2, 2020 at Case No. 1348 of 2018). The Court recalls that the defense had no information as to why the Appellant failed to appear. The Court does have a clear recollection that no information was presented as to any cause or acceptable reason as to why the Appellant was not present for trial.

In his post-sentence motion, counsel asserts that the Appellant failed to appear because he was homeless and had no notice of the trial date. At the time of trial, the Appellant had an outstanding warrant for failure to appear at Case No. 1348 of 2018 which was entered on November 2, 2020.

The Appellant out on bail in the community has an affirmative duty to keep the court, his attorney and his bondsman of a good address where he can be located. With the warrant for failure to appear in his other pending case, the Appellant may not have been inclined to uphold his responsibility. However, he could have contacted at least his attorney on a periodic basis to obtain information about this case. Notices were sent to his residence address on at least three occasions providing him notice of his trial, they were not returned and the Appellant failed to provide any other address.

It is in the discretion of the court as to whether a trial should proceed in absentia. This Court in its discretion and based on the information at the time of trial determined that the Appellant's failure to appear was without cause. Defendant, by failing to notify the Court, his attorney or his bondsman or remain in contact with them, waived his right to be present at trial. There was no information that the Appellant would be available to appear in the near future.

After a review of the issue presented that the Court erred when it proceeded in absentia, the Court stands by its position that no just cause for the Defendant's absence was provided to the Court prior to trial. The Appellant's assertion that the Court erred in proceeding with his trial in absentia is without merit and his appeal should dismissed for this and the other reasons listed above.
