

License Suspension – Due Process

1. Royce Foltz, II filed an appeal from a Notice of Suspension issued by the Commonwealth of Pennsylvania, Department of Transportation, Bureau of Driver's Licensing.

2. The Court denied Royce's driver's license suspension appeal, reinstated the 12-month suspension assessed against him, and directed the Bureau to offset that suspension by providing 60 days' credit to this suspension.

ORDER AND OPINION DENYING APPEAL AND CREDITING TIME

AND NOW, this 17th day of February, 2021, the Court denies the appeal of Royce Foltz, II from his license suspension, reinstates the 12 month suspension required by statute, and directs the Bureau to apply 60 days' of credit to the suspension.

. PROCEDURAL HISTORY

On July 17, 2020 Royce Foltz, II (hereinafter "Royce") filed a timely appeal from a Notice of Suspension issued by the Commonwealth of Pennsylvania, Department of Transportation, Bureau of Driver's Licensing (hereinafter "the Bureau") dated June 19, 2020. According to the Notice, Royce's driver's license was to be suspended for a period of one year beginning July 24, 2020.

After several continuances, this Court heard Royce's appeal on January 27, 2021. At the conclusion of the hearing, the Court dismissed Royce's appeal, reinstated his 12 months suspension, and directed 60 days' of credit be applied to his 12 months suspension. The Bureau orally moved for reconsideration of the Court's Order with respect to the application of an offset or credit of 60 days. The Court granted the Bureau's request for reconsideration and provided coursel for the parties the opportunity to provide letter briefs in support of their respective positions. This matter is now ripe for determination.

FACTUAL HISTORY

Royce was charged with DUI, Highest Rate, 1st Offense with a violation date of February 12, 2017.¹ He was accepted into the ARD program for this alleged offense, and as a result was assessed a 60 day driver's license suspension. Royce's license suspension became effective June 26, 2018, and his driving privilege was restored August 25, 2018. Sometime thereafter, Royce was removed unsuccessfully from the ARD program.

On January 30, 2020 Royce was convicted of DUI, Highest Rate, 1st Offense. On June 11, 2020² the York County Clerk of Courts submitted a DL-21 to the Bureau certifying Royce's conviction. Thereafter, on June 19, 2020 the Bureau mailed Royce notice of a 12 month license suspension.

III. ANALYSIS

The Bureau argues Commonwealth, *Dep't of Transp. Bureau of Traffic Safety v. Yarbinitz*, 97 Pa. Commw. 169, 171, 508 A.2d 641, 642 (1986) and its progeny stand for the proposition that this Court can <u>never</u> examine a license suspension appeal beyond examining whether "the identity of the party whose license has been suspended has been established and [whether] the grounds for the suspension are found to be proper." Once that inquiry is complete, the Bureau argues, the Court's "inquiry has ended." This argument ignores additional language used in *Yarbinitz* and the Pennsylvania Supreme Court's recent decision in *Commonwealth v. Middaugh*, _____A.3d ___, 2021 PA Lexis 185 (2021). In *Yarbinitz*, the Commonwealth Court said, "If the person whose

In *Yarbinitz*, the Commonwealth Court said, "If the person whose license is suspended committed the offense, and if the offense is a valid basis for suspension and **no violation of due process has occurred**..." *Commonwealth, Dep't of Transp. Bureau of Traffic Safety v. Yarbinitz,* 97 Pa. Commw. 169, 171, 508 A.2d 641, 642 (1986)(emphasis added). Thus, this Court can, and should, ensure that a driver's right to due process has been protected. Likewise, in *Middaugh*, the Pennsylvania Supreme Court recognized that the statutory scheme of license suspension is not absolute, but subject to constitutional challenge. Thus, the Court reasoned, "although we have concluded that there is no statutory basis for relief, restrictions imposed by the Constitution can limit whether otherwise-valid legislation may be applied in specific circumstances." *Middaugh at 15.* Accordingly, it is clear this Court's review is not as limited as the Bureau suggests, but can properly extend to a determination of whether Royce has received all of his due process rights.

In determining that fundamental fairness was a due process right that applied to license suspension appeals, in Middaugh the Court reviewed a line of holding regarding fairness. Thus,

Relatedly, due process incorporates the concept that the government must treat individuals with basic fairness. See, e.g., N.C. *Dep't of Revenue v. The Kimberley Rice Kaestner 1992 Family Trust*, U.S. , , 139 S. Ct. 2213, 2219, 204 L. Ed. 2d 621 (2019) (explaining the Fourteenth Amendment's Due Process Clause is centrally concerned with the fundamental fairness of governmental activity); *Pennsylvania v. Finley*, 481 U.S. 551, 557, 107 S. Ct. 1990, 1994, 95 L. Ed. 2d 539 (1987) (referring to "the fundamental fairness mandated by the Due Process Clause"); *Rogers v. Tennessee*, 532 U.S. 451, 462, 121 S. Ct. 1693, 1700, 149 L. Ed. 2d 697 (2001). Like the requirement of a means-end correspondence, this fairness mandate is a facet of "substantive" due process. See *Perry v. New Hampshire*, 565 U.S. 228, 249, 132 S. Ct. 716, 730, 181 L. Ed. 2d 694 (2012) (Thomas, J., concurring) (citing cases). See generally Timothy Sandefur, In Defense of Substantive Due Process, or the Promise of Lawful Rule, 35 HARV. J. LAW & PUB. POL'Y 283, 307 (arguing that the "of law" portion of the phrase "due process of law" was historically understood to encompass a requirement that laws and their implementation must "accord basic fairness and equality" to all individuals).

Middaugh at 18-19.

Here, Royce served a 60 day suspension as a result of his acceptance into the ARD program. Royce completed that suspension without issue, and his license was reinstated prior to his removal from ARD. There is no dispute and the record clearly supports that the 60 day suspension Royce served as part of his ARD was for the same DUI offense that, after he was removed from ARD, he was convicted resulting in the 12 month suspension he now appeals.

Without a doubt, 75 Pa.C.S. § 3804(e)(1) directs the Bureau "shall" suspend Royce's license "upon receiving a certified record of the individual's conviction..." However, this mandate upon the Bureau here is the same as it was in *Middaugh*. Notwithstanding that mandate, in *Middaugh* the Supreme Court put aside the suspension requirement when it conflicted with the driver's due process right to fundamental fairness in the timing of the institution of the license suspension. Likewise, this Court now finds it would be a violation of Royce's due process right to fundamental fairness to impose the 12 month suspension without any credit or offset for the 60 day suspension he served while in the ARD program.

Section 3807(d) of the Motor Vehicle Code requires a license suspension "as a condition of participation" in ARD resulting from a DUI charge with a blood alcohol concentration of more than 0.10%. 75 *Pa.C.S.* § 3807(d). Notably, the statute does not require the suspension take place immediately upon placement into the ARD program. The records reveals, though, Royce's license was suspended upon his acceptance into the program. Further, section 3807(e) provides guidance as to

how to handle a participant's failure to successfully complete the ARD program. This subsection, however, does not address what, if anything, is to occur with the license suspension the driver has completed. Thus, the General Assembly has been silent on the issue before this Court.

The Bureau argues case precedent requires Royce to serve both sus-

pensions without offset or credit. We disagree. In Seig v. PennDOT, 550 A.2d 844 (Pa. Cmwlth. 1988), the driver sought credit for a suspension served under his first DUI charge against a second DUI charge, because he was ultimately acquitted of the first DUI. Seig is readily distinguishable from the present case on its facts. Royce seeks offset or credit from his ARD suspension against his conviction suspension for the exact same charge.

The Bureau also cites to Commonwealth v. Gretz, 114 Pa. Commw. 287, 292, 538 A.2d 976, 978 (1988) to support its argument. Initially, Gretz does not provide any different standard than that which was set forth in Yarbinitz, supra which was already addressed. While Gretz is factually similar to the instant case, some of the language used in its reasoning and quoted by the Bureau flies in the face of other long standing

case precedent regarding license suspensions. The *Gretz* court states, "The principle upon which ARD operates is that if the participant behaves, upon successful completion of the program, that person is spared the **punishment** provided by law for those not accepted into the program. Once a participant violates the program, however, that person returns to 'square one' for resentencing and, in this case, is subject to the civil penalty DOT is required by law to impose. Gretz at 292, 978 (emphasis added).

As recently as 2018, the Commonwealth Court has held, "the suspension of an individual's driving privilege has traditionally been considered a civil sanction as opposed to a criminal punishment." Factor v. DOT, Bureau of Driver Licensing, 199 A.3d 492, 501 (Pa. Cmwlth. 2018) (emphasis added). Thus, a license suspension is a civil sanction, regardless of whether it is a result of ARD or conviction, or otherwise. To now hold that a license suspension is part of the "punishment" to which a person agrees when they attempt completion of the ARD program would fly in the face of the long standing tradition that license suspensions are not punishment, but are a civil sanction. Thus, this Court cannot accept the dicta language of Gretz as controlling its review of this case

In reaching our holding, we note the expressed purpose of license suspensions. Thus, "the underlying policy objective [is] enhancing public safety by removing dangerous drivers from the roadways for a defined period of time after a predicate violation. The inconvenience and disruption stemming from a license suspension serves the same purpose by deterring drivers from repeating their dangerous conduct after privileges are restored." Middaugh at 13. Here, it is without dispute the General Assembly has determined the appropriate length of a license suspension for a DUI such as that for which Royce was convicted is 12 months. Thus, this Court denied Royce's appeal and reinstated his 12 month suspension as a result of his DUI conviction.

It is equally clear, though, that without relief Royce would be re-quired to serve a total of 14 months' suspension as a result of this single DUI conviction. Such a result would be an absurd interpretation of the statutory scheme, is not supported by the policy purpose of license suspensions, and would be fundamentally unfair to Royce.

Nothing about the statutory scheme which permits a driver to undergo a lesser suspension of his driver's license as part of the successful completion of ARD suggests that a driver who is not successful in completing ARD poses more of a risk to public safety, and therefore, should be subject to a longer suspension than a driver who does not even attempt ÅRD. Said differently, a driver convicted of DUI, such as Royce, who does not attempt ARD and is convicted faces a 12 month suspension and not longer. Again, this is the length of suspension the General Assembly concluded is sufficient to protect other drivers and deter future violations. The General Assembly likewise provided an incentive to drivers who successfully complete ARD, as they only face a 60 day license suspension. Nothing about this statutory scheme and further, nothing about the facts involved here, suggests Royce should face a total license suspension of 14 months because he did not successfully complete ARD. Quite the opposite, Royce's conviction for DUI requires a 12 months suspension and nothing more. To do anything else would be fundamentally unfair to Royce, and would thus violate his due process rights

Lastly, the Bureau argues Section 1516 of the MVC precludes this Court from assigning Royce's successful and completed 60 days suspension against his yet to be completed 12 month suspension. Specifically, it cites to the language of subsection (d), which states, "Any fully or partially served suspension or revocation time may only be reassigned or credited toward a suspension or revocation segment processed on the driver's record as of the actual commencement date of the fully or partially served suspension or revocation time." 75 Pa.C.S. § 1516(d). This section does not apply to the Court in reviewing license suspension appeals. It only applies to the Bureau or department as referenced in the statute. Subsection (d) speaks to drivers who wish to have the department update records the driver believes are incorrect. Thus, the immediate prior sentence to that cited by the Bureau begins, "In updating records, the department shall ... " Id (emphasis added). Accordingly, this section does not impact this Court's ability to provide credit or offset as required to meet due process requirements, such as the circumstances of Royce's suspension.

IV. CONCLUSION

Because it is this Court's duty to apply the statutory driver's license suspension requirements, while protecting the due process rights of drivers facing suspension, this Court denies Royce's driver's license suspension appeal, reinstates the 12 month suspension assessed against him, and directs the Bureau to offset that suspension by providing 60 days credit to this suspension.

LIFE AFTER LAW AND OTHER REFLECTIONS

My retirement from the practice of law was accompanied by a partial retirement from the active life I had known for many years. Forced by blindness in my right eye and a considerable loss of sight in the left. Prostate cancer therapy also has taken some of the wind out of my sails. I stay home most of the time - except for medical appointments. Happily, old Fieldstone, my home in southern York County for fifty-nine years, is a very pleasant place to hang out.

Before I could settle into a daily routine, I had to deal with the mess my assistant, on whom my limited vision had caused me to rely, had left. It revealed some \$17,000.00, in unrecorded checks, over and above her salary, written to herself or her home mortgage holder. And my CPA had to be engaged to prepare and file unfiled payroll tax forms.

Quite often, my day commences after 9:00 a.m., because my lengthy phone conversations with my Soul Mate, Gwen, out in Silicon Valley, sometimes do not end before 2 a.m. We unexpectedly reconnected about 17 months ago. Hopefully, she will come here in the summer so our lives can unfold. Gwen is the 'Gwen' of Gwendale. Sixty-five years ago this was a very nice, modest priced residential development built by her then father-in-law, R.S. Noonan.

On arising I usually have a 'cof of cuppie' and eat breakfast, while online. Daughter, Laura, who along with her S.O. lives with me, provided me with a large TV screen as a computer monitor, so I can enlarge print to become legible. I work on my modest investment portfolio, check emails, including my investment service, Seeking Alpha ("Alpha" is a greater than usual return - happily I receive 9%+), and scan the Times and the Post. I return to those pursuits later in the day.

I also write in two genres. Opinion pieces, which sometimes appear in local newspapers. And, I have a mostly unused blog. Also, Poems of Romance for Gwen.

Laura also provided me with a professional quality elliptical trainer, which is a God's send.

So . . . "I'm in pretty good shape, for the shape I am in."

As I am quite old - 94 years in the making - my life has coincided with the rapid acceleration of technology and the societal changes this phenomenon has wrought. From a time when people and their ideas tended to stay put. To travel to the other side of the world in less than a day and the profusion of

views - of everyone with something to say, who now can make themselves heard everywhere from anywhere.

From a body politic of a roughly common societal outlook, which encouraged tolerance and cooperation among its members and allowed forward progress. Where greater informality in dealings, including in the operation of the courts, was the way of things. To the present mélange, where diverse ethnic, religious, economic backgrounds collide. These cultural differences have transformed that relaxed, casual interaction into one of strict formality and legality - particularly in the courts and the structure of the law generally. And, to our great disadvantage, those holding conflicting political outlooks now seem bent on destroying one another, making joint action in sensible and necessary measures almost impossible. In turn, leaving us vulnerable to depredations by enemies, foreign and domestic.

For most of my lifetime, there has been an almost universal, patriotic appreciation of and thankfulness for the freedoms enjoyed by most Americans. Thousands of Americans died for it in WWII and the Korean War. Tragically, this sentiment has been depleted by a previously unthinkable, un-American anarchy and insurgency, on the part of a once flag-wavingly loyal, organized significant minority, who have sought to destroy the legal structure that has made possible a way of life, for most of us, of comfort and amenities unparalleled in human history.

African Americans were 'left out.' While there have been major strides forward, there is still a long way to go.

And then, into the present time, where the high tech that now permeates our lives is broken down into a seemingly infinitesimal number of discrete, interdependent functions. A failure of just one of these to perform in its programmed sequence, and none of the others can continue and the process halts. The importance of maintaining these essential routines has brought about ever-increasing governmental regulation. Unpopular generally and detested by those who are unwilling or unable to recognize our interdependence and its implications, these laws do provide work for lawyers who enforce them or assist those who are caught up in them. For regulators, the trick is to do no more than necessary.

My practice extended back to when lawyers usually either dictated to a secretary or wrote in long hand on a legal pad. Dictating machines were new and not in wide use. Electric typewriters were around, but the iconic, advanced IBM Electric had not yet appeared. Nor had copy machines. So, sheets of document paper, separated by sheets of carbon paper, were inserted in the typewriter to produce several copies. The inevitable typos resulted in a smudged product. Computerized document preparation and storage was still years in the future.

Like most others, real estate was originally an important part of my practice, which included actually searching the title, preparing the documents, and handling settlement. All functions subsequently taken over by commercial title insurance companies, though many lawyers now act as title company agents. Title company encroachment on our real estate practices had caused tremors in the profession, except in Philadelphia and Pittsburgh where the Bar had earlier ceded that function to the title companies.

Over the long haul, my practice was concentrated most heavily in Municipal Law, with emphasis on Zoning and Subdivision, as well as Wills and Estates. I served as Township Solicitor, Borough Solicitor, Zoning Hearing Board Solicitor, Municipality Authority Solicitor, Special Township Counsel and several times as landowner's counsel. The later capacity produced Anstine v York Township, 411 Pa. 33; 190 A2d 712; 1963 Pa LEXIS 474, where for the first time an appellate court struck down a zoning ordinance for unreasonable, arbitrary, and discriminatory treatment of mobile homes.

I was always a sole practitioner. New lawyers are well advised to avoid going it alone. Try to find others for whom you can have respect and endeavor to join with them. Avoid cheap shots. Do not forget, you have an obligation to conduct yourself so as to uphold the honor of your profession. So, be honest: to Judges, other lawyers, your clients, and the public - and most of all - to yourself. Do not emulate the relatively recent example set by a most highly placed lawyer who lied to the public about a very important matter on network TV. Try to be an excellent lawyer - not the cheapest. And remember, if your client is a son-of-a-bitch, he's YOUR son-of-a-bitch!




