

NOTICE

NOTICE IS GIVEN that the Board of County Commissioners of Adams County, Pennsylvania (the "County"), enacted an Ordinance on June 1, 2016 signifying its intention to incorporate a municipality authority under the Municipality Authorities Act, as amended (the "Authorities Act, as arended the "Authorities Act"), of the Commonwealth, and that Articles of Incorporation will be filed with the Secretary of the Commonwealth of Pennsylvania on or before June 22, 2016

Attached to the Ordinance is a copy of the Articles of Incorporation, which includes the following: (1) the name of the Authority which shall be the "Adams County General Authority"; (2) a statement that the Authority is formed under the Authorities Act for the purposes of undertaking the projects set forth below; (3) the permitted projects of the Authority within the geographic confines of Adams County, Pennsylvania, that include the power to (a) acquire, hold, construct, finance, improve, maintain and operate, own and lease, either in the capacity of lessor or lessee, buildings to be devoted wholly or partially for public uses, including public school buildings, and facilities for the conduct of judicial proceedings, (b) finance public buildings, (c) finance hospitals and health care facilities, (d) finance certain educational facilities, (e) finance parks, recreation grounds and facilities, (f) finance industrial development projects, including, but not limited to projects to retain or develop existing industries and the development of new industries, the development and administration of business improvements and administrative services related thereto, and (g) other projects as set forth in the Articles of Incorporation; (4) a statement regarding compensation of members of the Board of the Authority; (5) a list of any other municipality authorities previously incorporated by the County under the Authorities Act, and earlier legislation; (6) the name of the incorporating municipality, which is the County; (7) a list of the names, addresses and offices of the Board of County Commissioners of the County; (8) the number of Board members established at 5; (9) a list of the names, addresses and initial terms of office of the first members of the Board of the Authority; and (10) the term of existence set at 50 years.
