Cover your coughs and sneezes with a tissue, or cough into your elbow, not your hand.

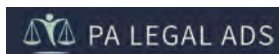

PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE  
PIKE COUNTY SENTENCING INFORMATION

---

*June 1, 2020* — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Aleksandr Grigorev, age 47, of Dingmans Ferry, PA, was sentenced to 54 months to 192 months in a state correctional facility, followed by 36 months of probation and fined \$2,500.00 for the crimes of Aggravated Indecent Assault, and 2 counts of Corruption of Minors. Grigorev was determined to be a Tier III sexual violent predator following a hearing and will be required to register with the Commonwealth of Pennsylvania in accordance with Megan's Law as a sexual offender for the remainder of his life. Between April of 2005 and April of 2011, at a residence in Delaware Township, Grigoryev penetrated the genitals and engaged in sexual activity with an individual under the age of 13 years.

Cody Hamm, age 31, of Prompton, PA, was sentenced to 4 months to 8 months in the Pike County Jail and fined \$300.00 for the crime of Unauthorized Use of a Motor Vehicle. Hamm took a vehicle from a residence in Shohola on July 2, 2018, without the owner's permission.

Zachary Ray Simmons, age 22, of East Stroudsburg, PA, was sentenced to 6 months of probation and fined \$300.00 for the crime of Driving Under the Influence. State police were dispatched to Woodbridge Road in Lehman Township where Simmons had driven his vehicle into a ditch. The faint odor of alcohol, bloodshot eyes and the admission to drinking prior to driving resulted in Field Sobriety Tests which showed impairment and a breath test confirmed a blood alcohol content of .90%.

Christopher David Pannella, age 26, of Franklin, NJ, was sentenced to 12 months of probation, fined \$500.00 and a driver's license suspension for a duration to be determined by PennDOT, for the crime of Fleeing or Attempting to Elude a Police Officer. Pannella failed to pull his motorcycle over when authorized to do so by an officer of the Eastern Pike Regional Police Department on July 13, 2019, along Route 6 & 209 in Westfall Township.

Ernest A. Strunck, age 65, of Milford, PA, was sentenced to 11 1/2 months to 23 1/2 months in the Pike County Jail and fined \$500.00 for the crime of Burglary. Strunck broke into a commercial building located along Route 6 & 209 in Milford Township on May 24, 2019, and took various items without the permission of the property owner.

Sergey Smirnov, age 33, of Bushkill, PA, was sentenced to 6 months to 23 1/2 months in the Pike County Jail, followed by 12 months of probation and fined \$1,500.00 for the crime of Possession with Intent to Manufacture or Deliver a Controlled or

Counterfeit Substance. The state police responded to a residence in Lehman Township for a report of a burglary and erratic behavior of the resident on December 16, 2018. Smirnov was found in possession of Psilocybin mushrooms and Psilocyn.

Travis Walter Corter, age 25, of Dingmans Ferry, PA, was sentenced to 1 month to 4 months in the Pike County Jail and fined \$300.00 for the crime of Possession of a Controlled Substance to run consecutive with his prior conviction of Possession of Drug Paraphernalia. Corter missed an appointment with the Probation Office on June 21, 2019. When Corter was located at a residence in Blooming Grove Township, he was found in possession of Heroin.

Mirella Maria Smith, age 60, of Dingmans Ferry, PA, was sentenced to 1 month and 72 hours to 18 months in the Pike County Jail, a fine of \$1,100.00 and driver license suspension of 12 months for 2 counts of the crime of Simple Assault and Driving Under the Influence. State police were dispatched to Lakeview Drive in Delaware Township on December 6, 2019, where Smith was passed out behind the wheel off her vehicle. Smith was incapable of performing Field Sobriety Tests. A breath test confirmed a blood alcohol content of .231%. On January 1, 2020, during a domestic dispute at a residence in Delaware Township, Smith caused bodily injury to two individuals.

Charles Hubschmitt, age 37, of Milford, PA, was sentenced to 231 days to 23 1/2 months in the Pike County Jail and fined \$800.00 for the crimes of Simple Assault and Institutional Vandalism. Hubschmitt injured an individual during a dispute at a residence in Dingman Township on October 17, 2019, and will at the state police barracks in Blooming Grove, spit on the floors and bench requiring sanitation procedures be conducted.

Randy James Hotaling, age 26, of Shohola, PA, was sentenced to 10 months to 23 months in the Pike County Jail, followed by 1 year of probation and fined \$800.00 for the crimes of Criminal Use of Communication Facility and Invasion of Privacy. A hearing determined that Hotaling was a Tier 1 sexual offender and will be required to register with the Commonwealth of Pennsylvania as a sexual offender for the next 15 years. Hotaling used a cell phone to attempt to film a 12 year old female showering at a residence in Lackawaxen Township on July 14, 2018.

Joseph John Greb, age 51, of Tafton, PA, was sentenced to 2 months to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. Greb was stopped by the state police on May 9, 2019, for operating his vehicle several times across the double yellow lines of Gumbletown Road in Palmyra Township. Greb was observed to have glassy eyes, slurred speech and emitting the smell of an alcoholic beverage. Field Sobriety Tests were conducted and a breath test confirmed a blood alcohol content of .116%.

Nelson Gonzalez, age 40, of Milford, PA, was sentenced to 3 years of probation and fined \$1,000.00 for the crimes of Simple Assault and Resisting Arrest. The state police were dispatched to a residence in Dingman Township on July 27, 2019, where during a domestic dispute, Gonzalez injured an individual and when placed under arrest, resisted the trooper's directive.

Nichole Mary Quattrochi, age 45, of Mt. Pocono, PA, was sentenced to 18 months of probation and fined \$800.00 for the crimes of Possession of Drug Paraphernalia and Endangering the Welfare of Children. Quattrochi was found using and possessing drugs at a residence in Lehman Township on October 18, 2018, creating an unsafe setting for a 5 year old child present at that location.

Timothy Scott Phillips, age 53, of Hawley, PA, was sentenced to 30 days to 6 months in the Pike County Jail, fined \$750.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police responded to Route 6 and Shook Road in Palmyra Township on July 24, 2018, where Phillips had fallen off his electric pedal cycle. Phillips admitted to drinking liquor prior to riding the cycle. A breath test confirmed a blood alcohol content of .173%.

Shaun Best, age 25, of East Stroudsburg, PA, was sentenced to 3 years of probation, fined \$800.00 and had his driver's license suspended for a duration to be determined by PennDOT for 2 counts of the crime of Simple Assault, Recklessly Endangering Another Person and the Summary Offenses of Required Financial Responsibility and Reckless Driving. Best recklessly operated his vehicle when he swerved at on-coming traffic along Milford Road in Lehman Township on March 17, 2019, striking another vehicle and causing it to roll over resulting in the injury of the two occupants. Best was also found to be operating a vehicle without insurance.

*June 8, 2020* — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Henry James Masker, age 48, of Dingmans Ferry, PA, was sentenced to 5 days to 6 months in the Pike County Jail, fined \$1,575.00 and had his driver's license suspended for 12 months for the crimes of Driving Under the Influence, Possession of Drug Paraphernalia and the Summary Offenses of Registration and Certificate of Title Required, Driving While Operating Privilege Suspended and Required Financial Responsibility. The state police were dispatched to SR 739 in Delaware Township on February 5, 2014, where Masker had driven into a PennDOT plow truck. Masker, who admitted to drinking alcohol prior to driving, appeared sleepy, had red eyes, dilated pupils and slurred speech. Field Sobriety Tests were conducted which showed impairment and a breath test confirmed a blood alcohol content of .089%. Masker was

found in possession of a Marihuana pipe, driving on a suspended license and driving an unregistered and uninsured vehicle.

Thomas Maute, age 67, of Dingmans Ferry, PA, was sentenced to 6 months of probation and fined \$900.00 for the crimes of Driving Under the Influence, Recklessly Endangering Another Person and Criminal Mischief. On April 7, 2019, Maute recklessly drove his vehicle at a public safety vehicle in Dingmans Ferry. Maute was stopped by public safety but then sped off. When Maute was apprehended, the state trooper detected the smell of an alcoholic beverage. Maute refused to submit to a breath or blood test. While in transport in the trooper car, Maute urinated on the car seat and spit on the car console.

Alex Michael Roxburgh, age 27, of Milford, PA, was sentenced to 143 days to 12 months in the Pike County Jail and fined \$500.00 for the crime of Theft. Roxburgh took two credit cards from an individual's residence in Dingman Township in August of 2019, and made transactions totaling in excess of \$800.00 without the card holder's permission.

Richard Saylor, age 56, of Chalfont, PA, was sentenced to 2 years of probation and fined \$700.00 for the crimes of Simple Assault, Defiant Trespass and 2 counts of the Summary Offense of Harassment. A dispute occurred at a residence in Palmyra Township on April 29, 2019, between Saylor and an individual. During the dispute, Saylor pointed a hand gun at the individual and engaged in a physical altercation with two individuals and failed to leave the property when requested to do so.

Robert William Gregovich, age 59, of Dingmans Ferry, PA, was sentenced to a fine of \$500.00 for the crime of Theft. Between May 9 of 2019 and May 10 of 2019, Gregovich charged merchandise totaling \$2,651.87 to an account at a business in Matamoras where he was not authorized to charge.

Ryan Michael Donahue, age 32, of Milford, PA, was sentenced to 9 months in the Pike County Jail followed by 90 days of probation, fined \$1,300.00 and had his driver's license suspended for 60 days for the crime of Fleeing or Attempting to Elude a Police Officer and the Summary Offenses of Operation Following a Suspension Registration, Driving While Operating Privilege is Suspended or Revoked and Reckless Driving. The state police pulled Donahue over for operating without a registration along SR 6 in Dingman Township on June 21, 2020. Donahue refused to pull over, traveling at a high rate of speed and crashing into a tree and before fleeing on foot.
