COMMONWEALTH VS. MARSHALL

- 1. Evidence of other crimes, wrongs or acts may be introduced to prove (1) motive; (2) intent; (3) absence of mistake or accident; (4) a common scheme, plan or design embracing commission of two or more crimes so related to each other that proof of one tends to prove the others; or (5) the identity of the person charged with the commission of the crime upon trial.
- 2. Under the *res gestae* exception to Rule 404(b), evidence of other crimes, wrongs or acts may be admissible in situations where the distinct crimes are part of a chain or sequence of events which formed the history of the case and were part of its natural development.
- 3. The admissibility of evidence, including evidence of other crimes, wrongs or acts, is solely within the discretion of the trial court and will only be reversed upon a showing of an abuse of that discretion.
- 4. The judge, as fact finder in a non-jury trial, is well equipped to disregard any prejudice of the prior acts evidence. Therefore, the admission of evidence of Appellant's prior acts under Rule 404(b) was within the trial court's discretion and was proper.
- 5. Two crimes merge for sentencing purposes only if 1) the crimes arise from a single criminal act; and 2) all of the statutory elements of one of the offenses are included in the statutory elements of the other.

OPINION PURSUANT TO PA. R.A.P. 1925(A)

The Appellant, James Edward Marshall, appeals his convictions of simple assault and harassment in violation of Sections 2701(a)(1), 2709(a)(1) and 2709(a)(4) of the Pennsylvania Crimes Code. Appellant claims that 1) the trial court erred in admitting evidence of prior bad acts pursuant to the Commonwealth's motion under Rule 404(b) because the cumulative prejudicial effect of the prior acts substantially outweighed any probative value, and 2) that the trial court erred in imposing consecutive sentences for the charges of simple assault and harassment (18 Pa. C.S. § 2709(a)(4)) arguing these charges should have been merged for sentencing purposes, as they arose from the same single incident. For the reasons set forth below, it is respectfully requested that Appellant's conviction and judgment of sentence be affirmed.

On July 12, 2009, Officer Eric Gimbi of the Eastern Adams Regional Police Department received a complaint of an alleged assault from Sheri Smith. According to Ms. Smith, she was standing on her driveway at approximately 1:15 p.m. when the Appellant, the father of her three children, arrived at her residence located at 11 Elm Lane in New Oxford, Adams County, Pennsylvania. An argument ensued between Ms. Smith and Appellant because their oldest daughter, Ashiea, had disrespected a friend of Ms. Smith's, which resulted in Ms. Smith taking Ashiea's cell phone. Appellant demanded that Ms. Smith return the cell phone to Ashiea. Appellant then pulled Ms. Smith's ponytail, yelled and spit in Ms. Smith's face, and slapped Ms. Smith across the face with an open hand. When Appellant let go of Ms. Smith's ponytail, she retreated to her residence, but Appellant followed her inside to her office. Inside the office Ms. Smith and Appellant continued to argue, and Appellant slapped Ms. Smith across the head and ear, which caused Ms. Smith's eardrum to pop. At one point, as Ms. Smith was sitting in a reclining office chair, Appellant grabbed Ms. Smith by the throat and choked her until she could no longer breathe. During the course of the argument between Appellant and Ms. Smith, Appellant threatened to kill Ms. Smith if she called the police, and said if he did not kill her before he went to jail, he would kill her once he was released. Appellant also threatened to slice Ms. Smith's throat.

As a result of the above-described incidents, Appellant was charged with two counts of terroristic threats under 18 Pa. C.S. §§ 2706(a)(1), (3), two counts of simple assault under 18 Pa. C.S. §§ 2701(a)(1), (3), and two counts of harassment under 18 Pa. C.S. §§ 2709 (a)(1), (4). On January 19, 2010, Appellant appeared before this Court with counsel and waived his right to a jury trial. A nonjury trial was scheduled for March 23, 2010. On March 18, 2010, the Commonwealth filed a Motion for Admission of Prior Acts Evidence Pursuant to Pa.R.E. 404(b). Specifically, the Commonwealth sought to introduce evidence of Appellant's prior bad acts of violence against Ms. Smith that occurred from 1995 until 2007 resulting in various Protection from Abuse Orders. According to the Commonwealth, Appellant's prior bad acts of violence against Ms. Smith were relevant to show intent, to establish motive, to evidence a continuing course of conduct and to demonstrate the res gestae of the July 12, 2009 incident and the relationship between Ms. Smith and Appellant. On March 19, 2010 this Court granted the Commonwealth's Motion for Admission of Prior Acts Evidence Pursuant to Pa.R.E. 404(b) subject to laying an appropriate foundation for such evidence. Following a non-jury trial on March 23, 2010, Appellant was found guilty of Count 4 – simple assault (under 18 Pa. C.S. § 2701(a)(1)) as a misdemeanor of the second degree, Count 5 – harassment (under 18 Pa. C.S. § 2709(a)(4)) as a misdemeanor of the third degree, and Count 6 – harassment (under 18 Pa. C.S. § 2709(a)(1)) as a summary offense. On July 1, 2010 Appellant was sentenced to 12 to 24 months imprisonment on Count 4 – Simple Assault, and six to 12 months imprisonment on Count 5 – Harassment, which would be consecutive to the sentence imposed in Count 4. The Commonwealth stipulated that the Count 6 conviction would merge into Count 4 for sentencing purposes only.

On appeal, Appellant first argues that the trial court erred in admitting evidence under Rule 404(b). Generally, evidence of other crimes, wrongs or acts is not admissible at trial to show the character of the accused or to prove conformity therewith. Pa.R.E. 404(b)(1). However, evidence of other crimes, wrongs or acts may be introduced to prove (1) motive; (2) intent; (3) absence of mistake or accident; (4) a common scheme, plan or design embracing commission of two or more crimes so related to each other that proof of one tends to prove the others; or (5) the identity of the person charged with the commission of the crime upon trial. Pa.R.E. 404(b)(2); Commonwealth v. Morris, 425 A.2d 715, 720 (Pa. 1981). Evidence of other crimes, wrongs or acts also may be admissible "to impeach the credibility of a testifying defendant, to show that the defendant has used the prior bad acts to threaten the victim," Commonwealth v. Jackson, 900 A.2d 936, 940 (Pa. Super. 2006), and may also be admissible to show a course of conduct. Commonwealth v. Urrutia, 653 A.2d 706, 709 (Pa. Super. 1995). Additionally, under the res gestae exception to Rule 404(b), evidence of other crimes, wrongs or acts may be admissible in situations where "the distinct crimes are part of a chain or sequence of events which formed the history of the case and were part of its natural development." Commonwealth v.

¹ Appellant was found not guilty on Counts 1 and 2 (Terroristic Threats under 18 Pa. C.S. §§ 2706(a)(1), (3)). The charge of Simple Assault under 18 Pa. C.S. § 2701(a)(3) was dismissed.

Billa, 555 A.2d 835, 840 (Pa. 1989). To determine the admissibility of evidence of other crimes, wrongs or acts, "the trial court should balance the relevancy and evidentiary need for the evidence against the prejudicial effect." *Id.* The admissibility of evidence, including evidence of other crimes, wrongs or acts, is solely within the discretion of the trial court and will only be reversed upon a showing of an abuse of that discretion. *Commonwealth v. Stallworth*, 781 A.2d 110, 118 (Pa. 2001).

In the instant case, evidence of Appellant's prior acts of violence and protection from abuse orders was admissible to show Appellant's intent, a continuing course of conduct, and the res gestae of the July 12, 2009 incident and his relationship with Ms. Smith. The prior acts evidence revealing a lengthy history of abuse was relevant to show the Appellant's intent to cause or attempt to cause bodily injury and Appellant's specific intent to harass, annoy or alarm Ms. Smith on the date in question.² Similarly, the prior acts evidence was admissible to prove a course of conduct, as Appellant's actions established a pattern and history of repeated and regular threats and violence against Ms. Smith from 1995 through 2007, leading to the July 12, 2009 incident. Finally, the prior acts evidence was also admissible for res gestae purposes because the Appellant's conduct between 1995 and 2007 shows his ongoing violent behavior towards Ms. Smith and presents the history of the case. Although Appellant argues that the probative value of the prior acts evidence was substantially outweighed by its prejudicial effect, this argument is meritless. This was a bench trial. The judge, as fact finder in a non-jury trial, is well-equipped to disregard any prejudice of the prior acts evidence. See, e.g., Commonwealth v. Kenny, 474 A.2d 313, 317 (Pa. Super. 1984) (noting that "judicial fact finders are capable of disregarding most prejudicial evidence"). Therefore, the admission of evidence of Appellant's prior acts under Rule 404(b) was within the trial court's discretion and was proper. The probative value of the evidence was not substantially outweighed by its prejudicial effect.

Next, appellant argues that the trial court erred in imposing consecutive sentences for the charges of simple assault and harassment

² Harassment under 18 Pa. C.S. § 2709(a)(4) requires the intent to harass, annoy or alarm another person, and simple assault under 18 Pa. C.S. § 2701(a)(1) requires an attempt to cause or intentionally, knowingly or recklessly causing bodily injury to another.

(under 18 Pa. C.S. § 2709(a)(4)) suggesting these charges should have merged for sentencing purposes, as the charges arose out of a single incident. The Appellant's argument is without merit. Under Pennsylvania statutory authority, "no crimes shall merge for sentencing purposes unless the crimes arose from a single criminal act *and* all of the statutory elements of one offense are included in the statutory elements of the other offense." **42 Pa. C.S. § 9765** (emphasis added). Therefore, under this statutory mandate, two crimes merge for sentencing purposes only if "1) the crimes arise from a single criminal act; and 2) all of the statutory elements of one of the offenses are included in the statutory elements of the other." *Commonwealth v. Baldwin*, 985 A.2d 830, 833 (Pa. 2009); *see also* **42 Pa. C.S. § 9765**; *Commonwealth v. Coppedge*, 984 A.2d 562, 564 (Pa. Super. 2009).

In the instant case, although the crimes arise from a single criminal act, the statutory elements of simple assault under 18 Pa. C.S. § 2071(a)(1) and harassment under 18 Pa. C.S. § 2709(a)(4) are wholly different. Under the Pennsylvania Crimes Code, "[a] person is guilty of assault if he attempts to cause or intentionally, knowingly or recklessly caused bodily injury to another." 18 Pa. C.S. § 2071(a) (1). On the other hand, "a person commits the crime of harassment when, with the intent to harass, annoy or alarm another, the person communicates to or about such other person in any lewd, lascivious, threatening or obscene words, language or drawings or caricatures." 18 Pa. C.S. § 2709(a)(4). As evidenced by the plain language of the definition of each crime for which Appellant was found guilty, simple assault does not require communication to or about a person in a lewd, lascivious, threatening or obscene words, and harassment does not require an attempt to cause or the causing of bodily injury to another. In fact, the crimes of simple assault and harassment in this case share no common elements. Thus, under the plain language of 42 Pa. C.S. § 9765, merger is prohibited in this case because each offense includes an element that the other does not. It is therefore respectfully requested that the Appellant's conviction and judgment of the sentence be affirmed.
