SUMMARY OF OPINION:

A defendant who was convicted of third degree murder filed a petition under the Post-Conviction Relief Act (PCRA) seeking a new trial on the grounds that his trial counsel allegedly provided ineffective assistance by failing to: (1) object to the explanation that was furnished to the jury in response to a question during deliberations; (2) take exception to the wording of the verdict slip; (3) object or request a mistrial or curative instruction during the prosecutor's closing argument; (4) submit the curriculum vitae of its firearms expert into evidence; (5) oppose the jury's receipt of the curriculum vitae of the prosecution's firearm and tool mark examiner; (6) take issue with the jury's review of a redacted version of the report of the defense firearms expert; (7) pursue on appeal the submission of that redacted report to the jury; (8) properly investigate the bloodstain pattern evidence and retain an expert in that field; (9) timely request additional glass and ballistics testing; (10) sufficiently investigate prosecutorial misconduct; (11) request an involuntary manslaughter instruction; (12) conduct a reasonable investigation; (13) challenge on appeal the court rulings relating to a requested continuance, additional testing, and suppression of evidence; and (14) seek the appointment of co-counsel. In addition, defendant asserted an "after-discovered evidence" claim pursuant to § 9543(a)(2)(vi) of the PCRA.

To secure post-conviction relief based upon a claim of ineffective assistance of counsel, defendant was required to establish that: (a) his underlying legal claim had arguable merit; (b) his former counsel had no reasonable strategic basis for his action or inaction; and (c) but for the professional errors of counsel, there was a reasonable probability that the verdict would have been different. Defendant's 14 claims did not entitle him to PCRA relief under the tripartite test since those claims lacked arguable merit, trial counsel had a reasonable basis for his chosen course that was designed to effectuate defendant's interests, or defendant did not suffer the requisite prejudice as a result. Furthermore, since defendant did not demonstrate that the gunshot residue analysis report that was first produced after trial constituted exculpatory evidence that would likely compel a different verdict, he was not entitled to a new trial under 42 Pa.C.S. § 9543(a)(2)(vi). Consequently, defendant's original and amended PCRA petitions were denied.

SUMMARY OF OPINION:

A private citizen filed a *quo warranto* action against a newly appointed school board member seeking to remove that appointee on the basis that the Ethics Act allegedly required him to file a Statement of Financial Interest ("SOFI") at least ten days before he was interviewed and appointed. The appointee maintained that the Ethics Act did not require him to file his SOFI until after he was appointed to the Board and became a "public official" under the Act, that he timely filed his SOFI prior to the statutory deadline of May 1, 2019. The appointee further argued that plaintiff lacked standing to file a *quo warranto* action since he did not have a "special interest" in the matter and had never asked the Attorney General and the District Attorney to initiate a *quo warranto* proceeding against the appointee.

Plaintiff filed petitions for preliminary injunctions immediately removing the appointee and barring him from continuing to be represented by counsel retained by the Board. To obtain that injunctive relief, plaintiff was required to prove that his right to relief was clear in that he was "likely to prevail on the merits." Plaintiff conceded that he did not seek appointment to the Board vacancy, as a result of which he did not possess "a special interest" in the matter, nor did he ask the Attorney General or the District Attorney to file a *quo warranto* action. Therefore, plaintiff did not demonstrate that he had standing to file and litigate the *quo warranto* action, and as such, he did not establish that his right to relief was clear so as to entitle him to his requested preliminary injunction. Moreover, plaintiff acknowledged during the injunction hearing that he could not cite any authority to support his petition to enjoin the appointee from being represented by his counsel who was paid by the School District's insurer. Plaintiff did not allege any ethical infraction or comparable violation that would warrant the extreme remedy of removing a party's chosen counsel. Based upon plaintiff's failure to provide any factual and legal support for his alternative injunctive relief, his petition to enjoin the appointee from being represented by his retained counsel was also denied.

SUMMARY OF OPINION:

Due to chronic difficulties experienced by the borrowers in attempting to negotiate a resolution with the lender's servicer in connection with the Lackawanna County Residential Mortgage Foreclosure Diversion Program, an Order was issued pursuant to Pa.R.C.P. 212.5(b) and Lacka. Co. R.C.P. 1143.1(e) compelling the personal attendance of the servicer's assigned representative at the next Conciliation Conference. After that individual failed to appear, a rule was issued upon her to show cause why she should not be held in contempt of court, and the servicer and its representative failed to timely respond to that rule to show cause and neglected to appear for the contempt hearing. To sustain a finding of civil contempt, it must be established by a preponderance of the evidence that: (1) the contemnor had notice of the specific order which [s]he is alleged to have disobeyed; (2) the act constituting the contemnor's violation was volitional; and (3) the contemnor acted with wrongful intent, which means that [s]he knew or should reasonably have been aware that the contemnor's conduct was wrongful. Since the evidence established those factors, and the imposition of counsel fees can serve as a sanction upon a finding of civil contempt, the servicer's representative was adjudged to be in civil contempt and ordered to reimburse the borrower's counsel for counsel fees and expenses incurred as a result of the contemptuous conduct.

SUMMARY OF OPINION:

A patent holder filed a breach of contract action against a California manufacturer and distributor of novelty candy and gift products, and asserted a breach of the parties' 2011 settlement agreement resolving their patent infringement dispute. The manufacturer/distributor filed preliminary objections seeking to dismiss the action based upon a lack of personal jurisdiction under 42 Pa.C.S. § 5322. The parties' submissions raised issues of fact regarding the defendant's contacts with and business activities in the state of Pennsylvania, thereby entitling the plaintiff to conduct discovery regarding those activities before the preliminary objections would be submitted for a decision. Thus, the plaintiff was afforded sixty days within which to conduct discovery relevant to the issue of personal jurisdiction over the defendant, and to thereafter submit supplemental briefs together with a praecipe for reargument of preliminary objections.
